Mrs. MILLER of Michigan (for herself and Mr. BRADY of Pennsylvania) introduced the following bill; which was referred to the Committee on House Administration

A BILL

To provide for the appointment of members of the Board of Directors of the Office of Compliance to replace members whose terms expire during 2017, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. APPOINTMENT OF MEMBERS OF BOARD OF DI-**
4 **RECTORS OF OFFICE OF COMPLIANCE.**

5 (a) APPOINTMENT OF MEMBERS.—

6 (1) MEMBERS REPLACING MEMBERS WHOSE
7 TERMS EXPIRE IN MARCH 2017.—Notwithstanding
8 the first sentence of section 301(e) of the Congres-

1 sional Accountability Act of 1995 (2 U.S.C.
2 1381(e)), of the members of the Board of Directors
3 of the Office of Compliance who are appointed to re-
4 place the 3 members whose terms expire in March
5 2017—

6 (A) one shall have a term of office of 3
7 years; and

8 (B) two shall have a term of office of 4
9 years,

10 as designated at the time of appointment by the per-
11 sons specified in section 301(b) of such Act (2
12 U.S.C. 1381(b)).

13 (2) MEMBERS REPLACING MEMBERS WHOSE
14 TERMS EXPIRE IN MAY 2017.—In accordance with
15 the first sentence of section 301(e) of the Congres-
16 sional Accountability Act of 1995 (2 U.S.C.
17 1381(e)), the members of the Board of Directors of
18 the Office of Compliance who are appointed to re-
19 place the 2 members whose terms expire in May
20 2017 shall each have a term of office of 5 years.

21 (b) SERVICE OF CURRENT MEMBERS.—Notwith-
22 standing the second sentence of section 301(e) of the Con-
23 gressional Accountability Act of 1995 (2 U.S.C. 1381(e))
24 or section 3 of the Office of Compliance Administrative

1 and Technical Corrections Act of 2015 (Public Law 114–
2 6; 2 U.S.C. 1381 note)—

3 (1) an individual serving as a member of the
4 Board of Directors of the Office of Compliance
5 whose term expires in March 2017 may be re-
6 appointed to serve one additional term at the length
7 designated under paragraph (1) of subsection (a),
8 but may not be reappointed to any additional terms
9 after that additional term expires; and

10 (2) an individual serving as a member of the
11 Board of Directors of the Office of Compliance
12 whose term expires in May 2017 may be reappointed
13 to serve one additional term at the length referred
14 to in paragraph (2) of subsection (a), but may not
15 be reappointed to any additional terms after that ad-
16 ditional term expires.

17 (c) PERMITTING MEMBERS TO SERVE UNTIL AP-
18 POINTMENT OF SUCCESSORS.—Section 301(e) of the Con-
19 gressional Accountability Act of 1995 (2 U.S.C. 1381(e))
20 is amended by adding at the end the following new para-
21 graph:

22 “(3) PERMITTING SERVICE UNTIL APPOINT-
23 MENT OF SUCCESSOR.—A member of the Board may

- 1 serve after the expiration of that member's term
- 2 until a successor has taken office.”.
