To require the Secretary of the Treasury to mint coins in commemoration of the centennial of Boys Town, and for other purposes.

1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "Boys Town Centennial Commemorative Coin Act".
- 4 SEC. 2. FINDINGS.

- 5 Congress finds that—
- 6 (1) Boys Town is a nonprofit organization dedi-7 cated to saving children and healing families, nation-8 ally headquartered in the village of Boys Town, Ne-9 braska;
- (2) Father Flanagan's Boys Home, known as
 "Boys Town", was founded on December 12, 1917,
 by Servant of God Father Edward Flanagan;
- 13 (3) Boys Town was created to serve children of 14 all races and religions;
 - (4) news of the work of Father Flanagan spread worldwide with the success of the 1938 movie, "Boys Town";
 - (5) after World War II, President Truman asked Father Flanagan to take his message to the world, and Father Flanagan traveled the globe visiting war orphans and advising government leaders on how to care for displaced children;
 - (6) Boys Town has grown exponentially, and now provides care to children and families across the country in 11 regions, including California, Nevada, Texas, Nebraska, Iowa, Louisiana, North Florida,

- 17 (d) Legal Tender.—The coins minted under this
- 18 Act shall be legal tender, as provided in section 5103 of
- 19 title 31, United States Code.
- 20 (e) Numismatic Items.—For purposes of sections
- 21 5134 and 5136 of title 31, United States Code, all coins
- 22 minted under this Act shall be considered to be numis-
- 23 matic items.

1 SEC. 4. DESIGN OF COINS.

- 2 (a) In General.—The design of the coins minted
- 3 under this Act shall be emblematic of the 100 years of
- 4 Boys Town, one of the largest nonprofit child care agen-
- 5 cies in the United States.
- 6 (b) Designation and Inscriptions.—On each coin
- 7 minted under this Act, there shall be—
- 8 (1) a designation of the value of the coin;
- 9 (2) an inscription of the year "2017"; and
- 10 (3) inscriptions of the words "Liberty", "In
- God We Trust", "United States of America", and
- "E Pluribus Unum".
- 13 (c) Selection.—The design for the coins minted
- 14 under this Act shall be—
- 15 (1) selected by the Secretary, after consultation
- with the National Executive Director of Boys Town
- and the Commission of Fine Arts; and
- 18 (2) reviewed by the Citizens of Coinage Advi-
- sory Committee.
- 20 SEC. 5. ISSUANCE OF COINS.
- 21 (a) QUALITY OF COINS.—Coins minted under this
- 22 Act shall be issued in uncirculated and proof qualities.
- 23 (b) MINT FACILITY.—Only one facility of the United
- 24 States Mint may be used to strike any particular quality
- 25 of the coins minted under this Act.

- 1 (c) Period for Issuance.—The Secretary may
- 2 issue coins under this Act only during the period begin-
- 3 ning on January 1, 2017, and ending on December 31,
- 4 2017.

5 SEC. 6. SALE OF COINS.

- 6 (a) Sale Price.—The coins issued under this Act
- 7 shall be sold by the Secretary at a price equal to the sum
- 8 of—
- 9 (1) the face value of the coins; and
- 10 (2) the cost of designing and issuing the coins
- 11 (including labor, materials, dies, use of machinery,
- overhead expenses, marketing, and shipping).
- 13 (b) Bulk Sales.—The Secretary shall make bulk
- 14 sales of the coins issued under this Act at a reasonable
- 15 discount.
- 16 (c) Prepaid Orders.—
- 17 (1) IN GENERAL.—The Secretary shall accept
- prepaid orders for the coins minted under this Act
- before the issuance of such coins.
- 20 (2) DISCOUNT.—Sale prices with respect to pre-
- 21 paid orders under paragraph (1) shall be at a rea-
- sonable discount.
- 23 SEC. 7. SURCHARGES.
- 24 (a) IN GENERAL.—All sales of coins issued under this
- 25 Act shall include a surcharge as follows:

- 1 (1) A surcharge of \$35 per coin for the \$5 coin.
- 2 (2) A surcharge of \$10 per coin for the \$1 coin.
- 3 (3) A surcharge of \$5 per coin for the half dol-
- 4 lar coin.
- 5 (b) DISTRIBUTION.—Subject to section 5134(f) of
- 6 title 31, United States Code, all surcharges received by
- 7 the Secretary from the sale of coins issued under this Act
- 8 shall be paid to Boys Town to carry out Boys Town's
- 9 cause of caring for and assisting children and families in
- 10 underserved communities across America.
- 11 (c) AUDITS.—Boys Town shall be subject to the audit
- 12 requirements of section 5134(f)(2) of title 31, United
- 13 States Code, with regard to the amounts received under
- 14 subsection (b).
- 15 (d) Limitation.—Notwithstanding subsection (a),
- 16 no surcharge may be included with respect to the issuance
- 17 under this Act of any coin during a calendar year if, as
- 18 of the time of such issuance, the issuance of such coin
- 19 would result in the number of commemorative coin pro-
- 20 grams issued during such year to exceed the annual two
- 21 commemorative coin program issuance limitation under
- 22 section 5112(m)(1) of title 31, United States Code (as in
- 23 effect on the date of the enactment of this Act). The Sec-
- 24 retary of the Treasury may issue guidance to carry out
- 25 this subsection.

1 SEC. 8. FINANCIAL ASSURANCES.

- The Secretary shall take such actions as may be nec-
- 3 essary to ensure that—
- 4 (1) minting and issuing coins under this Act
 5 will not result in any net cost to the Federal Govern6 ment; and
- 7 (2) no funds, including applicable surcharges, 8 shall be disbursed to any recipient designated in sec-9 tion 7 until the total cost of designing and issuing 10 all of the coins authorized by this Act (including labor, materials, dies, use of machinery, overhead ex-11 12 penses, marketing, and shipping) is recovered by the 13 United States Treasury, consistent with sections 14 5112(m) and 5134(f) of title 31, United States
