Mr. NEWHOUSE, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 2685) making appropriations for the Department of Defense for the fiscal year ending September 30, 2016, and for other purposes, and providing for consideration of the bill (H.R. 2393) to amend the Agricultural Marketing Act of 1946 to repeal country of origin labeling requirements with respect to beef, pork, and chicken, and for other purposes.

1 *Resolved*, That (a) at any time after adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 2685) making appropriations for
6 the Department of Defense for the fiscal year ending Sep-
7 tember 30, 2016, and for other purposes. The first reading
8 of the bill shall be dispensed with. All points of order
9 against consideration of the bill are waived. General de-
10 bate shall be confined to the bill and shall not exceed one
11 hour equally divided and controlled by the chair and rank-
12 ing minority member of the Committee on Appropriations.
13 After general debate the bill shall be considered for
14 amendment under the five-minute rule. Points of order
15 against provisions in the bill for failure to comply with
16 clause 2 of rule XXI are waived.

17 (b) During consideration of the bill for amendment—

18 (1) each amendment, other than amendments
19 provided for in paragraph (2), shall be debatable for
20 10 minutes equally divided and controlled by the
21 proponent and an opponent and shall not be subject
22 to amendment except as provided in paragraph (2);

23 (2) no pro forma amendment shall be in order
24 except that the chair and ranking minority member
25 of the Committee on Appropriations or their respec-

1 tive designees may offer up to 10 pro forma amend-
2 ments each at any point for the purpose of debate;
3 and

4 (3) the chair of the Committee of the Whole
5 may accord priority in recognition on the basis of
6 whether the Member offering an amendment has
7 caused it to be printed in the portion of the Con-
8 gressional Record designated for that purpose in
9 clause 8 of rule XVIII. Amendments so printed shall
10 be considered as read.

11 (c) When the committee rises and reports the bill
12 back to the House with a recommendation that the bill
13 do pass, the previous question shall be considered as or-
14 dered on the bill and amendments thereto to final passage
15 without intervening motion except one motion to recommit
16 with or without instructions.

17 SEC. 2. Upon adoption of this resolution it shall be
18 in order to consider in the House the bill (H.R. 2393)
19 to amend the Agricultural Marketing Act of 1946 to re-
20 peal country of origin labeling requirements with respect
21 to beef, pork, and chicken, and for other purposes. All
22 points of order against consideration of the bill are waived.
23 The amendment in the nature of a substitute rec-
24 ommended by the Committee on Agriculture now printed
25 in the bill shall be considered as adopted. The bill, as

1 amended, shall be considered as read. All points of order
2 against provisions in the bill, as amended, are waived. The
3 previous question shall be considered as ordered on the
4 bill, as amended, and on any further amendment thereto,
5 to final passage without intervening motion except: (1) one
6 hour of debate equally divided and controlled by the chair
7 and ranking minority member of the Committee on Agri-
8 culture; and (2) one motion to recommit with or without
9 instructions.
