RESOLUTION

Providing for consideration of the bill (H.R. 160) to amend the Internal Revenue Code of 1986 to repeal the excise tax on medical devices, and providing for consideration of the bill (H.R. 1190) to repeal the provisions of the Patient Protection and Affordable Care Act providing for the Independent Payment Advisory Board.

- 1 *Resolved*, That upon adoption of this resolution it
- 2 shall be in order to consider in the House the bill (H.R.
- 3 160) to amend the Internal Revenue Code of 1986 to re-

1 repeal the excise tax on medical devices. All points of order
2 against consideration of the bill are waived. The amend-
3 ment in the nature of a substitute recommended by the
4 Committee on Ways and Means now printed in the bill,
5 modified by the amendment printed in part A of the report
6 of the Committee on Rules accompanying this resolution,
7 shall be considered as adopted. The bill, as amended, shall
8 be considered as read. All points of order against provi-
9 sions in the bill, as amended, are waived. The previous
10 question shall be considered as ordered on the bill, as
11 amended, and on any further amendment thereto, to final
12 passage without intervening motion except: (1) one hour
13 of debate equally divided and controlled by the chair and
14 ranking minority member of the Committee on Ways and
15 Means; and (2) one motion to recommit with or without
16 instructions.

17 SEC. 2. Upon adoption of this resolution it shall be
18 in order to consider in the House the bill (H.R. 1190)
19 to repeal the provisions of the Patient Protection and Af-
20 fordable Care Act providing for the Independent Payment
21 Advisory Board. All points of order against consideration
22 of the bill are waived. The amendment printed in part B
23 of the report of the Committee on Rules accompanying
24 this resolution shall be considered as adopted. The bill,
25 as amended, shall be considered as read. All points of

1 order against provisions in the bill, as amended, are
2 waived. The previous question shall be considered as or-
3 dered on the bill, as amended, and on any further amend-
4 ment thereto, to final passage without intervening motion
5 except: (1) one hour of debate equally divided among and
6 controlled by the chair and ranking minority member of
7 the Committee on Ways and Means and the chair and
8 ranking minority member of the Committee on Energy
9 and Commerce; and (2) one motion to recommit with or
10 without instructions.
