Mr. NEWHOUSE, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for further consideration of the bill (H.R. 5) to support State and local accountability for public education, protect State and local authority, inform parents of the performance of their children’s schools, and for other purposes, and providing for consideration of the bill (H.R. 2647) to expedite under the National Environmental Policy Act and improve forest management activi-

ties in units of the National Forest System derived from the public domain, on public lands under the jurisdiction of the Bureau of Land Management, and on tribal lands to return resilience to overgrown, fire-prone forested lands, and for other purposes.

1 *Resolved*, That during further consideration of the bill
2 (H.R. 5) to support State and local accountability for pub-
3 lic education, protect State and local authority, inform
4 parents of the performance of their children’s schools, and
5 for other purposes, pursuant to House Resolution 125, it
6 shall be in order to consider the further amendments
7 printed in part A of the report of the Committee on Rules
8 accompanying this resolution as though they were the last
9 further amendments printed in part B of House Report
10 114-29.

11 SEC. 2. At any time after adoption of this resolution
12 the Speaker may, pursuant to clause 2(b) of rule XVIII,
13 declare the House resolved into the Committee of the
14 Whole House on the state of the Union for consideration
15 of the bill (H.R. 2647) to expedite under the National En-
16 vironmental Policy Act and improve forest management
17 activities in units of the National Forest System derived
18 from the public domain, on public lands under the jurisdic-
19 tion of the Bureau of Land Management, and on tribal
20 lands to return resilience to overgrown, fire-prone forested
21 lands, and for other purposes. The first reading of the bill

1 shall be dispensed with. All points of order against consid-
2 eration of the bill are waived. General debate shall be con-
3 fined to the bill and amendments specified in this section
4 and shall not exceed one hour equally divided among and
5 controlled by the chair and ranking minority member of
6 the Committee on Agriculture and the chair and ranking
7 minority member of the Committee on Natural Resources.
8 After general debate the bill shall be considered for
9 amendment under the five-minute rule. In lieu of the
10 amendments in the nature of a substitute recommended
11 by the Committees on Agriculture and Natural Resources
12 now printed in the bill, it shall be in order to consider
13 as an original bill for the purpose of amendment under
14 the five-minute rule an amendment in the nature of a sub-
15 stitute consisting of the text of Rules Committee Print
16 114-21 modified by the amendment printed in part B of
17 the report of the Committee on Rules accompanying this
18 resolution. That amendment in the nature of a substitute
19 shall be considered as read. All points of order against
20 that amendment in the nature of a substitute are waived.
21 No amendment to that amendment in the nature of a sub-
22 stitute shall be in order except those printed in part C
23 of the report of the Committee on Rules. Each such
24 amendment may be offered only in the order printed in
25 the report, may be offered only by a Member designated

1 in the report, shall be considered as read, shall be debat-
2 able for the time specified in the report equally divided
3 and controlled by the proponent and an opponent, shall
4 not be subject to amendment, and shall not be subject to
5 a demand for division of the question in the House or in
6 the Committee of the Whole. All points of order against
7 such amendments are waived. At the conclusion of consid-
8 eration of the bill for amendment the Committee shall rise
9 and report the bill to the House with such amendments
10 as may have been adopted. Any Member may demand a
11 separate vote in the House on any amendment adopted
12 in the Committee of the Whole to the bill or to the amend-
13 ment in the nature of a substitute made in order as origi-
14 nal text. The previous question shall be considered as or-
15 dered on the bill and amendments thereto to final passage
16 without intervening motion except one motion to recommit
17 with or without instructions.
