## RESOLUTION

Providing for consideration of the bill (H.R. 3495) to amend title XIX of the Social Security Act to allow for greater State flexibility with respect to excluding providers who are involved in abortions, and waiving a requirement of clause 6(a) of rule XIII with respect to consideration of certain resolutions reported from the Committee on Rules.

1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider in the House the bill (H.R.  
3 3495) to amend title XIX of the Social Security Act to

1 allow for greater State flexibility with respect to excluding  
2 providers who are involved in abortions. All points of order  
3 against consideration of the bill are waived. The amend-  
4 ment printed in the report of the Committee on Rules ac-  
5 companying this resolution shall be considered as adopted.  
6 The bill, as amended, shall be considered as read. All  
7 points of order against provisions in the bill, as amended,  
8 are waived. The previous question shall be considered as  
9 ordered on the bill, as amended, and on any further  
10 amendment thereto, to final passage without intervening  
11 motion except: (1) one hour of debate equally divided and  
12 controlled by the chair and ranking minority member of  
13 the Committee on Energy and Commerce or their respec-  
14 tive designees; and (2) one motion to recommit with or  
15 without instructions.

16       SEC. 2. The requirement of clause 6(a) of rule XIII  
17 for a two-thirds vote to consider a report from the Com-  
18 mittee on Rules on the same day it is presented to the  
19 House is waived with respect to any resolution reported  
20 through the legislative day of October 1, 2015.
