## RESOLUTION

Providing for consideration of the bill (H.R. 3457) to prohibit the lifting of sanctions on Iran until the Government of Iran pays the judgments against it for acts of terrorism, and for other purposes; providing for consideration of the conference report to accompany the bill (H.R. 1735) to authorize appropriations for fiscal year 2016 for military activities of the Department of Defense, for military construction, and for defense activi-

ties of the Department of Energy, to prescribe military personnel strengths for such fiscal year, and for other purposes; and providing for consideration of motions to suspend the rules.

1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider in the House the bill (H.R.  
3 3457) to prohibit the lifting of sanctions on Iran until the  
4 Government of Iran pays the judgments against it for acts  
5 of terrorism, and for other purposes. All points of order  
6 against consideration of the bill are waived. The amend-  
7 ment in the nature of a substitute printed in the report  
8 of the Committee on Rules accompanying this resolution  
9 shall be considered as adopted. The bill, as amended, shall  
10 be considered as read. All points of order against provi-  
11 sions in the bill, as amended, are waived. The previous  
12 question shall be considered as ordered on the bill, as  
13 amended, and on any further amendment thereto, to final  
14 passage without intervening motion except: (1) one hour  
15 of debate equally divided and controlled by the chair and  
16 ranking minority member of the Committee on Foreign  
17 Affairs; and (2) one motion to recommit with or without  
18 instructions.

19       SEC. 2. Upon adoption of this resolution it shall be  
20 in order to consider the conference report to accompany  
21 the bill (H.R. 1735) to authorize appropriations for fiscal  
22 year 2016 for military activities of the Department of De-

1 fense, for military construction, and for defense activities  
2 of the Department of Energy, to prescribe military per-  
3 sonnel strengths for such fiscal year, and for other pur-  
4 poses. All points of order against the conference report  
5 and against its consideration are waived. The conference  
6 report shall be considered as read. The previous question  
7 shall be considered as ordered on the conference report  
8 to its adoption without intervening motion except: (1) one  
9 hour of debate; and (2) one motion to recommit if applica-  
10 ble.

11       SEC. 3. It shall be in order at any time on the legisla-  
12 tive day of October 1, 2015, for the Speaker to entertain  
13 motions that the House suspend the rules as though under  
14 clause 1 of rule XV. The Speaker or his designee shall  
15 consult with the Minority Leader or her designee on the  
16 designation of any matter for consideration pursuant to  
17 this section.
