Ms. FOXX, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 10) to reauthorize the Scholarships for Opportunity and Results Act, and for other purposes, and providing for consideration of the bill (H.R. 692) to ensure the payment of interest and principal of the debt of the United States.

1 *Resolved*, That at any time after adoption of this reso-
2 lution the Speaker may, pursuant to clause 2(b) of rule
3 XVIII, declare the House resolved into the Committee of
4 the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 10) to reauthorize the Scholarships

1 for Opportunity and Results Act, and for other purposes.
2 The first reading of the bill shall be dispensed with. All
3 points of order against consideration of the bill are waived.
4 General debate shall be confined to the bill and shall not
5 exceed one hour equally divided and controlled by the chair
6 and ranking minority member of the Committee on Over-
7 sight and Government Reform. After general debate the
8 bill shall be considered for amendment under the five-
9 minute rule. The amendments recommended by the Com-
10 mittee on Oversight and Government Reform now printed
11 in the bill shall be considered as adopted in the House
12 and in the Committee of the Whole. The bill, as amended,
13 shall be considered as read. All points of order against
14 provisions in the bill, as amended, are waived. No further
15 amendment to the bill, as amended, shall be in order ex-
16 cept those printed in the report of the Committee on Rules
17 accompanying this resolution. Each further amendment
18 may be offered only in the order printed in the report,
19 may be offered only by a Member designated in the report,
20 shall be considered as read, shall be debatable for the time
21 specified in the report equally divided and controlled by
22 the proponent and an opponent, shall not be subject to
23 amendment, and shall not be subject to a demand for divi-
24 sion of the question in the House or in the Committee
25 of the Whole. All points of order against such further

1 amendments are waived. At the conclusion of consider-
2 ation of the bill for amendment the Committee shall rise
3 and report the bill, as amended, to the House with such
4 further amendments as may have been adopted. The pre-
5 vious question shall be considered as ordered on the bill,
6 as amended, and on any further amendment thereto, to
7 final passage without intervening motion except one mo-
8 tion to recommit with or without instructions.

9 SEC. 2. Upon adoption of this resolution it shall be
10 in order to consider in the House the bill (H.R. 692) to
11 ensure the payment of interest and principal of the debt
12 of the United States. All points of order against consider-
13 ation of the bill are waived. The bill shall be considered
14 as read. All points of order against provisions in the bill
15 are waived. The previous question shall be considered as
16 ordered on the bill and on any amendment thereto to final
17 passage without intervening motion except: (1) one hour
18 of debate equally divided and controlled by the chair and
19 ranking minority member of the Committee on Ways and
20 Means; and (2) one motion to recommit.
