Mr. WOODALL, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 3762) to provide for reconciliation pursuant to section 2002 of the concurrent resolution on the budget for fiscal year 2016; waiving a requirement of clause 6(a) of rule XIII with respect to consideration of certain resolutions reported from the Committee on Rules; and providing for consideration of motions to suspend the rules.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.

1 3762) to provide for reconciliation pursuant to section
2 2002 of the concurrent resolution on the budget for fiscal
3 year 2016. All points of order against consideration of the
4 bill are waived. The amendment printed in the report of
5 the Committee on Rules accompanying this resolution
6 shall be considered as adopted. The bill, as amended, shall
7 be considered as read. All points of order against provi-
8 sions in the bill, as amended, are waived. The previous
9 question shall be considered as ordered on the bill, as
10 amended, and on any further amendment thereto, to final
11 passage without intervening motion except: (1) two hours
12 of debate equally divided and controlled by the chair and
13 ranking minority member of the Committee on the Budget
14 or their respective designees; and (2) one motion to recom-
15 mit with or without instructions.

16 SEC. 2. The requirement of clause 6(a) of rule XIII
17 for a two-thirds vote to consider a report from the Com-
18 mittee on Rules on the same day it is presented to the
19 House is waived with respect to any resolution reported
20 through the legislative day of October 23, 2015.

21 SEC. 3. It shall be in order at any time on the legisla-
22 tive day of October 22, 2015, or October 23, 2015, for
23 the Speaker to entertain motions that the House suspend
24 the rules as though under clause 1 of rule XV. The Speak-
25 er or his designee shall consult with the Minority Leader

1 or her designee on the designation of any matter for con-
2 sideration pursuant to this section.
