Mr. COLE, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

## RESOLUTION

Providing for consideration of the bill (H.R. 1737) to nullify certain guidance of the Bureau of Consumer Financial Protection and to provide requirements for guidance issued by the Bureau with respect to indirect auto lending; providing for consideration of the bill (H.R. 511) to clarify the rights of Indians and Indian tribes on Indian lands under the National Labor Relations Act; and for other purposes.

1       *Resolved*, That at any time after adoption of this reso-  
2 lution the Speaker may, pursuant to clause 2(b) of rule  
3 XVIII, declare the House resolved into the Committee of  
4 the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 1737) to nullify certain guidance  
6 of the Bureau of Consumer Financial Protection and to  
7 provide requirements for guidance issued by the Bureau  
8 with respect to indirect auto lending. The first reading of  
9 the bill shall be dispensed with. All points of order against  
10 consideration of the bill are waived. General debate shall  
11 be confined to the bill and shall not exceed one hour equal-  
12 ly divided and controlled by the chair and ranking minor-  
13 ity member of the Committee on Financial Services. After  
14 general debate the bill shall be considered for amendment  
15 under the five-minute rule. The bill shall be considered  
16 as read. All points of order against provisions in the bill  
17 are waived. No amendment to the bill shall be in order  
18 except those printed in the report of the Committee on  
19 Rules accompanying this resolution. Each such amend-  
20 ment may be offered only in the order printed in the re-  
21 port, may be offered only by a Member designated in the  
22 report, shall be considered as read, shall be debatable for  
23 the time specified in the report equally divided and con-  
24 trolled by the proponent and an opponent, shall not be  
25 subject to amendment, and shall not be subject to a de-

1 mand for division of the question in the House or in the  
2 Committee of the Whole. All points of order against such  
3 amendments are waived. At the conclusion of consider-  
4 ation of the bill for amendment the Committee shall rise  
5 and report the bill to the House with such amendments  
6 as may have been adopted. The previous question shall  
7 be considered as ordered on the bill and amendments  
8 thereto to final passage without intervening motion except  
9 one motion to recommit with or without instructions.

10       SEC. 2. Upon adoption of this resolution it shall be  
11 in order to consider in the House the bill (H.R. 511) to  
12 clarify the rights of Indians and Indian tribes on Indian  
13 lands under the National Labor Relations Act. All points  
14 of order against consideration of the bill are waived. The  
15 amendment in the nature of a substitute recommended by  
16 the Committee on Education and the Workforce now  
17 printed in the bill shall be considered as adopted. The bill,  
18 as amended, shall be considered as read. All points of  
19 order against provisions in the bill, as amended, are  
20 waived. The previous question shall be considered as or-  
21 dered on the bill, as amended, and on any further amend-  
22 ment thereto, to final passage without intervening motion  
23 except: (1) one hour of debate equally divided and con-  
24 trolled by the chair and ranking minority member of the

1 Committee on Education and the Workforce; and (2) one  
2 motion to recommit with or without instructions.

3 SEC. 3. Upon adoption of this resolution—

4 (a) the House shall be considered to have: (1) taken  
5 from the Speaker's table the bill (S. 1177) to reauthorize  
6 the Elementary and Secondary Education Act of 1965 to  
7 ensure that every child achieves; (2) stricken all after the  
8 enacting clause of such bill and inserted in lieu thereof  
9 the provisions of H.R. 5, as passed by the House; and  
10 (3) passed the Senate bill as so amended; and

11 (b) it shall be in order for the chair of the Committee  
12 on Education and the Workforce or his designee to move  
13 that the House insist on its amendment to S. 1177 and  
14 request a conference with the Senate thereon.

15 SEC. 4. In the engrossment of H.R. 3762, the Clerk  
16 shall strike title I and redesignate the subsequent titles  
17 accordingly.
