# RESOLUTION

Providing for consideration of the bill (H.R. 8) to modernize energy infrastructure, build a 21st century energy and manufacturing workforce, bolster America's energy security and diplomacy, and promote energy efficiency and government accountability, and for other purposes; pro-

viding for consideration of the joint resolution (S.J. Res. 23) providing for congressional disapproval under chapter 8 of title 5, United States Code, of a rule submitted by the Environmental Protection Agency relating to “Standards of Performance for Greenhouse Gas Emissions from New, Modified, and Reconstructed Stationary Sources: Electric Utility Generating Units”; and providing for consideration of the joint resolution (S.J. Res. 24) providing for congressional disapproval under chapter 8 of title 5, United States Code, of a rule submitted by the Environmental Protection Agency relating to “Carbon Pollution Emission Guidelines for Existing Stationary Sources: Electric Utility Generating Units”.

1       *Resolved*, That at any time after adoption of this reso-  
2 lution the Speaker may, pursuant to clause 2(b) of rule  
3 XVIII, declare the House resolved into the Committee of  
4 the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 8) to modernize energy infrastruc-  
6 ture, build a 21st century energy and manufacturing  
7 workforce, bolster America’s energy security and diplo-  
8 macy, and promote energy efficiency and government ac-  
9 countability, and for other purposes. The first reading of  
10 the bill shall be dispensed with. All points of order against  
11 consideration of the bill are waived. General debate shall  
12 be confined to the bill and shall not exceed one hour equal-  
13 ly divided and controlled by the chair and ranking minor-  
14 ity member of the Committee on Energy and Commerce.  
15 After general debate, the Committee of the Whole shall

1 rise without motion. No further consideration of the bill  
2 shall be in order except pursuant to a subsequent order  
3 of the House.

4 SEC. 2. Upon adoption of this resolution it shall be  
5 in order to consider in the House any joint resolution spec-  
6 ified in section 3 of this resolution. All points of order  
7 against consideration of each such joint resolution are  
8 waived. Each such joint resolution shall be considered as  
9 read. All points of order against provisions in each such  
10 joint resolution are waived. The previous question shall be  
11 considered as ordered on each such joint resolution and  
12 on any amendment thereto to final passage without inter-  
13 vening motion except: (1) one hour of debate equally di-  
14 vided and controlled by the chair and ranking minority  
15 member of the Committee on Energy and Commerce; and  
16 (2) one motion to commit.

17 SEC. 3. The joint resolutions referred to in section  
18 2 of this resolution are as follows:

19 (a) The joint resolution (S.J. Res. 23) providing for  
20 congressional disapproval under chapter 8 of title 5,  
21 United States Code, of a rule submitted by the Environ-  
22 mental Protection Agency relating to “Standards of Per-  
23 formance for Greenhouse Gas Emissions from New, Modi-  
24 fied, and Reconstructed Stationary Sources: Electric Util-  
25 ity Generating Units”.

1       (b) The joint resolution (S.J. Res. 24) providing for  
2 congressional disapproval under chapter 8 of title 5,  
3 United States Code, of a rule submitted by the Environ-  
4 mental Protection Agency relating to “Carbon Pollution  
5 Emission Guidelines for Existing Stationary Sources:  
6 Electric Utility Generating Units”.
