RESOLUTION

Providing for consideration of the conference report to accompany the bill (H.R. 644) to reauthorize trade facilitation and trade enforcement functions and activities, and for other purposes, and providing for consideration of the Senate amendments to the bill (H.R. 2250) making appropriations for the Legislative Branch for the fiscal year ending September 30, 2016, and for other purposes.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider the conference report to ac-

1 company the bill (H.R. 644) to reauthorize trade facilita-
2 tion and trade enforcement functions and activities, and
3 for other purposes. All points of order against the con-
4 ference report and against its consideration are waived.
5 The conference report shall be considered as read. The
6 previous question shall be considered as ordered on the
7 conference report to its adoption without intervening mo-
8 tion except: (1) one hour of debate; and (2) one motion
9 to recommit if applicable.

10 SEC. 2. Upon adoption of this resolution it shall be
11 in order to take from the Speaker's table the bill (H.R.
12 2250) making appropriations for the Legislative Branch
13 for the fiscal year ending September 30, 2016, and for
14 other purposes, with the Senate amendments thereto, and
15 to consider in the House, without intervention of any point
16 of order, a single motion offered by the chair of the Com-
17 mittee on Appropriations or his designee that the House
18 concur in the Senate amendments. The Senate amend-
19 ments and the motion shall be considered as read. The
20 motion shall be debatable for one hour equally divided and
21 controlled by the chair and ranking minority member of
22 the Committee on Appropriations. The previous question
23 shall be considered as ordered on the motion to its adop-
24 tion without intervening motion or demand for division of
25 the question.
