## RESOLUTION

Providing for consideration of the bill (H.R. 1927) to amend title 28, United States Code, to improve fairness in class action litigation.

1       *Resolved*, That at any time after adoption of this reso-  
2 lution the Speaker may, pursuant to clause 2(b) of rule  
3 XVIII, declare the House resolved into the Committee of  
4 the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 1927) to amend title 28, United  
6 States Code, to improve fairness in class action litigation.  
7 The first reading of the bill shall be dispensed with. All

1 points of order against consideration of the bill are waived.  
2 General debate shall be confined to the bill and amend-  
3 ments specified in this resolution and shall not exceed one  
4 hour equally divided and controlled by the chair and rank-  
5 ing minority member of the Committee on the Judiciary.  
6 After general debate the bill shall be considered for  
7 amendment under the five-minute rule. In lieu of the  
8 amendment in the nature of a substitute recommended by  
9 the Committee on the Judiciary now printed in the bill,  
10 it shall be in order to consider as an original bill for the  
11 purpose of amendment under the five-minute rule an  
12 amendment in the nature of a substitute consisting of the  
13 text of Rules Committee Print 114-38. That amendment  
14 in the nature of a substitute shall be considered as read.  
15 All points of order against that amendment in the nature  
16 of a substitute are waived. No amendment to that amend-  
17 ment in the nature of a substitute shall be in order except  
18 those printed in the report of the Committee on Rules ac-  
19 companying this resolution. Each such amendment may  
20 be offered only in the order printed in the report, may  
21 be offered only by a Member designated in the report,  
22 shall be considered as read, shall be debatable for the time  
23 specified in the report equally divided and controlled by  
24 the proponent and an opponent, shall not be subject to  
25 amendment, and shall not be subject to a demand for divi-

1 sion of the question in the House or in the Committee  
2 of the Whole. All points of order against such amendments  
3 are waived. At the conclusion of consideration of the bill  
4 for amendment the Committee shall rise and report the  
5 bill to the House with such amendments as may have been  
6 adopted. Any Member may demand a separate vote in the  
7 House on any amendment adopted in the Committee of  
8 the Whole to the bill or to the amendment in the nature  
9 of a substitute made in order as original text. The previous  
10 question shall be considered as ordered on the bill and  
11 amendments thereto to final passage without intervening  
12 motion except one motion to recommit with or without in-  
13 structions.

14       SEC. 2. Further proceedings on any question on a  
15 motion relating to the disposition of the veto message and  
16 the bill, H.R. 3762, may be postponed through the legisla-  
17 tive day of January 25, 2016, as though under clause 8  
18 of rule XX.
