# RESOLUTION

Providing for consideration of the bill (H.R. 1206) to prohibit the hiring of additional Internal Revenue Service employees until the Secretary of the Treasury certifies that no employee of the Internal Revenue Service has a seriously delinquent tax debt, and providing for consideration of the bill (H.R. 4885) to require that user fees collected by the Internal Revenue Service be deposited into the general fund of the Treasury.

1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider in the House the bill (H.R.  
3 1206) to prohibit the hiring of additional Internal Revenue  
4 Service employees until the Secretary of the Treasury cer-  
5 tifies that no employee of the Internal Revenue Service  
6 has a seriously delinquent tax debt. All points of order  
7 against consideration of the bill are waived. In lieu of the  
8 amendment in the nature of a substitute recommended by  
9 the Committee on Ways and Means now printed in the  
10 bill, an amendment in the nature of a substitute consisting  
11 of the text of Rules Committee Print 114-47 shall be con-  
12 sidered as adopted. The bill, as amended, shall be consid-  
13 ered as read. All points of order against provisions in the  
14 bill, as amended, are waived. The previous question shall  
15 be considered as ordered on the bill, as amended, and on  
16 any further amendment thereto, to final passage without  
17 intervening motion except: (1) one hour of debate equally  
18 divided and controlled by the chair and ranking minority  
19 member of the Committee on Ways and Means; (2) the  
20 further amendment printed in the report of the Committee  
21 on Rules accompanying this resolution, if offered by the  
22 Member designated in the report, which shall be in order  
23 without intervention of any point of order, shall be consid-  
24 ered as read, shall be separately debatable for the time  
25 specified in the report equally divided and controlled by

1 the proponent and an opponent, and shall not be subject  
2 to a demand for a division of the question; and (3) one  
3 motion to recommit with or without instructions.

4       SEC. 2. Upon adoption of this resolution it shall be  
5 in order to consider in the House the bill (H.R. 4885)  
6 to require that user fees collected by the Internal Revenue  
7 Service be deposited into the general fund of the Treasury.  
8 All points of order against consideration of the bill are  
9 waived. In lieu of the amendment in the nature of a sub-  
10 stitute recommended by the Committee on Ways and  
11 Means now printed in the bill, an amendment in the na-  
12 ture of a substitute consisting of the text of Rules Com-  
13 mittee Print 114-50 shall be considered as adopted. The  
14 bill, as amended, shall be considered as read. All points  
15 of order against provisions in the bill, as amended, are  
16 waived. The previous question shall be considered as or-  
17 dered on the bill, as amended, and on any further amend-  
18 ment thereto, to final passage without intervening motion  
19 except: (1) one hour of debate equally divided and con-  
20 trolled by the chair and ranking minority member of the  
21 Committee on Ways and Means; and (2) one motion to  
22 recommit with or without instructions.
