RESOLUTION

Providing for consideration of the Senate amendment to the bill (H.R. 2576) to modernize the Toxic Substances Control Act, and for other purposes, and providing for consideration of the bill (H.R. 897) to amend the Federal Insecticide, Fungicide, and Rodenticide Act and the Federal Water Pollution Control Act to clarify Congressional intent regarding the regulation of the use of pesticides in or near navigable waters, and for other purposes.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to take from the Speaker's table the bill
3 (H.R. 2576) to modernize the Toxic Substances Control
4 Act, and for other purposes, with the Senate amendment
5 thereto, and to consider in the House, without intervention
6 of any point of order, a motion offered by the chair of
7 the Committee on Energy and Commerce or his designee
8 that the House concur in the Senate amendment with an
9 amendment inserting the text of Rules Committee Print
10 114-54 modified by the amendment printed in the report
11 of the Committee on Rules accompanying this resolution
12 in lieu of the matter proposed to be inserted by the Senate.
13 The Senate amendment and the motion shall be consid-
14 ered as read. The motion shall be debatable for one hour
15 equally divided and controlled by the chair and ranking
16 minority member of the Committee on Energy and Com-
17 merce. The previous question shall be considered as or-
18 dered on the motion to its adoption without intervening
19 motion or demand for division of the question.

20 SEC. 2. Upon adoption of this resolution it shall be
21 in order to consider in the House the bill (H.R. 897) to
22 amend the Federal Insecticide, Fungicide, and
23 Rodenticide Act and the Federal Water Pollution Control
24 Act to clarify Congressional intent regarding the regula-
25 tion of the use of pesticides in or near navigable waters,

1 and for other purposes. All points of order against consid-
2 eration of the bill are waived. An amendment in the nature
3 of a substitute consisting of the text of Rules Committee
4 Print 114-53 shall be considered as adopted. The bill, as
5 amended, shall be considered as read. All points of order
6 against provisions in the bill, as amended, are waived. The
7 previous question shall be considered as ordered on the
8 bill, as amended, and on any further amendment thereto,
9 to final passage without intervening motion except: (1) one
10 hour of debate equally divided and controlled by the chair
11 and ranking minority member of the Committee on Trans-
12 portation and Infrastructure; and (2) one motion to re-
13 commit with or without instructions.
