Mr. BYRNE, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 5931) to provide for the prohibition on cash payments to the Government of Iran, and for other purposes, and waiving a requirement of clause 6(a) of rule XIII with respect to consideration of certain resolutions reported from the Committee on Rules.

- 1 *Resolved*, That at any time after adoption of this reso-
- 2 lution the Speaker may, pursuant to clause 2(b) of rule
- 3 XVIII, declare the House resolved into the Committee of

1 the Whole House on the state of the Union for consider-
2 ation of the bill (H.R. 5931) to provide for the prohibition
3 on cash payments to the Government of Iran, and for
4 other purposes. The first reading of the bill shall be dis-
5 pensed with. All points of order against consideration of
6 the bill are waived. General debate shall be confined to
7 the bill and shall not exceed one hour equally divided and
8 controlled by the chair and ranking minority member of
9 the Committee on Foreign Affairs. After general debate
10 the bill shall be considered for amendment under the five-
11 minute rule. In lieu of the amendment in the nature of
12 a substitute recommended by the Committee on Foreign
13 Affairs now printed in the bill, it shall be in order to con-
14 sider as an original bill for the purpose of amendment
15 under the five-minute rule an amendment in the nature
16 of a substitute consisting of the text of Rules Committee
17 Print 114-64. That amendment in the nature of a sub-
18 stitute shall be considered as read. All points of order
19 against that amendment in the nature of a substitute are
20 waived. No amendment to that amendment in the nature
21 of a substitute shall be in order except those printed in
22 the report of the Committee on Rules accompanying this
23 resolution. Each such amendment may be offered only in
24 the order printed in the report, may be offered only by
25 a Member designated in the report, shall be considered

1 as read, shall be debatable for the time specified in the
2 report equally divided and controlled by the proponent and
3 an opponent, shall not be subject to amendment, and shall
4 not be subject to a demand for division of the question
5 in the House or in the Committee of the Whole. All points
6 of order against such amendments are waived. At the con-
7 clusion of consideration of the bill for amendment the
8 Committee shall rise and report the bill to the House with
9 such amendments as may have been adopted. Any Member
10 may demand a separate vote in the House on any amend-
11 ment adopted in the Committee of the Whole to the bill
12 or to the amendment in the nature of a substitute made
13 in order as original text. The previous question shall be
14 considered as ordered on the bill and amendments thereto
15 to final passage without intervening motion except one
16 motion to recommit with or without instructions.

17 SEC. 2. The requirement of clause 6(a) of rule XIII
18 for a two-thirds vote to consider a report from the Com-
19 mittee on Rules on the same day it is presented to the
20 House is waived with respect to any resolution reported
21 through the legislative day of September 27, 2016, relat-
22 ing to a measure making or continuing appropriations for
23 the fiscal year ending September 30, 2017.
