## A BILL

To designate the same individual serving as the Chief Nurse Officer of the Public Health Service as the National Nurse for Public Health.

1       *Be it enacted by the Senate and House of Representa-  
2 tives of the United States of America in Congress assembled,*

**3 SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “National Nurse Act  
5 of 2015”.

**6 SEC. 2. NATIONAL NURSE FOR PUBLIC HEALTH.**

7       Title XVII of the Public Health Service Act (42  
8 U.S.C. 300u et seq.) is amended by adding at the end  
9 the following:

1   **“SEC. 1711. NATIONAL NURSE FOR PUBLIC HEALTH.**

2       “(a) ESTABLISHMENT.—

3           “(1) IN GENERAL.—The same individual des-  
4           ignated as the Chief Nurse Officer of the Public  
5           Health Service under section 205 shall also be des-  
6           gnated by the Secretary as the National Nurse for  
7           Public Health.

8           “(2) DESIGNATION.—Not later than 30 days  
9           after the date of enactment of this section, the Sec-  
10          retary shall designate the individual serving as the  
11          Chief Nurse Officer of the Public Health Service on  
12          such date as the first National Nurse for Public  
13          Health. Subsequent designations shall occur in ac-  
14          cordance with Commissioned Corps Instruction  
15          CC23.4.6 (relating to Chief Professional Officer  
16          Nominations), as in effect on February 13, 2008.

17       “(b) RANK AND GRADE.—The National Nurse for  
18          Public Health shall be of an equivalent rank to the Chief  
19          of the Army and Air Force Nurse Corps and the Director  
20          of Navy Nurse Corps.

21       “(c) DUTIES.—The National Nurse for Public Health  
22          shall carry out the following:

23           “(1) Provide leadership and coordination of  
24           Public Health Service nursing professional affairs  
25           for the Office of the Surgeon General and other  
26           agencies of the Public Health Service, including pro-

1 viding representation for the Government of the  
2 United States at the Global Forum for Government  
3 Chief Nursing and Midwifery Officers and serving as  
4 a member of the Federal Nursing Service Council.

5 “(2) Represent the Surgeon General and the  
6 agencies of Public Health Service in communications  
7 with groups and societies concerned with nursing  
8 issues at the local, State, national, and international  
9 levels.

10 “(3) Provide guidance and advice to the Sur-  
11 geon General and the Nurse Professional Advisory  
12 Committee on matters such as standards, recruit-  
13 ment, retention, readiness, and career development  
14 of nurses employed by and contracted with agencies  
15 of the Public Health Service.

16 “(4) Conduct outreach and education for pur-  
17 poses of paragraphs (5) through (7).

18 “(5) Provide guidance and leadership for activi-  
19 ties to promote the public health, including encour-  
20 aging nurses and other health professionals to be  
21 volunteers and developing projects that educate the  
22 public about and engage the public in prevention  
23 practices to achieve better health.

24 “(6) Provide guidance and leadership to encour-  
25 age nurses to engage in furthering their education in

1       order to conduct nursing research, increase the  
2       awareness of evidence-based practice, and educate  
3       future nurses.

4           “(7) Provide guidance and leadership for activi-  
5       ties that will increase public safety and emergency  
6       preparedness.

7           “(8) Prepare and publish a biennial report on  
8       the state of the Commissioned Corps of the Public  
9       Health Service Nurse Category.

10          “(d) NATIONAL HEALTH PRIORITIES—NATIONAL  
11       PREVENTION STRATEGY.—

12           “(1) IN GENERAL.—The National Nurse for  
13       Public Health, in cooperation with the Surgeon Gen-  
14       eral of the Public Health Service, heads of the agen-  
15       cies of the Public Health Service, States, and orga-  
16       nizations that represent health professionals, shall  
17       continue to participate in the identification of na-  
18       tional health priorities.

19           “(2) ADDRESSING NATIONAL HEALTH PRIOR-  
20       ITIES.—The National Nurse for Public Health, in  
21       addressing national health priorities, shall encourage  
22       volunteerism of nurses and other individuals, and  
23       strengthen the relationship between Government  
24       agencies and health-related national organizations.

25           “(3) COMMUNITY-BASED PROJECTS.—

1                 “(A) IMPLEMENTATION.—In addressing  
2                 national health priorities, the National Nurse  
3                 for Public Health shall—

4                         “(i) provide guidance and coordination  
5                         on recommended activities to organiza-  
6                         tions;

7                         “(ii) acknowledge successful programs  
8                         and encourage their replication;

9                         “(iii) promote the dissemination of  
10                         evidence-based practice in educating the  
11                         public on health promotion and disease  
12                         prevention activities;

13                         “(iv) encourage practicing nurses and  
14                         other health professionals, including retired  
15                         health professionals and students enrolled  
16                         in health professional programs, to partici-  
17                         pate in health promotion activities and rep-  
18                         licate successful health promotion activities  
19                         in their local communities; and

20                         “(v) collaborate with Federal agencies  
21                         to monitor activities being conducted  
22                         through the collection and evaluation of  
23                         data to determine if national health prior-  
24                         ties are being addressed.

1                 “(B) OUTREACH AND EDUCATION.—In  
2                 conducting outreach and education under sub-  
3                 section (c)(4), the National Nurse for Public  
4                 Health shall give priority to the inclusion of di-  
5                 verse approaches, including social media cam-  
6                 paigns, to address national health priorities.

7                 “(C) EVALUATIONS.—The National Nurse  
8                 for Public Health shall participate in preparing  
9                 the annual status report of the National Pre-  
10                 vention, Health Promotion and Public Health  
11                 Council under section 4001(h)(2) of the Patient  
12                 Protection and Affordable Care Act.

13                 “(D) DISSEMINATION OF INFORMATION.—  
14                 The National Nurse for Public Health shall dis-  
15                 seminate information to governmental agencies,  
16                 schools, and community-based, nonprofit orga-  
17                 nizations interested in health promotion and  
18                 improving public health through community ac-  
19                 tion.”.
