1 **SEC. 2. DEFINITION OF SECRETARY.**

2 In this Act, except as otherwise expressly provided,
3 the term “Secretary” means the Secretary of Transpor-
4 tation.

5 **SEC. 3. PASSENGER TRANSPORTATION; DEFINITIONS.**

6 Section 24102 is amended—

7 (1) by redesignating paragraphs (5) through
8 (9) as paragraphs (6) through (10), respectively;

9 (2) by inserting after paragraph (4), the fol-
10 lowing:

11 “(5) ‘long-distance route’ means a route de-
12 scribed in paragraph (6)(C).”;

13 (3) by amending paragraph (6)(A), as redesi-
14 gnated, to read as follows:

15 “(A) the Northeast Corridor main line be-
16 tween Boston, Massachusetts and the Virginia

 18 **APPROPRIATIONS**

19 **SEC. 101. AUTHORIZATION OF GRANTS TO AMTRAK.**

20 (a) IN GENERAL.—There are authorized to be appro-
 21 priated to the Secretary for the use of Amtrak for deposit
 22 into the accounts established under section 24319(a) of
 23 title 49, United States Code, the following amounts:

24 (1) For fiscal year 2016, \$1,450,000,000.

25 (2) For fiscal year 2017, \$1,550,000,000.

1 (3) For fiscal year 2018, \$1,700,000,000.

2 (4) For fiscal year 2019, \$1,900,000,000.

3 (b) PROJECT MANAGEMENT OVERSIGHT.—The Sec-
4 retary may withhold up to one half of 1 percent of the
5 amount appropriated under subsection (a) for the costs
6 of management oversight of Amtrak.

7 (c) COMPETITION.—In administering grants to Am-
8 trak under section 24318 of title 49, United States Code,
9 the Secretary may withhold, from amounts that would oth-
10 erwise be made available to Amtrak, such sums as are nec-
11 essary from the amount appropriated under subsection (a)
12 of this section to cover the operating subsidy described in
13 section 24711(b)(1)(E)(ii) of title 49, United States Code.

14 (d) STATE-SUPPORTED ROUTE COMMITTEE.—The
15 Secretary may withhold up to \$2,000,000 from the
16 amount appropriated in each fiscal year under subsection
17 (a) of this section for the use of the State-Supported
18 Route Committee established under section 24712 of title
19 49, United States Code.

20 (e) NORTHEAST CORRIDOR COMMISSION.—The Sec-
21 retary may withhold up to \$5,000,000 from the amount
22 appropriated in each fiscal year under subsection (a) of
23 this section for the use of the Northeast Corridor Commis-
24 sion established under section 24905 of title 49, United
25 States Code.

1 **SEC. 102. NATIONAL INFRASTRUCTURE AND SAFETY IN-**
 2 **VESTMENTS.**

3 (a) **IN GENERAL.**—There are authorized to be appro-
 4 priated to the Secretary for grants under chapter 244 of
 5 title 49, United States Code, the following amounts:

6 (1) For fiscal year 2016, \$350,000,000.

7 (2) For fiscal year 2017, \$430,000,000.

8 (3) For fiscal year 2018, \$600,000,000.

9 (4) For fiscal year 2019, \$900,000,000.

10 (b) **PROJECT MANAGEMENT OVERSIGHT.**—The Sec-
 11 retary may withhold up to 1 percent from the amount ap-
 12 propriated under subsection (a) of this section for the
 13 costs of project management oversight of grants carried
 14 out under chapter 244 of title 49, United States Code.

15 **SEC. 103. AUTHORIZATION OF APPROPRIATIONS FOR NA-**
 16 **TIONAL TRANSPORTATION SAFETY BOARD**
 17 **RAIL INVESTIGATIONS.**

18 (a) **IN GENERAL.**—Notwithstanding any other provi-
 19 sion of law, there are authorized to be appropriated to the
 20 National Transportation Safety Board to carry out rail-
 21 road accident investigations under section 1131(a)(1)(C)
 22 of title 49, United States Code, the following amounts:

23 (1) For fiscal year 2016, \$6,300,000.

24 (2) For fiscal year 2017, \$6,400,000.

25 (3) For fiscal year 2018, \$6,500,000.

26 (4) For fiscal year 2019, \$6,600,000.

1 (b) **INVESTIGATION PERSONNEL.**—Amounts appro-
 2 priated under subsection (a) of this section shall be avail-
 3 able to the National Transportation Safety Board for per-
 4 sonnel, in regional offices and in Washington, DC, whose
 5 duties involve railroad accident investigations.

6 **SEC. 104. AUTHORIZATION OF APPROPRIATIONS FOR AM-**
 7 **TRAK OFFICE OF INSPECTOR GENERAL.**

8 There are authorized to be appropriated to the Office
 9 of Inspector General of Amtrak the following amounts:

10 (1) For fiscal year 2016, \$20,000,000.

11 (2) For fiscal year 2017, \$20,500,000.

12 (3) For fiscal year 2018, \$21,000,000.

13 (4) For fiscal year 2019, \$21,500,000.

14 **SEC. 105. NATIONAL COOPERATIVE RAIL RESEARCH PRO-**
 15 **GRAM.**

16 (a) **IN GENERAL.**—Section 24910 is amended—

17 (1) in subsection (b)—

18 (A) in paragraph (12), by striking “and”;

19 (B) in paragraph (13), by striking the pe-
 20 riod at the end and inserting “; and”;

21 (C) by adding at the end the following:

22 “(14) to improve the overall safety of intercity
 23 passenger and freight rail operations.”; and

24 (2) by amending subsection (c) to read as fol-
 25 lows:

1 “(e) ALLOCATION.—At least \$5,000,000 of the
 2 amounts appropriated to the Secretary for a fiscal year
 3 to carry out railroad research and development programs
 4 shall be available to carry out this section.”.

5 **TITLE II—AMTRAK REFORM**

6 **SEC. 201. AMTRAK GRANT PROCESS.**

7 (a) REQUIREMENTS AND PROCEDURES.—Chapter
 8 243 is amended by adding at the end the following:

9 **“§ 24317. Costs and revenues**

10 “(a) ALLOCATION.—Not later than 180 days after
 11 the date of enactment of the Railroad Reform, Enhance-
 12 ment, and Efficiency Act, Amtrak shall establish and
 13 maintain internal controls to ensure Amtrak’s costs, reve-
 14 nues, and other compensation are appropriately and pro-
 15 portionally allocated to its Northeast Corridor train serv-
 16 ices or infrastructure, its State-supported routes, its long-
 17 distance routes, and its other national network activities.

18 “(b) RULE OF CONSTRUCTION.—Nothing in this sec-
 19 tion shall be construed to limit the ability of Amtrak to
 20 enter into an agreement with 1 or more States to allocate
 21 operating and capital costs under section 209 of the Pas-
 22 senger Rail Investment and Improvement Act of 2008 (49
 23 U.S.C. 24101 note).

1 **“§ 24318. Grant process**

2 “(a) PROCEDURES FOR GRANT REQUESTS.—Not
3 later than 90 days after the date of enactment of the Rail-
4 road Reform, Enhancement, and Efficiency Act, the Sec-
5 retary of Transportation shall establish and transmit to
6 the Committee on Commerce, Science, and Transportation
7 and the Committee on Appropriations of the Senate and
8 the Committee on Transportation and Infrastructure and
9 the Committee on Appropriations of the House of Rep-
10 resentatives substantive and procedural requirements, in-
11 cluding schedules, for grant requests under this section.

12 “(b) GRANT REQUESTS.—Amtrak shall transmit
13 grant requests for Federal funds appropriated to the Sec-
14 retary of Transportation for the use of Amtrak to—

15 “(1) the Secretary; and

16 “(2) the Committee on Commerce, Science, and
17 Transportation; the Committee on Appropriations;
18 and the Committee on the Budget of the Senate and
19 the Committee on Transportation and Infrastruc-
20 ture; the Committee on Appropriations; and the
21 Committee on the Budget of the House of Rep-
22 resentatives.

23 “(c) CONTENTS.—A grant request under subsection
24 (b) shall—

25 “(1) describe projected operating and capital
26 costs for the upcoming fiscal year for Northeast Cor-

1 ridor train services and infrastructure, Amtrak's
2 State-supported routes, and Amtrak's long-distance
3 routes, and Amtrak's other national network activi-
4 ties, as applicable, in comparison to prior fiscal year
5 actual financial performance;

6 “(2) describe the capital projects to be funded,
7 with cost estimates and an estimated timetable for
8 completion of the projects covered by the request;

9 “(3) assess Amtrak's financial condition;

10 “(4) be displayed on Amtrak's Web site within
11 a reasonable timeframe following its transmission
12 under subsection (b); and

13 “(5) describe how the funding requested in a
14 grant will be allocated to the accounts established
15 under section 24319(a), considering the projected
16 operating losses or capital costs for services and ac-
17 tivities associated with such accounts over the time
18 period intended to be covered by the grants.

19 “(d) REVIEW AND APPROVAL.—

20 “(1) THIRTY-DAY APPROVAL PROCESS.—

21 “(A) IN GENERAL.—Not later than 30
22 days after the date that Amtrak submits a
23 grant request under this section, the Secretary
24 of Transportation shall complete a review of the
25 request and provide notice to Amtrak that—

1 “(i) the request is approved; or

2 “(ii) the request is disapproved, in-
3 cluding the reason for the disapproval and
4 an explanation of any incomplete or defi-
5 cient items.

6 “(B) GRANT AGREEMENT.—If a grant re-
7 quest is approved, the Secretary shall enter into
8 a grant agreement with Amtrak that allocates
9 the grant funding to 1 of the 4 accounts estab-
10 lished under section 24319(a).

11 “(2) FIFTEEN-DAY MODIFICATION PERIOD.—
12 Not later than 15 days after the date of the notice
13 under paragraph (1)(A)(ii), Amtrak shall submit a
14 modified request for the Secretary’s review.

15 “(3) MODIFIED REQUESTS.—Not later than 15
16 days after the date that Amtrak submits a modified
17 request under paragraph (2), the Secretary shall ei-
18 ther approve the modified request, or, if the Sec-
19 retary finds that the request is still incomplete or
20 deficient, the Secretary shall identify in writing to
21 the Committee on Commerce, Science, and Trans-
22 portation, the Committee on Appropriations, and the
23 Committee on the Budget of the Senate and the
24 Committee on Transportation and Infrastructure,
25 the Committee on Appropriations, and the Com-

1 mittee on the Budget of the House of Representa-
2 tives the remaining deficiencies and recommend a
3 process for resolving the outstanding portions of the
4 request.

5 “(e) PAYMENTS TO AMTRAK.—

6 “(1) IN GENERAL.—A grant agreement entered
7 into under subsection (d) shall specify the oper-
8 ations, services, and other activities to be funded by
9 the grant. The grant agreement shall include provi-
10 sions, consistent with the requirements of this chap-
11 ter, to measure Amtrak’s performance and ensure
12 accountability in delivering the operations, services,
13 or activities to be funded by the grant.

14 “(2) SCHEDULE.—Except as provided in para-
15 graph (3), in each fiscal year for which amounts are
16 appropriated to the Secretary for the use of Amtrak,
17 and for which the Secretary and Amtrak have en-
18 tered into a grant agreement under subsection (d),
19 the Secretary shall disburse grant funds to Amtrak
20 on the following schedule:

21 “(A) 50 percent on October 1.

22 “(B) 25 percent on January 1.

23 “(C) 25 percent on April 1.

24 “(3) EXCEPTIONS.—The Secretary may make a
25 payment to Amtrak of appropriated funds—

1 “(A) more frequently than the schedule
2 under paragraph (2) if Amtrak, for good cause,
3 requests more frequent payment before the end
4 of a payment period; or

5 “(B) with a different frequency or in dif-
6 ferent percentage allocations in the event of a
7 continuing resolution or in the absence of an
8 appropriations Act for the duration of a fiscal
9 year.

10 “(f) AVAILABILITY OF AMOUNTS AND EARLY APPRO-
11 PRIATIONS.—Amounts appropriated to the Secretary for
12 the use of Amtrak shall remain available until expended.
13 Amounts for capital acquisitions and improvements may
14 be appropriated for a fiscal year before the fiscal year in
15 which the amounts will be obligated.

16 “(g) LIMITATIONS ON USE.—Amounts appropriated
17 to the Secretary for the use of Amtrak may not be used
18 to cross-subsidize operating losses or capital costs of com-
19 muter rail passenger or freight rail transportation.

22 not later than October 1, 2016, Amtrak, in consultation

13 “(A) capital projects described in section
 14 24904(a)(2)(E)(i), and developed under the
 15 planning process established under that section,
 16 to bring Northeast Corridor infrastructure to a
 17 state-of-good-repair;

18 “(B) capital projects described in clauses
 19 (ii) and (iv) of section 24904(a)(2)(E) that are
 20 developed under the planning process estab-
 21 lished under that section intended to increase
 22 corridor capacity, improve service reliability,
 23 and reduce travel time on the Northeast Cor-
 24 ridor;

1 “(C) capital projects to improve safety and
2 security;

3 “(D) capital projects to improve customer
4 service and amenities;

5 “(E) acquiring, rehabilitating, manufac-
6 turing, remanufacturing, overhauling, or im-
7 proving equipment and associated facilities used
8 for intercity rail passenger transportation by
9 Northeast Corridor train services;

10 “(F) retirement of principal and payment
11 of interest on loans for capital projects de-
12 scribed in this paragraph or for capital leases

17 Transportation and Infrastructure of the House of
18 Representatives.

19 ~~“(g) RULE OF CONSTRUCTION.—~~The decisions of the
20 Committee—

21 ~~“(1) shall pertain to the rail operations of Am-~~
22 ~~trak and related activities of trains operated by Am-~~
23 ~~trak on State-sponsored routes; and~~

1 to use in determining what intercity rail passenger trans-
2 portation routes and services it should provide, including
3 the establishment of new routes, the elimination of exist-
4 ing routes, and the contraction or expansion of services
5 or frequencies over such routes.

6 “(b) CONSIDERATIONS.—Amtrak shall require the
7 independent entity, in developing the methodologies de-
8 scribed in subsection (a), to consider—

9 “(1) the current and expected performance and
10 service quality of intercity rail passenger transpor-
11 tation operations, including cost recovery, on-time
12 performance, ridership, on-board services, stations,
13 facilities, equipment, and other services;

14 “(2) the connectivity of a route with other
15 routes;

16 “(3) the transportation needs of communities
17 and populations that are not well served by intercity
18 rail passenger transportation service or by other
19 forms of intercity transportation;

20 “(4) the methodologies of Amtrak and major
21 intercity rail passenger transportation service pro-
22 viders in other countries for determining intercity
23 passenger rail routes and services;

1 “(5) the financial and operational effects on the
2 overall network, including the effects on indirect
3 costs;

4 “(6) the views of States and the recommenda-
5 tions described in State rail plans, rail carriers that
6 own infrastructure over which Amtrak operates,
7 Interstate Compacts established by Congress and
8 States, Amtrak employee representatives, stake-
9 holder organizations, and other interested parties;
10 and

11 “(7) the funding levels that will be available
12 under authorization levels that have been enacted
13 into law.

14 “(e) RECOMMENDATIONS.—Not later than 1 year
15 after the date of enactment of the Railroad Reform, En-
16 hancement, and Efficiency Act, Amtrak shall transmit to
17 the Committee on Commerce, Science, and Transportation
18 of the Senate and the Committee on Transportation and
19 Infrastructure of the House of Representatives rec-
20 ommendations developed by the independent entity under
21 subsection (a).

22 “(d) CONSIDERATION OF RECOMMENDATIONS.—Not
23 later than 90 days after the date the recommendations are
24 transmitted under subsection (e), Amtrak shall consider
25 the adoption of each recommendation and transmit to the

1 Committee on Commerce, Science, and Transportation of
 2 the Senate and the Committee on Transportation and In-
 3 frastructure of the House of Representatives a report ex-
 4 plaining the reasons for adopting or not adopting each rec-
 5 ommendation.”.

6 **SEC. 205. COMPETITION.**

7 (a) ALTERNATE PASSENGER RAIL SERVICE PILOT
 8 PROGRAM.—Section 24711 is amended to read as follows:
 9 “§ 24711. **Alternate passenger rail service pilot pro-**
 10 **gram**

11 “(a) IN GENERAL.—Not later than 18 months after
 12 the date of enactment of the Railroad Reform, Enhance-
 13 ment, and Efficiency Act, the Secretary of Transportation
 14 shall promulgate a rule to implement a pilot program for
 15 competitive selection of rail carriers for long-distance
 16 routes (as defined in section 24102).

17 “(b) PILOT PROGRAM REQUIREMENTS.—

18 “(1) IN GENERAL.—The pilot program shall—

19 “(A) allow a party described in paragraph
 20 (2) to petition the Secretary to provide intercity
 21 rail passenger transportation over a long-dis-
 22 tance route in lieu of Amtrak for an operations
 23 period of 4 years from the date of commence-
 24 ment of service by the winning bidder and, at
 25 the option of the Secretary, consistent with the

1 rule promulgated under subsection (a), allow
2 the contract to be renewed for an additional op-
3 erations period of 4 years, but not to exceed a
4 total of 3 operations periods;

5 “(B) require the Secretary to—

6 “(i) notify the petitioner and Amtrak
7 of receipt of the petition under subpara-
8 graph (A) and to publish in the Federal
9 Register a notice of receipt not later than
10 30 days after the date of receipt; and

11 “(ii) establish a deadline, of not more
12 than 120 days after the notice of receipt is
13 published in the Federal Register under
14 clause (i), by which both the petitioner and
15 Amtrak, if Amtrak chooses to do so, would
16 be required to submit a complete bid to
17 provide intercity rail passenger transpor-
18 tation over the applicable route;

19 “(C) require that each bid—

20 “(i) describe the capital needs, finan-
21 cial projections, and operational plans, in-
22 cluding staffing plans, for the service, and
23 such other factors as the Secretary con-
24 siders appropriate; and

1 “(ii) be made available by the winning
2 bidder to the public after the bid award;

3 “(D) for a route that receives funding
4 from a State or States, require that for each
5 bid received from a party described in para-
6 graph (2); other than a State, the Secretary
7 have the concurrence of the State or States that
8 provide funding for that route;

9 “(E) for a winning bidder that is not or
10 does not include Amtrak, require the Secretary
11 to execute a contract not later than 270 days
12 after the deadline established under subpara-
13 graph (B)(ii) and award to the winning bid-
14 der—

15 “(i) subject to paragraphs (3) and
16 (4), the right and obligation to provide
17 intercity rail passenger transportation over
18 that route subject to such performance
19 standards as the Secretary may require;
20 and

21 “(ii) an operating subsidy, as deter-
22 mined by the Secretary, for—

23 “(I) the first year at a level that
24 does not exceed 90 percent of the level
25 in effect for that specific route during

1 the fiscal year preceding the fiscal
2 year in which the petition was re-
3 ceived, adjusted for inflation; and

4 “(H) any subsequent years at the
5 level calculated under subclause (I),
6 adjusted for inflation; and

7 “(F) for a winning bidder that is or in-
8 cludes Amtrak, award to that bidder an oper-
9 ating subsidy, as determined by the Secretary,
10 over the applicable route that will not change
11 during the fiscal year in which the bid was sub-
12 mitted solely as a result of the winning bid.

13 “(2) ELIGIBLE PETITIONERS.—The following
14 parties are eligible to submit petitions under para-
15 graph (1):

16 “(A) A rail carrier or rail carriers that own
17 the infrastructure over which Amtrak operates
18 a long-distance route.

19 “(B) A rail passenger carrier with a writ-
20 ten agreement with the rail carrier or rail car-
21 riers that own the infrastructure over which
22 Amtrak operates a long-distance route and that
23 host or would host the intercity rail passenger
24 transportation.

1 “(C) A State, group of States, or State-
2 supported joint powers authority or other sub-
3 State governance entity responsible for provi-
4 sion of intercity rail passenger transportation
5 with a written agreement with the rail carrier
6 or rail carriers that own the infrastructure over
7 which Amtrak operates a long-distance route
8 and that host or would host the intercity rail
9 passenger transportation.

10 “(D) A State, group of States, or State-
11 supported joint powers authority or other sub-
12 State governance entity responsible for provi-
13 sion of intercity rail passenger transportation
14 and a rail passenger carrier with a written
15 agreement with the rail carrier or rail carriers
16 that own the infrastructure over which Amtrak
17 operates a long-distance route and that host or
18 would host the intercity rail passenger transpor-
19 tation.

20 “(3) PERFORMANCE STANDARDS.—If the win-
21 ning bidder under paragraph (1)(E)(i) is not or does
22 not include Amtrak, the performance standards shall
23 be consistent with the performance required of or
24 achieved by Amtrak on the applicable route during
25 the last fiscal year.

1 “(4) AGREEMENT GOVERNING ACCESS
 2 ISSUES.—Unless the winning bidder already has ap-
 3 plicable access agreements in place or includes a rail
 4 carrier that owns the infrastructure used in the op-
 5 eration of the route, the winning bidder under para-
 6 graph (1)(E)(i) shall enter into a written agreement
 7 governing access issues between the winning bidder
 8 and the rail carrier or rail carriers that own the in-
 9 frastructure over which the winning bidder would
 10 operate and that host or would host the intercity rail
 11 passenger transportation.

12 “(e) ACCESS TO FACILITIES; EMPLOYEES.—If the
 13 Secretary awards the right and obligation to provide rail
 14 passenger transportation over a route under this section
 15 to an entity in lieu of Amtrak—

16 “(1) the Secretary shall require Amtrak to pro-
 17 vide access to the Amtrak-owned reservation system,
 18 stations, and facilities directly related to operations
 19 of the awarded routes to the rail passenger carrier
 20 awarded a contract under this section, in accordance
 21 with subsection (g), as necessary to carry out the
 22 purposes of this section;

23 “(2) an employee of any person, except for a
 24 freight railroad or a person employed or contracted
 25 by a freight railroad, used by such rail passenger

1 carrier in the operation of a route under this section
2 shall be considered an employee of that rail pas-
3 senger carrier and subject to the applicable Federal
4 laws and regulations governing similar crafts or
5 classes of employees of Amtrak; and

6 “(3) the winning bidder shall provide hiring
7 preference to qualified Amtrak employees displaced
8 by the award of the bid, consistent with the staffing
9 plan submitted by the bidder, and shall be subject
10 to the grant conditions under section 24405.

11 “(d) CESSATION OF SERVICE.—If a rail passenger
12 carrier awarded a route under this section ceases to oper-
13 ate the service or fails to fulfill an obligation under the
14 contract required under subsection (b)(1)(E), the Sec-
15 retary shall take any necessary action consistent with this
16 title to enforce the contract and ensure the continued pro-
17 vision of service, including—

18 “(1) the installment of an interim rail pas-
19 senger carrier;

20 “(2) providing to the interim rail passenger ear-
21 nier under paragraph (1) an operating subsidy nec-
22 essary to provide service; and

23 “(3) rebidding the contract to operate the rail
24 passenger transportation.

25 “(e) BUDGET AUTHORITY.—

1 “(1) IN GENERAL.—The Secretary shall provide
2 to a winning bidder that is not or does not include
3 Amtrak and that is selected under this section any
4 appropriations withheld under section 101(e) of the
5 Railroad Reform, Enhancement, and Efficiency Act,
6 or any subsequent appropriation for the same pur-
7 pose, necessary to cover the operating subsidy de-
8 scribed in subsection (b)(1)(E)(ii).

9 “(2) AMTRAK.—If the Secretary selects a win-
10 ning bidder that is not or does not include Amtrak,
11 the Secretary may provide to Amtrak an appropriate
12 portion of the appropriations under section 101(a) of
13 the Railroad Reform, Enhancement, and Efficiency
14 Act, or any subsequent appropriation for the same
15 purpose, to cover any cost directly attributable to
16 the termination of Amtrak service on the route and
17 any indirect costs to Amtrak imposed on other Am-
18 trak routes as a result of losing service on the route
19 operated by the winning bidder. Any amount pro-
20 vided by the Secretary to Amtrak under this para-
21 graph shall not be deducted from or have any effect
22 on the operating subsidy described in subsection
23 (b)(1)(E)(ii).

24 “(f) DEADLINE.—If the Secretary does not promul-
25 gate the final rule and implement the program before the

1 deadline under subsection (a), the Secretary shall submit
2 to the Committee on Commerce, Science, and Transpor-
3 tation of the Senate and the Committee on Transportation
4 and Infrastructure of the House of Representatives a let-
5 ter, signed by the Secretary and Administrator of the Fed-
6 eral Railroad Administration, each month until the rule
7 is complete, including—

8 “(1) the reasons why the rule has not been
9 issued;

10 “(2) an updated staffing plan for completing
11 the rule as soon as feasible;

12 “(3) the contact information of the official that
13 will be overseeing the execution of the staffing plan;

17 “(g) DISPUTES.—If Amtrak and the rail passenger
18 carrier awarded a route under this section cannot agree
19 upon terms to carry out subsection (c)(1), and the Surface
20 Transportation Board finds that access to Amtrak’s facili-
21 ties or equipment, or the provision of services by Amtrak,
22 is necessary under subsection (c)(1) and that the oper-
23 ation of Amtrak’s other services will not be impaired
24 thereby, the Surface Transportation Board shall issue an
25 order that the facilities and equipment be made available;

1 and that services be provided, by Amtrak, and shall deter-
2 mine reasonable compensation, liability, and other terms
3 for use of the facilities and equipment and provision of
4 the services.

5 “(h) LIMITATION.—Not more than 3 long-distance
6 routes may be selected under this section for operation by
7 a winning bidder that is not or does not include Amtrak.

8 “(i) PRESERVATION OF RIGHT TO COMPETITION ON
9 STATE-SUPPORTED ROUTES.—Nothing in this section
10 shall be construed as prohibiting a State from introducing
11 competition for intercity rail passenger transportation or
12 services on its State-supported route or routes.”

13 (b) REPORT.—Not later than 4 years after the date
14 of implementation of the pilot program under section
15 24711 of title 49, United States Code, and quadrennially
16 thereafter until the pilot program is discontinued, the Sec-
17 retary shall submit to the Committee on Commerce,
18 Science, and Transportation of the Senate and the Com-
19 mittee on Transportation and Infrastructure of the House
20 of Representatives a report on the results on the pilot pro-
21 gram to date and any recommendations for further action.

22 **SEC. 206. ROLLING STOCK PURCHASES.**

23 (a) IN GENERAL.—Prior to entering into any con-
24 tract in excess of \$100,000,000 for rolling stock and loco-
25 motive procurements Amtrak shall submit a business case

1 analysis to the Secretary, the Committee on Commerce,
 2 Science, and Transportation and the Committee on Appro-
 3 priations of the Senate and the Committee on Transpor-
 4 tation and Infrastructure and the Committee on Appro-
 5 priations of the House of Representatives, on the utility
 6 of such procurements.

7 (b) ~~CONTENTS.~~—The business case analysis shall—

8 (1) include a cost and benefit comparison that
 9 describes the total lifecycle costs and the anticipated
 10 benefits related to revenue, operational efficiency, re-
 11 liability, and other factors;

12 (2) set forth the total payments by fiscal year;

13 (3) identify the specific source and amounts of
 14 funding for each payment, including Federal funds,
 15 State funds, Amtrak profits, Federal, State, or pri-
 16 vate loans or loan guarantees, and other funding;

17 (4) include an explanation of whether any pay-
 18 ment under the contract will increase Amtrak's
 19 grant request, as required under section 24318 of
 20 title 49, United States Code, in that particular fiscal
 21 year; and

22 (5) describe how Amtrak will adjust the pro-
 23 curement if future funding is not available.

24 (c) ~~RULE OF CONSTRUCTION.~~—Nothing in this sec-
 25 tion shall be construed as requiring Amtrak to disclose

1 confidential information regarding a potential vendor's
 2 proposed pricing or other sensitive business information
 3 prior to contract execution.

4 **SEC. 207. FOOD AND BEVERAGE POLICY.**

5 (a) IN GENERAL.—Chapter 243, as amended in sec-
 6 tion 202 of this Act, is further amended by adding after
 7 section 24320 the following:

9 “(a) PLAN.—Not later than 90 days after the date

22 “(3) product development and supply chain effi-

24 “(4) training, awards, and accountability;

1 ~~“(5) technology enhancements and process im-~~
2 ~~provements; and~~

3 ~~“(6) ticket revenue allocation.~~

4 ~~“(c) SAVINGS CLAUSE.—Amtrak shall ensure that no~~
5 ~~Amtrak employee holding a position as of the date of en-~~
6 ~~actment of the Railroad Reform, Enhancement, and Effi-~~
7 ~~ciency Act is involuntarily separated because of—~~

8 ~~“(1) the development and implementation of the~~

11 ~~plement this section.~~

12 ~~“(d) NO FEDERAL FUNDING FOR OPERATING~~
13 ~~LOSSES.—Beginning on the date that is 4 years after the~~

15 ~~and Efficiency Act, no Federal funds may be used to cover~~
16 ~~any operating loss associated with providing food and bev-~~

4 (b) CONFORMING AMENDMENT.—The table of con-

7 **SEC. 208. LOCAL PRODUCTS AND PROMOTIONAL EVENTS.**

6 ~~(c)~~ PROGRAM ADMINISTRATION.—The pilot program
7 shall—

8 ~~(1)~~ for local food and beverage products, ensure
9 the products are integrated into existing food and
10 beverage services, including compliance with all ap-
11 plicable regulations and standards;

12 ~~(2)~~ for promotional events, ensure the events
13 are held in compliance with all applicable regulations
14 and standards, including terms to address insurance
15 requirements; and

16 ~~(3)~~ require an annual report that documents
17 revenues and costs and indicates whether the prod-
18 ucts or events resulted in a reduction in the financial
19 contribution of a State or States to the applicable
20 State-supported route.

21 ~~(d)~~ REPORT.—Not later than 4 years after the date
22 of establishment of the pilot programs under this section,
23 Amtrak shall report to the Committee on Commerce,
24 Science, and Transportation of the Senate and the Com-
25 mittee on Transportation and Infrastructure of the House

1 of Representatives on which States have participated in
2 the pilot programs under this section. The report shall
3 summarize the financial and operational outcomes of the
4 pilot programs.

5 (e) **RULE OF CONSTRUCTION.**—Nothing in this sub-
6 section shall be construed as limiting Amtrak’s ability to
7 operate special trains in accordance with section 216 of
8 the Passenger Rail Investment and Improvement Act of
9 2008 (49 U.S.C. 24308 note).

10 **SEC. 209. RIGHT-OF-WAY LEVERAGING.**

11 (a) **REQUEST FOR PROPOSALS.**—

12 (1) **IN GENERAL.**—Not later than 1 year after
13 the date of enactment of this Act, Amtrak shall
14 issue a Request for Proposals seeking qualified per-
15 sons or entities to utilize right-of-way and real estate
16 owned, controlled, or managed by Amtrak for tele-
17 communications systems, energy distribution sys-
18 tems, and other activities considered appropriate by
19 Amtrak.

20 (2) **CONTENTS.**—The Request for Proposals
21 shall provide sufficient information on the right-of-
22 way and real estate assets to enable respondents to
23 propose an arrangement that will monetize or gen-
24 erate additional revenue from such assets through

1 revenue sharing or leasing agreements with Amtrak,
2 to the extent possible.

3 (b) CONSIDERATION OF PROPOSALS.—Not later than

18 (d) SAVINGS CLAUSE.—Nothing in this section shall
19 be construed to limit Amtrak's ability to utilize right-of-
20 way or real estate assets that it currently owns, controls,
21 or manages or constrain Amtrak's ability to enter into
22 agreements with other parties to utilize such assets.

23 **SEC. 210. STATION DEVELOPMENT.**

24 (a) REPORT ON DEVELOPMENT OPTIONS.—Not later
25 than 1 year after the date of enactment of this Act, Am-

1 trak shall transmit to the Committee on Commerce,
2 Science, and Transportation of the Senate and the Com-
3 mittee on Transportation and Infrastructure of the House
4 of Representatives a report on options to enhance eco-
5 nomic development and accessibility of and around Am-
6 trak stations and terminals, for the purposes of—

7 (1) improving station condition, functionality,
8 capacity, and customer amenities;

9 (2) generating additional investment capital and
10 development-related revenue streams;

11 (3) increasing ridership and revenue;

12 (4) complying with the applicable sections of
13 the Americans with Disabilities Act of 1990 (42
14 U.S.C. 12101 et seq.) and the Rehabilitation Act of
15 1973 (29 U.S.C. 701 et seq.); and

16 (5) strengthening multimodal connections, in-
17 cluding transit, intercity buses, roll-on and roll-off
18 bicycles, and airports, as appropriate.

19 (b) REQUEST FOR INFORMATION.—Not later than 90
20 days after the date the report is transmitted under sub-
21 section (a), Amtrak shall issue a Request of Information
22 for 1 or more owners of stations served by Amtrak to for-
23 mally express an interest in completing the requirements
24 of this section.

25 (c) PROPOSALS.—

1 (1) REQUEST FOR PROPOSALS.—Not later than
2 180 days after the date the Request for Information
3 is issued under subsection (a), Amtrak shall issue a
4 Request for Proposals from qualified persons, in-
5 cluding small business concerns owned and con-
6 trolled by socially and economically disadvantaged
7 individuals and veteran-owned small businesses, to
8 lead, participate, or partner with Amtrak, a station
9 owner that responded under subsection (b), and
10 other entities in enhancing development in and
11 around such stations and terminals using applicable
12 options identified under subsection (a) at facilities
13 selected by Amtrak.

14 (2) CONSIDERATION OF PROPOSALS.—Not later
15 than 1 year after the date the Request for Proposals
16 are issued under paragraph (1), Amtrak shall review
17 and consider qualified proposals submitted under
18 paragraph (1). Amtrak or a station owner that re-
19 sponded under subsection (b) may enter into such
20 agreements as are necessary to implement any quali-
21 fied proposal.

22 (d) REPORT.—Not later than 3 years after the date
23 of enactment of this Act, Amtrak shall transmit to the
24 Committee on Commerce, Science, and Transportation of
25 the Senate and the Committee on Transportation and In-

1 frastructure of the House of Representatives a report on
2 the Request for Proposals process required under this sec-
3 tion, including summary information of any qualified pro-
4 posals submitted to Amtrak and any proposals acted upon
5 by Amtrak or a station owner that responded under sub-
6 section (b).

7 (e) DEFINITIONS.—In this section, the terms “small
8 business concern”, “socially and economically disadvan-
9 tagged individual”, and “veteran-owned small business”
10 have the meanings given the terms in section 304(e) of
11 this Act.

12 (f) SAVINGS CLAUSE.—Nothing in this section shall
13 be construed to limit Amtrak’s ability to develop its sta-
14 tions, terminals, or other assets, to constrain Amtrak’s
15 ability to enter into and carry out agreements with other
16 parties to enhance development at or around Amtrak sta-
17 tions or terminals, or to affect any station development
18 initiatives ongoing as of the date of enactment of this Act.

19 **SEC. 211. AMTRAK DEBT.**

20 Section 205 of the Passenger Rail Investment and
21 Improvement Act of 2008 (49 U.S.C. 24101 note) is
22 amended—

23 (1) by striking “as of the date of enactment of
24 this Act” each place it appears;

25 (2) in subsection (a)—

1 (A) by inserting “, to the extent provided
2 in advance in appropriations Acts” after “Am-
3 trak’s indebtedness”; and

4 (B) by striking the second sentence;

5 (3) in subsection (b), by striking “The Sec-
6 retary of the Treasury, in consultation” and insert-
7 ing “To the extent amounts are provided in advance
8 in appropriations Acts, the Secretary of the Treas-
9 ury, in consultation”;

10 (4) in subsection (d), by inserting “, to the ex-
11 tent provided in advance in appropriations Acts”
12 after “as appropriate”;

13 (5) in subsection (e)—

14 (A) in paragraph (1), by striking “by sec-
15 tion 102 of this division”; and

16 (B) in paragraph (2), by striking “by sec-
17 tion 102” and inserting “for Amtrak”;

18 (6) in subsection (g), by inserting “, unless that
19 debt receives credit assistance, including direct loans
20 and loan guarantees, under chapter 6 of title 23,
21 United States Code or title V of the Railroad Revi-
22 talization and Regulatory Act of 1976 (45 U.S.C.
23 821 et seq.)” after “Secretary”; and

24 (7) by striking subsection (h).

1 **SEC. 212. AMTRAK PILOT PROGRAM FOR PASSENGERS**
2 **TRANSPORTING DOMESTICATED CATS AND**
3 **DOGS.**

4 (a) **IN GENERAL.**—Not later than 1 year after the
5 date of enactment of this Act, Amtrak shall develop a pilot
6 program that allows passengers to transport domesticated
7 cats or dogs on certain trains operated by Amtrak.

8 (b) **PET POLICY.**—In developing the pilot program
9 required under subsection (a), Amtrak shall—

10 (1) in the case of a passenger train that is com-
11 prised of more than 1 car, designate, where feasible,
12 at least 1 car in which a ticketed passenger may
13 transport a domesticated cat or dog in the same
14 manner as carry-on baggage if—

15 (A) the cat or dog is contained in a pet
16 kennel;

17 (B) the pet kennel complies with Amtrak
18 size requirements for carriage of carry-on bag-
19 gage;

20 (C) the passenger is traveling on a train
21 operating on a route described in subparagraph
22 (A), (B), or (D) of section 24102(6) of title 49,
23 United States Code; and

24 (D) the passenger pays a fee described in
25 paragraph (3);

1 (2) allow a ticketed passenger to transport a
2 domesticated cat or dog on a train in the same man-
3 ner as cargo if—

4 (A) the cat or dog is contained in a pet
5 kennel;

6 (B) the pet kennel is stowed in accordance
7 with Amtrak requirements for cargo stowage;

8 (C) the passenger is traveling on a train
9 operating on a route described in subparagraph
10 (A), (B), or (D) of section 24102(6) of title 49,
11 United States Code;

12 (D) the cargo area is temperature con-
13 trolled in a manner protective of cat and dog
14 safety and health; and

15 (E) the passenger pays a fee described in
16 paragraph (3); and

17 (3) collect fees for each cat or dog transported
18 by a ticketed passenger in an amount that, in the
19 aggregate and at a minimum, covers the full costs
20 of the pilot program.

21 (c) REPORT.—Not later than 1 year after the pilot
22 program required under subsection (a) is first imple-
23 mented, Amtrak shall transmit to the Committee on Com-
24 merce, Science, and Transportation of the Senate and the
25 Committee on Transportation and Infrastructure of the

1 House of Representatives a report containing an evalua-
 2 tion of the pilot program.

3 (d) LIMITATION ON STATUTORY CONSTRUCTION.—

4 (1) SERVICE ANIMALS.—The pilot program
 5 under subsection (a) shall be separate from and in
 6 addition to the policy governing Amtrak passengers
 7 traveling with service animals. Nothing in this sec-
 8 tion may be interpreted to limit or waive the rights
 9 of passengers to transport service animals.

10 (2) ADDITIONAL TRAIN CARS.—Nothing in this
 11 section may be interpreted to require Amtrak to add
 12 additional train cars or modify existing train cars.

13 (3) FEDERAL FUNDS.—No Federal funds may
 14 be used to implement the pilot program required
 15 under this section.

16 **SEC. 213. AMTRAK BOARD OF DIRECTORS.**

17 (a) IN GENERAL.—Section 24302(a) is amended to
 18 read as follows:

19 “(a) COMPOSITION AND TERMS.—

20 “(1) IN GENERAL.—The Amtrak Board of Di-
 21 rectors (referred to in this section as the ‘Board’) is
 22 composed of the following 9 directors, each of whom
 23 must be a citizen of the United States:

24 “(A) The Secretary of Transportation.

25 “(B) The President of Amtrak.

1 “(C) 7 individuals appointed by the Presi-
2 dent of the United States, by and with the ad-
3 vice and consent of the Senate, with general
4 business and financial experience, experience or
5 qualifications in transportation, freight and
6 passenger rail transportation, travel, hospi-
7 tality, or passenger air transportation busi-
8 nesses, or representatives of employees or users
9 of passenger rail transportation or a State gov-
10 ernment.

11 “(2) SELECTION.—In selecting individuals de-
12 scribed in paragraph (1)(C) for nominations for ap-
13 pointments to the Board, the President shall consult
14 with the Speaker of the House of Representatives,
15 the minority leader of the House of Representatives,
16 the majority leader of the Senate, and the minority
17 leader of the Senate. The individuals appointed to
18 the Board under paragraph (1)(C) shall be com-
19 posed of the following;

20 “(A) 2 individuals from the Northeast Cor-
21 ridor.

22 “(B) 4 individuals from regions of the
23 country outside of the Northeast Corridor and
24 geographically distributed with—

1 “(i) 2 individuals from States with
2 long-distance routes operated by Amtrak;
3 and

4 “(ii) 2 individuals from States with
5 State-supported routes operated by Am-
6 trak.

7 “(C) 1 individual from the Northeast Cor-
8 ridor or a State with long-distance or State-
9 supported routes.

10 “(3) TERM.—An individual appointed under
11 paragraph (1)(C) shall be appointed for a term of 5
12 years. The term may be extended until the individ-
13 ual’s successor is appointed and qualified. Not more
14 than 4 individuals appointed under paragraph (1)(C)
15 may be members of the same political party.

16 “(4) CHAIRPERSON AND VICE CHAIRPERSON.—
17 The Board shall elect a chairperson and vice chair-
18 person, other than the President of Amtrak, from
19 among its membership. The vice chairperson shall
20 serve as chairperson in the absence of the chair-
21 person.

22 “(5) SECRETARY’S DESIGNEE.—The Secretary
23 may be represented at Board meetings by the Sec-
24 retary’s designee.”.

1 (b) **RULE OF CONSTRUCTION.**—Nothing in this sec-
 2 tion shall be construed as affecting the term of any direc-
 3 tor serving on the Amtrak Board of Directors under sec-
 4 tion 24302(a)(1)(C) of title 49, United States Code, on
 5 the day preceding the date of enactment of this Act.

6 **TITLE III—INTERCITY**
 7 **PASSENGER RAIL POLICY**

8 **SEC. 301. COMPETITIVE OPERATING GRANTS.**

9 (a) **IN GENERAL.**—Chapter 244 is amended—

10 (1) by striking section 24406; and

11 (2) by inserting after section 24405 the fol-
 12 lowing:

13 **“§ 24406. Competitive operating grants**

14 **“(a) APPLICANT DEFINED.**—In this section, the term
 15 ‘applicant’ means—

16 **“(1) a State;**

17 **“(2) a group of States;**

18 **“(3) an Interstate Compact;**

19 **“(4) a public agency or publicly chartered au-**
 20 **thority established by 1 or more States and having**
 21 **responsibility for providing intercity rail passenger**
 22 **transportation or commuter rail passenger transpor-**
 23 **tation;**

24 **“(5) a political subdivision of a State;**

1 “(6) Amtrak or another rail passenger carrier
2 that provides intercity rail passenger transportation;

3 “(7) Any rail carrier in partnership with at
4 least 1 of the entities described in paragraphs (1)
5 through (5); and

6 “(8) any combination of the entities described
7 in paragraphs (1) through (7).

8 “(b) GRANTS AUTHORIZED.—The Secretary of
9 Transportation shall develop and implement a program for
10 issuing 3-year operating assistance grants to applicants,
11 on a competitive basis, for the purpose of initiating, re-
12 storing, or enhancing intercity rail passenger service.

13 “(c) APPLICATION.—An applicant for a grant under
14 this section shall submit to the Secretary—

15 “(1) a capital and mobilization plan that—

16 “(A) describes any capital investments,
17 service planning actions (such as environmental
18 reviews); and mobilization actions (such as
19 qualification of train crews) required for initi-
20 ation of service; and

21 “(B) includes the timeline for undertaking
22 and completing each of the investments and ac-
23 tions referred to in subparagraph (A);

24 “(2) an operating plan that describes the
25 planned operation of the service, including—

1 “(A) the identity and qualifications of the
2 train operator;

3 “(B) the identity and qualifications of any
4 other service providers;

5 “(C) service frequency;

6 “(D) the planned routes and schedules;

7 “(E) the station facilities that will be uti-
8 lized;

9 “(F) projected ridership, revenues, and
10 costs;

11 “(G) descriptions of how the projections
12 under subparagraph (F) were developed;

13 “(H) the equipment that will be utilized,
14 how such equipment will be acquired or refur-
15 bished, and where such equipment will be main-
16 tained; and

17 “(I) a plan for ensuring safe operations
18 and compliance with applicable safety regula-
19 tions;

20 “(3) a funding plan that—

21 “(A) describes the funding of initial capital
22 costs and operating costs for the first 3 years
23 of operation;

24 “(B) includes a commitment by the appli-
25 cant to provide the funds described in subpara-

1 graph (A) to the extent not covered by Federal
2 grants and revenues; and

3 “(C) describes the funding of operating
4 costs and capital costs, to the extent necessary,
5 after the first 3 years of operation; and

6 “(4) a description of the status of negotiations
7 and agreements with—

8 “(A) each of the railroads or regional
9 transportation authorities whose tracks or fa-
10 cilities would be utilized by the service;

11 “(B) the anticipated rail passenger carrier,
12 if such entity is not part of the applicant group;
13 and

14 “(C) any other service providers or entities
15 expected to provide services or facilities that
16 will be used by the service, including any re-
17 quired access to Amtrak systems, stations, and
18 facilities if Amtrak is not part of the applicant
19 group.

20 “(d) PRIORITIES.—In awarding grants under this
21 section, the Secretary shall give priority to applications—

22 “(1) for which planning, design, any environ-
23 mental reviews, negotiation of agreements, acquisi-
24 tion of equipment, construction, and other actions

1 necessary for initiation of service have been com-
2 pleted or nearly completed;

3 “(2) that would restore service over routes for-
4 merly operated by Amtrak, including routes with
5 international connections;

6 “(3) that would provide daily or daytime service
7 over routes where such service did not previously
8 exist;

9 “(4) that include private funding (including
10 funding from railroads); and funding or other sig-
11 nificant participation by State, local, and regional
12 governmental and private entities;

13 “(5) that include a funding plan that dem-
14 onstrates the intercity rail passenger service will be
15 financially sustainable beyond the 3-year grant pe-
16 riod;

17 “(6) that would provide service to regions and
18 communities that are underserved or not served by
19 other intercity public transportation;

20 “(7) that would foster economic development,
21 particularly in rural communities and for disadvan-
22 taged populations;

23 “(8) that would provide other non-transpor-
24 tation benefits; and

1 “(9) that would enhance connectivity and geo-
2 graphic coverage of the existing national network of
3 intercity passenger rail service.

4 “(e) LIMITATIONS.—

5 “(1) DURATION.—Federal operating assistance
6 grants authorized under this section for any indi-
7 vidual intercity rail passenger transportation route
8 may not provide funding for more than 3 years and
9 may not be renewed.

10 “(2) LIMITATION.—Not more than 6 of the op-
11 erating assistance grants awarded pursuant to sub-
12 section (b) may be simultaneously active.

13 “(3) MAXIMUM FUNDING.—Grants described in
14 paragraph (1) may not exceed—

15 “(A) 80 percent of the projected net oper-
16 ating costs for the first year of service;

17 “(B) 60 percent of the projected net oper-
18 ating costs for the second year of service; and

19 “(C) 40 percent of the projected net oper-
20 ating costs for the third year of service.

21 “(f) USE WITH CAPITAL GRANTS AND OTHER FED-
22 ERAL FUNDING.—A recipient of an operating assistance
23 grant under subsection (b) may use that grant in combina-
24 tion with other grants awarded under this chapter or any

1 other Federal funding that would benefit the applicable
2 service.

3 “(g) AVAILABILITY.—Amounts appropriated for ear-
4 rying out this section shall remain available until ex-
5 pended.

6 “(h) COORDINATION WITH AMTRAK.—If the Sec-
7 retary awards a grant under this section to a rail pas-
8 senger carrier other than Amtrak, Amtrak may be re-
9 quired under section 24711(e)(1) of this title to provide
10 access to its reservation system, stations, and facilities
11 that are directly related to operations to such carrier, to
12 the extent necessary to carry out the purposes of this sec-
13 tion. The Secretary may award an appropriate portion of
14 the grant to Amtrak as compensation for this access.

15 “(i) CONDITIONS.—

16 “(1) GRANT AGREEMENT.—The Secretary shall
17 require grant recipients under this section to enter
18 into a grant agreement that requires them to pro-
19 vide similar information regarding the route per-
20 formance, financial, and ridership projections, and
21 capital and business plans that Amtrak is required
22 to provide, and such other data and information as
23 the Secretary deems necessary.

24 “(2) INSTALLMENTS; TERMINATION.—The Sec-
25 retary may—

1 “(A) award grants under this section in in-
2 stallments, as the Secretary considers appro-
3 priate; and

4 “(B) terminate any grant agreement
5 upon—

6 “(i) the cessation of service; or

7 “(ii) the violation of any other term of
8 the grant agreement.

9 “(3) GRANT CONDITIONS.—Except as specifi-
10 cally provided in this section, the use of any
11 amounts appropriated for grants under this section
12 shall be subject to the requirements under this chap-
13 ter.

14 “(j) REPORT.—Not later than 4 years after the date
15 of enactment of the Railroad Reform, Enhancement, and
16 Efficiency Act, the Secretary, after consultation with
17 grant recipients under this section, shall submit a report
18 to Congress that describes—

19 “(1) the implementation of this section;

20 “(2) the status of the investments and oper-
21 ations funded by such grants;

22 “(3) the performance of the routes funded by
23 such grants;

24 “(4) the plans of grant recipients for continued
25 operation and funding of such routes; and

1 “(5) any legislative recommendations.”

2 (b) CONFORMING AMENDMENTS.—Chapter 244 is
3 amended—

4 (1) in the table of contents, by inserting after
5 the item relating to section 24405 the following:

“24406. Competitive operating grants.”;

6 (2) in the chapter title, by striking “**INTER-**
7 **CITY PASSENGER RAIL SERVICE COR-**
8 **RIDOR CAPITAL**” and inserting “**RAIL CAP-**
9 **ITAL AND OPERATING**”;

10 (3) in section 24401, by striking paragraph (1);

11 (4) in section 24402, by striking subsection (j)

12 and inserting the following:

13 “(j) **APPLICANT DEFINED.**—In this section, the term
14 ‘applicant’ means a State (including the District of Co-
15 lumbia), a group of States, an Interstate Compact, a pub-
16 lic agency or publicly chartered authority established by
17 1 or more States and having responsibility for providing
18 intercity rail passenger transportation, or a political sub-
19 division of a State.”; and

20 (5) in section 24405—

21 (A) in subsection (b)—

22 (i) by inserting “, or for which an op-
23 erating grant is issued under section
24 24406,” after “chapter”; and

1 (ii) in paragraph (2), by striking
2 “(43)” and inserting “(45”;

3 (B) in subsection (d)(1), in the matter pre-
4 ceding subparagraph (A), by inserting “or un-
5 less Amtrak ceased providing intercity pas-
6 senger railroad transportation over the affected
7 route more than 3 years before the commence-
8 ment of new service” after “unless such service
9 was provided solely by Amtrak to another enti-
10 ty”;

11 (C) in subsection (f), by striking “under
12 this chapter for commuter rail passenger trans-
13 portation, as defined in section 24012(4) of this
14 title.” and inserting “under this chapter for
15 commuter rail passenger transportation (as de-
16 fined in section 24102(3)).”; and

17 (D) by adding at the end the following:

18 “(g) SPECIAL TRANSPORTATION CIRCUMSTANCES.—

19 In carrying out this chapter, the Secretary shall allocate
20 an appropriate portion of the amounts available under this
21 chapter to provide grants to States—

22 “(1) in which there is no intercity passenger
23 rail service, for the purpose of funding freight rail
24 capital projects that are on a State rail plan devel-
25 oped under chapter 227 that provide public benefits

1 (as defined in chapter 227), as determined by the
2 Secretary; or

3 “(2) in which the rail transportation system is
4 not physically connected to rail systems in the conti-
5 nental United States or may not otherwise qualify
6 for a grant under this section due to the unique
7 characteristics of the geography of that State or
8 other relevant considerations, for the purpose of
9 funding transportation-related capital projects.”.

10 **SEC. 302. FEDERAL-STATE PARTNERSHIP FOR STATE OF**
11 **GOOD REPAIR.**

12 (a) AMENDMENT.—Chapter 244 is amended by in-
13 serting after section 24406, as added by section 301 of
14 this Act, the following:

15 **“§ 24407. Federal-State partnership for state of good**
16 **repair**

17 “(a) DEFINITIONS.—In this section:

18 “(1) APPLICANT.—The term ‘applicant’
19 means—

20 “(A) a State (including the District of Co-
21 lumbia);

22 “(B) a group of States;

23 “(C) an Interstate Compact;

24 “(D) a public agency or publicly chartered
25 authority established by 1 or more States that

1 has responsibility for providing intercity rail
 2 passenger transportation or commuter rail pas-
 3 senger transportation;

4 “(E) a political subdivision of a State;

5 “(F) Amtrak, acting on its own behalf or
 6 under a cooperative agreement with 1 or more
 7 States; or

8 “(G) any combination of the entities de-
 9 scribed in subparagraphs (A) through (F).

10 “(2) CAPITAL PROJECT.—The term ‘capital
 11 project’ means—

12 “(A) a project primarily intended to re-
 13 place, rehabilitate, or repair major infrastruc-
 14 ture assets utilized for providing intercity pas-
 15 senger rail service, including tunnels, bridges,
 16 stations, and other assets, as determined by the
 17 Secretary; or

18 “(B) a project primarily intended to im-
 19 prove intercity passenger rail performance, in-
 20 cluding reduced trip times, increased train fre-
 21 quencies, higher operating speeds, and other
 22 improvements, as determined by the Secretary.

23 “(3) NORTHEAST CORRIDOR.—The term
 24 ‘Northeast Corridor’ means—

1 “(A) the main rail line between Boston,
2 Massachusetts and the Virginia Avenue inter-
3 locking in the District of Columbia; and

4 “(B) the branch rail lines connecting to
5 Harrisburg, Pennsylvania, Springfield, Massa-
6 chusetts, and Spuyten Duyvil, New York.

7 “(4) QUALIFIED RAILROAD ASSET.—The term
8 ‘qualified railroad asset’ means infrastructure,
9 equipment, or a facility that—

10 “(A) is owned or controlled by an eligible
11 applicant; and

12 “(B) was not in a state of good repair on
13 the date of enactment of the Railroad Reform,
14 Enhancement, and Efficiency Act.

15 “(b) GRANT PROGRAM AUTHORIZED.—The Secretary
16 of Transportation shall develop and implement a program
17 for issuing grants to applicants, on a competitive basis,
18 to fund capital projects that reduce the state of good re-
19 pair backlog on qualified railroad assets.

20 “(c) ELIGIBLE PROJECTS.—Projects eligible for
21 grants under this section include capital projects to re-
22 place or rehabilitate qualified railroad assets, including—

23 “(1) capital projects to replace existing assets
24 in-kind;

1 “(2) capital projects to replace existing assets
2 with assets that increase capacity or provide a high-
3 er level of service; and

4 “(3) capital projects to ensure that service can
5 be maintained while existing assets are brought to a
6 state of good repair.

7 “(d) PROJECT SELECTION CRITERIA.—In selecting
8 an applicant for a grant under this section, the Secretary
9 shall—

10 “(1) give preference to eligible projects—

11 “(A) that are consistent with the goals, ob-
12 jectives, and policies defined in any regional rail
13 planning document that is applicable to a
14 project proposal; and

15 “(B) for which the proposed Federal share
16 of total project costs does not exceed 50 per-
17 cent; and

18 “(2) take into account—

19 “(A) the cost-benefit analysis of the pro-
20 posed project, including anticipated private and
21 public benefits relative to the costs of the pro-
22 posed project, including—

23 “(i) effects on system and service per-
24 formance;

1 “(ii) effects on safety, competitive-
2 ness, reliability, trip or transit time, and
3 resilience;

4 “(iii) efficiencies from improved inte-
5 gration with other modes; and

6 “(iv) ability to meet existing or antici-
7 pated demand;

8 “(B) the degree to which the proposed
9 project’s business plan considers potential pri-
10 vate sector participation in the financing, con-
11 struction, or operation of the proposed project;

12 “(C) the applicant’s past performance in
13 developing and delivering similar projects, and
14 previous financial contributions;

15 “(D) whether the applicant has, or will
16 have—

17 “(i) the legal, financial, and technical
18 capacity to carry out the project;

19 “(ii) satisfactory continuing control
20 over the use of the equipment or facilities;
21 and

22 “(iii) the capability and willingness to
23 maintain the equipment or facilities;

24 “(E) if applicable, the consistency of the
25 project with planning guidance and documents

1 set forth by the Secretary or required by law;
2 and

3 “(F) any other relevant factors, as deter-
4 mined by the Secretary.

5 “(e) PLANNING REQUIREMENTS.—A project is not el-
6 igible for a grant under this section unless the project is
7 specifically identified—

8 “(1) on a State rail plan prepared in accord-
9 ance with chapter 227; or

10 “(2) if the project is located on the Northeast
11 Corridor, on the Northeast Corridor Capital Invest-
12 ment Plan developed pursuant to section 24904(a).

13 “(f) NORTHEAST CORRIDOR PROJECTS.—

14 “(1) COMPLIANCE WITH USAGE AGREE-
15 MENTS.—Grant funds may not be provided under
16 this section to an eligible recipient for an eligible
17 project located on the Northeast Corridor unless
18 Amtrak and the public authorities providing com-
19 muter rail passenger transportation on the North-
20 east Corridor are in compliance with section
21 24905(e)(2).

22 “(2) CAPITAL INVESTMENT PLAN.—When se-
23 lecting projects located on the Northeast Corridor,
24 the Secretary shall consider the appropriate se-
25 quence and phasing of projects as contained in the

1 Northeast Corridor Capital Investment Plan devel-
2 oped pursuant to section 24904(a).

3 “(g) FEDERAL SHARE OF TOTAL PROJECT COSTS.—

4 “(1) TOTAL PROJECT COST.—The Secretary
5 shall estimate the total cost of a project under this
6 section based on the best available information, in-
7 cluding engineering studies, studies of economic fea-
8 sibility, environmental analyses, and information on
9 the expected use of equipment or facilities.

10 “(2) FEDERAL SHARE.—The Federal share of
11 total costs for a project under this subsection shall
12 not exceed 80 percent.

13 “(3) TREATMENT OF AMTRAK REVENUE.—If
14 Amtrak or another rail passenger carrier is an appli-
15 cant under this section, Amtrak or the other rail
16 passenger carrier, as applicable, may use ticket and
17 other revenues generated from its operations and
18 other sources to satisfy the non-Federal share re-
19 quirements.

20 “(h) LETTERS OF INTENT.—

21 “(1) IN GENERAL.—The Secretary may issue a
22 letter of intent to a grantee under this section
23 that—

24 “(A) announces an intention to obligate,
25 for a major capital project under this section,

1 an amount from future available budget author-
2 ity specified in law that is not more than the
3 amount stipulated as the financial participation
4 of the Secretary in the project; and

5 “(B) states that the contingent commit-
6 ment—

13 “(2) CONGRESSIONAL NOTIFICATION.—

14 “(A) IN GENERAL.—Not later than 30
15 days before issuing a letter under paragraph
16 (1), the Secretary shall submit written notifica-
17 tion to—

18 “(i) the Committee on Commerce,
19 Science, and Transportation of the Senate;

20 “(ii) the Committee on Appropriations
21 of the Senate;

22 “(iii) the Committee on Transpor-
23 tation and Infrastructure of the House of
24 Representatives; and

1 “(iv) the Committee on Appropria-
2 tions of the House of Representatives.

3 “(B) CONTENTS.—The notification sub-
4 mitted pursuant to subparagraph (A) shall in-
5 clude—

6 “(i) a copy of the proposed letter or
7 agreement;

5 **SEC. 305. GULF COAST RAIL SERVICE WORKING GROUP.**

7 date of enactment of this Act, the Secretary shall convene
8 a working group to evaluate the restoration of intercity
9 rail passenger service in the Gulf Coast region between
10 New Orleans, Louisiana, and Orlando, Florida.

11 (b) **MEMBERSHIP.**—The working group convened
12 pursuant to subsection (a) shall consist of representatives
13 of—

14 (1) the Federal Railroad Administration, which
15 shall serve as chair of the working group;

16 (2) Amtrak;

17 (3) the States along the proposed route or

19 (4) regional transportation planning organiza-
20 tions and metropolitan planning organizations, mu-
21 nicipalities, and communities along the proposed
22 route or routes, which shall be selected by the Ad-
23 ministrator;

1 (6) freight railroad carriers whose tracks may
2 be used for such service; and

3 (7) other entities determined appropriate by the
4 Secretary, which may include independent passenger
5 rail operators that express an interest in Gulf Coast
6 service.

7 (c) RESPONSIBILITIES.—The working group shall—

8 (1) evaluate all options for restoring intercity
9 rail passenger service in the Gulf Coast region, in-
10 cluding options outlined in the report transmitted to
11 Congress pursuant to section 226 of the Passenger
12 Rail Investment and Improvement Act of 2008 (divi-
13 sion B of Public Law 110–432);

14 (2) select a preferred option for restoring such
15 service;

16 (3) develop a prioritized inventory of capital
17 projects and other actions required to restore such
18 service and cost estimates for such projects or ac-
19 tions; and

20 (4) identify Federal and non-Federal funding
21 sources required to restore such service, including
22 options for entering into public-private partnerships
23 to restore such service.

24 (d) REPORT.—Not later than 9 months after the date
25 of enactment of this Act, the working group shall submit

2 Transportation of the Senate and the Committee on
3 Transportation and Infrastructure of the House of Rep-

16 **SEC. 306. INTEGRATED PASSENGER RAIL WORKING GROUP.**

17 (a) **IN GENERAL.**—Not later than 180 days after the
18 date of enactment of this Act, the Secretary shall convene
19 a working group to review issues relating to—

20 (1) the potential operation of State-supported
21 routes by rail passenger carriers other than Amtrak;

11 (5) railroads that host intercity State-supported

13 (6) employee representatives from railroad
14 unions and building trade unions with substantial
15 engagement in railroad rights of way construction
16 and maintenance; and

17 (7) other entities determined appropriate by the
18 Secretary.

19 (c) RESPONSIBILITIES.—The working group shall
20 evaluate options for improving State-supported routes and
21 may make recommendations, as appropriate, regarding—

22 (1) best practices for State or State authority
23 governance of State-supported routes;

24 (2) future sources of Federal and non-Federal
25 funding sources for State-supported routes;

1 (3) best practices in obtaining passenger rail
2 operations and services on a competitive basis with
3 the objective of creating the highest quality service
4 at the lowest cost to the taxpayer;

5 (4) ensuring potential interoperability of State-
6 supported routes as a part of a national network
7 with multiple providers providing integrated services
8 including ticketing, scheduling, and route planning;
9 and

10 (5) the interface between State-supported
11 routes and connecting commuter rail operations, in-
12 cluding maximized intra-modal and intermodal con-
13 nections and common sources of funding for capital
14 projects.

15 (d) MEETINGS.—Not later than 60 days after the es-
16 tablishment of the working group by the Secretary under
17 subsection (a), the working group shall convene an organi-
18 zational meeting outside of the District of Columbia and
19 shall define the rules and procedures governing the pro-
20 ceedings of the working group. The working group shall
21 hold at least 3 meetings per year in States that fund
22 State-supported routes.

23 (e) REPORTS.—

24 (1) PRELIMINARY REPORT.—Not later than 1
25 year after the date the working group is established;

1 the working group shall submit a preliminary report
 2 to the Secretary, the Governors of States funding
 3 State-supported routes, the Committee on Com-

 19 House of Representatives that includes final legisla-
 20 tive recommendations.

21 **SEC. 307. SHARED-USE STUDY.**

22 (a) IN GENERAL.—Not later than 3 years after the

 24 tion with Amtrak, commuter rail authorities, and other

15 ments directed towards shared-use right-of-way by

17 (5) approaches to operations, capacity, and cost

19 (A) allows for transparent decisionmaking;

21 (B) protects the proprietary interests of all
22 parties;

23 (6) liability requirements and arrangements, in-

1 (A) whether to expand statutory liability
2 limits to additional parties;

13 (7) the effect on rail passenger services, oper-
14 ations, liability limits and insurance levels of the as-
15 sertion of sovereign immunity by a State; and

16 (8) other issues identified by the Secretary.

17 (e) REPORT.—Not later than 60 days after the study
18 under subsection (a) is complete, the Secretary shall sub-
19 mit to the Committee on Commerce, Science, and Trans-
20 portation of the Senate and the Committee on Transpor-
21 tation and Infrastructure of the House of Representatives
22 a report that includes—

23 (1) the results of the study; and

1 (2) any recommendations for further action, in-

 8 under paragraph (2)(H) shall—

9 “(A) identify funding sources and financ-
 10 ing methods;

11 “(B) identify the expected allocated shares
 12 of costs pursuant to/using the cost allocation
 13 policy developed under section 24905(e);

14 “(C) identify the projects and programs
 15 that the Commission expects will receive Fed-
 16 eral financial assistance; and

17 “(D) identify the eligible entity or entities
 18 that the Commission expects will receive the
 19 Federal financial assistance described under
 20 subparagraph (C).

21 “(b) FAILURE TO DEVELOP A CAPITAL INVESTMENT
 22 PLAN.—If a capital investment plan has not been devel-
 23 oped by the Commission for a given fiscal year, then the
 24 funds assigned to the account established under section
 25 24319(b) for that fiscal year may be spent only on—

1 “(1) capital projects described in clause (i) or

14 ridor asset management plan developed under
15 paragraph (1); and

16 “(B) at least biennial thereafter, an update
17 to its Northeast Corridor asset management
18 plan.

19 “(d) NORTHEAST CORRIDOR SERVICE DEVELOP-
20 MENT PLAN UPDATES.—Not less frequently than once
21 every 10 years, the Commission shall update the North-
22 east Corridor service development plan.”.

16 **SEC. 309. NORTHEAST CORRIDOR THROUGH-TICKETING**
17 **AND PROCUREMENT EFFICIENCIES.**

18 (a) THROUGH-TICKETING STUDY.—

19 (1) IN GENERAL.—Not later than 3 years after
20 the date of enactment of this Act, the Northeast
21 Corridor Commission established under section
22 24905(a) of title 49, United States Code (referred to
23 in this section as the “Commission”); in consultation
24 with Amtrak and the commuter rail passenger trans-
25 portation providers along the Northeast Corridor

1 shall complete a study on the feasibility of and op-
2 tions for permitting through-ticketing between Am-
3 trak service and commuter rail services on the

9 that includes—

10 (A) the results of the study; and

11 (B) any recommendations for further ac-

13 (b) JOINT PROCUREMENT STUDY.—

14 (1) IN GENERAL.—Not later than 3 years after
15 the date of enactment of this Act, the Secretary, in
16 cooperation with the Commission, Amtrak, and com-
17 muter rail transportation authorities on the North-
18 east Corridor shall complete a study of the potential
19 benefits resulting from Amtrak and such authorities
20 undertaking select joint procurements for common
21 materials, assets, and equipment when expending
22 Federal funds for such purchases.

23 (2) CONTENTS.—In completing the study under
24 paragraph (1), the Secretary shall consider—

1 (A) the types of materials, assets, and
2 equipment that are regularly purchased by Am-

6 curements, including lower procurement costs,
7 better pricing, greater market relevancy, and

13 essary harmonization and reconciliation of Fed-
14 eral and State procurement or safety regula-
15 tions or standards and other requirements; and

16 (E) whether to create Federal incentives or
17 requirements relating to considering or carrying
18 out joint procurements when expending Federal
19 funds.

20 (3) TRANSMISSION.—Not later than 60 days
21 after completing the study required under this sub-
22 section, the Secretary shall submit to the Committee
23 on Commerce, Science, and Transportation of the
24 Senate and the Committee on Transportation and

1 Infrastructure of the House of Representatives a re-
2 port that includes—

3 (A) the results of the study; and

4 (B) any recommendations for further ac-
5 tion.

6 (c) NORTHEAST CORRIDOR.—In this section, the
7 term “Northeast Corridor” means the Northeast Corridor
8 main line between Boston, Massachusetts, and the Vir-
9 ginia Avenue interlocking in the District of Columbia, and
10 the Northeast Corridor branch lines connecting to Harris-
11 burg, Pennsylvania, Springfield, Massachusetts, and
12 Spuyten Duyvil, New York, including the facilities and
13 services used to operate and maintain those lines.

14 **SEC. 310. DATA AND ANALYSIS.**

23 transportation funding programs, including the ap-

 2 nicate the methodology used to calculate the project

5 (A) assumptions underlying calculations;

8 (C) the level of uncertainty in estimates of
 9 project benefits and costs; and

17 (I) the Keystone Corridor;

18 (J) the Northern New England Corridor;

19 and

20 (K) the Southeast Corridor.

21 (2) SUBMISSION.—Proposals shall be submitted
22 to the Secretary not later than 180 days after the
23 publication of such request for proposals under para-
24 graph (1).

25 (3) PERFORMANCE STANDARD.—Proposals sub-
26 mitted under paragraph (2) shall meet any stand-

1 ards established by the Secretary. For corridors with
2 existing intercity passenger rail service, proposals
3 shall also be designed to achieve a reduction of exist-
4 ing minimum intercity rail service trip times between
5 the main corridor city pairs by a minimum of 25
6 percent. In the case of a proposal submitted with re-
7 spect to paragraph (1)(A), the proposal shall be de-
8 signed to achieve a 2-hour or less express service be-
9 tween Washington, District of Columbia, and New
10 York City, New York.

11 (4) CONTENTS.—A proposal submitted under
12 this subsection shall include—

13 (A) the names and qualifications of the
14 persons submitting the proposal and the entities
15 proposed to finance, design, construct, operate,
16 and maintain the railroad, railroad equipment,
17 and related facilities, stations, and infrastruc-
18 ture;

19 (B) a detailed description of the proposed
20 rail service, including possible routes, required
21 infrastructure investments and improvements,
22 equipment needs and type, train frequencies,
23 peak and average operating speeds, and trip
24 times;

1 (C) a description of how the project would
2 comply with all applicable Federal rail safety
3 and security laws, orders, and regulations;

4 (D) the locations of proposed stations,
5 which maximize the usage of existing infra-
6 structure to the extent possible, and the popu-
7 lations such stations are intended to serve;

8 (E) the type of equipment to be used, in-
9 cluding any technologies, to achieve trip time
10 goals;

11 (F) a description of any proposed legisla-
12 tion needed to facilitate all aspects of the
13 project;

14 (G) a financing plan identifying—

15 (i) projected revenue, and sources
16 thereof;

17 (ii) the amount of any requested pub-
18 lic contribution toward the project, and
19 proposed sources;

20 (iii) projected annual ridership projec-
21 tions for the first 10 years of operations;

22 (iv) annual operations and capital
23 costs;

24 (v) the projected levels of capital in-
25 vestments required both initially and in

1 subsequent years to maintain a state-of-
2 good-repair necessary to provide the ini-
3 tially proposed level of service or higher
4 levels of service;

5 (vi) projected levels of private invest-
6 ment and sources thereof, including the
7 identity of any person or entity that has
8 made or is expected to make a commit-
9 ment to provide or secure funding and the
10 amount of such commitment; and

11 (vii) projected funding for the full fair
12 market compensation for any asset, prop-
13 erty right or interest, or service acquired
14 from, owned, or held by a private person or
15 Federal entity that would be acquired, im-
16 paired, or diminished in value as a result
17 of a project, except as otherwise agreed to
18 by the private person or entity;

19 (H) a description of how the project would
20 contribute to the development of the intercity
21 passenger rail system and an intermodal plan
22 describing how the system will facilitate conven-
23 ient travel connections with other transpor-
24 tation services;

1 (I) a description of how the project will en-
2 sure compliance with Federal laws governing
3 the rights and status of employees associated
4 with the route and service, including those spec-
5 ified in section 24405 of title 49, United States
6 Code;

7 (J) a description of how the design, con-
8 struction, implementation, and operation of the
9 project will accommodate and allow for future
10 growth of existing and projected intercity, com-
11 muter, and freight rail service;

12 (K) a description of how the project would
13 comply with Federal and State environmental
14 laws and regulations, of what environmental im-
15 pacts would result from the project, and of how
16 any adverse impacts would be mitigated; and

17 (L) a description of the project's impacts
18 on highway and aviation congestion, energy
19 consumption, land use, and economic develop-
20 ment in the service area.

21 (b) DETERMINATION AND ESTABLISHMENT OF COM-
22 MISSIONS.—Not later than 90 days after receipt of the
23 proposals under subsection (a), the Secretary shall—

24 (1) make a determination as to whether any
25 such proposals—

1 (A) contain the information required under
2 paragraphs (3) and (4) of subsection (a);

3 (B) are sufficiently credible to warrant fur-
4 ther consideration;

5 (C) are likely to result in a positive impact
6 on the Nation's transportation system; and

7 (D) are cost-effective and in the public in-
8 terest;

9 (2) establish a commission under subsection (c)
10 for each corridor with 1 or more proposals that the
11 Secretary determines satisfy the requirements of
12 paragraph (1); and

13 (3) forward to each commission established
14 under paragraph (2) the applicable proposals for re-
15 view and consideration.

16 (c) COMMISSIONS.—

17 (1) MEMBERS.—Each commission established
18 under subsection (b)(2) shall include—

19 (A) the governors of the affected States, or
20 their respective designees;

21 (B) mayors of appropriate municipalities
22 with stops along the proposed corridor, or their
23 respective designees;

1 (C) a representative from each freight rail-
2 road carrier using the relevant corridor, if ap-
3 plicable;

4 (D) a representative from each transit au-
5 thority using the relevant corridor, if applicable;

6 (E) representatives of nonprofit employee
7 labor organizations representing affected rail-
8 road employees; and

9 (F) the President of Amtrak or his or her
10 designee.

11 (2) APPOINTMENT AND SELECTION.—The Sec-
12 retary shall appoint the members under paragraph
13 (1). In selecting each commission's members to ful-
14 fill the requirements under subparagraphs (B) and
15 (E) of paragraph (1), the Secretary shall consult
16 with the Chairperson and Ranking Member of the
17 Committee on Commerce, Science, and Transpor-
18 tation of the Senate and of the Committee on Trans-
19 portation and Infrastructure of the House of Rep-
20 resentatives.

21 (3) CHAIRPERSON AND VICE-CHAIRPERSON SE-
22 LECTION.—The Chairperson and Vice-Chairperson
23 shall be elected from among members of each com-
24 mission.

25 (4) QUORUM AND VACANCY.—

1 (A) QUORUM.—A majority of the members
2 of each commission shall constitute a quorum.

3 (B) VACANCY.—Any vacancy in each com-
4 mission shall not affect its powers and shall be
5 filled in the same manner in which the original
6 appointment was made.

7 (5) APPLICATION OF LAW.—Except where oth-
8 erwise provided by this section, the Federal Advisory
9 Committee Act (5 U.S.C. App.) shall apply to each
10 commission created under this section.

11 (d) COMMISSION CONSIDERATION.—

12 (1) IN GENERAL.—Each commission established
13 under subsection (b)(2) shall be responsible for re-
14 viewing the proposal or proposals forwarded to it
15 under that subsection and not later than 90 days
16 after the establishment of the commission, shall
17 transmit to the Secretary a report, including—

18 (A) a summary of each proposal received;

19 (B) services to be provided under each pro-
20 posal, including projected ridership, revenues,
21 and costs;

22 (C) proposed public and private contribu-
23 tions for each proposal;

24 (D) the advantages offered by the proposal
25 over existing intercity passenger rail services;

1 (~~E~~) public operating subsidies or assets
2 needed for the proposed project;

3 (~~F~~) possible risks to the public associated
4 with the proposal, including risks associated
5 with project financing, implementation, comple-
6 tion, safety, and security;

7 (~~G~~) a ranked list of the proposals rec-
8 ommended for further consideration under sub-
9 section (c) in accordance with each proposal's
10 projected positive impact on the Nation's trans-
11 portation system;

12 (~~H~~) an identification of any proposed Fed-
13 eral legislation that would facilitate implemen-
14 tation of the projects and Federal legislation
15 that would be required to implement the
16 projects; and

17 (~~I~~) any other recommendations by the com-
18 mission concerning the proposed projects.

19 (~~2~~) VERBAL PRESENTATION.—Proposers shall
20 be given an opportunity to make a verbal presen-
21 tation to the commission to explain their proposals.

22 (~~3~~) AUTHORIZATION OF APPROPRIATIONS.—
23 There is authorized to be appropriated to the Sec-
24 retary for the use of each commission established

1 under subsection (b)(2) such sums as are necessary
2 to carry out this section.

3 (c) SELECTION BY SECRETARY.—

4 (1) IN GENERAL.—Not later than 60 days after
5 receiving the recommended proposals of the commis-
6 sions established under subsection (b)(2), the Sec-
7 retary shall—

8 (A) review such proposals and select any
9 proposal that provides substantial benefits to
10 the public and the national transportation sys-
11 tem, is cost-effective, offers significant advan-
12 tages over existing services, and meets other
13 relevant factors determined appropriate by the
14 Secretary; and

15 (B) submit to the Committee on Com-
16 merce, Science, and Transportation of the Sen-
17 ate and the Committee on Transportation and
18 Infrastructure of the House of Representatives

1 (2) SUBSEQUENT REPORT.—Following the sub-

6 structure of the House of Representatives a report
7 containing any proposal with respect to subpara-

11 proposal provided to the Secretary under subsection
12 (d), and any other information the Secretary con-

14 (3) LIMITATION ON REPORT SUBMISSION.—The
15 report required under paragraph (2) shall not be
16 submitted by the Secretary until the report sub-
17 mitted under paragraph (1)(B) has been considered
18 through a hearing by the Committee on Commerce,
19 Science, and Transportation of the Senate and the
20 Committee on Transportation and Infrastructure of
21 the House of Representatives on the report sub-
22 mitted under paragraph (1)(B).

23 (f) NO ACTIONS WITHOUT ADDITIONAL AUTHOR-
24 ITY.—No Federal agency may take any action to imple-

12 **SEC. 313. AMTRAK INSPECTOR GENERAL.**

13 (a) AUTHORITY.—

14 (1) IN GENERAL.—The Inspector General of
 15 Amtrak shall have the authority available to other
 16 Inspectors General, as necessary in carrying out the
 17 duties specified in the Inspector General Act of 1978
 18 (5 U.S.C. App.), to investigate any alleged violation
 19 of sections 286, 287, 371, 641, 1001, 1002 and
 20 1516 of title 18, United States Code.

21 (2) AGENCY.—For purposes of sections 286,
 22 287, 371, 641, 1001, 1002, and 1516 of title 18,
 23 United States Code, Amtrak and the Amtrak Office
 24 of Inspector General, shall be considered a corpora-

1 tion in which the United States has a proprietary in-
2 terest as set forth in section 6 of that title.

3 (b) ASSESSMENT.—The Inspector General of Amtrak
4 shall—

5 (1) not later than 60 days after the date of en-
6 actment of this Act, initiate an assessment to deter-
7 mine whether current expenditures or procurements
8 involving Amtrak’s fulfillment of the Americans with
9 Disabilities Act of 1990 (42 U.S.C. 12101 et seq.)
10 utilize competitive, market-driven provisions that are
11 applicable throughout the entire term of such related
12 expenditures or procurements; and

13 (2) not later than 6 months after the date of
14 enactment of this Act, transmit to the Committee on
15 Commerce, Science, and Transportation of the Sen-
16 ate and the Committee on Transportation and Infra-
17 structure of the House of Representatives the as-
18 sessment under paragraph (1).

19 (c) LIMITATION.—The authority provided by sub-
20 sections (a) and (b) shall be effective only with respect
21 to a fiscal year for which Amtrak receives a Federal sub-
22 sidy.

23 **SEC. 314. MISCELLANEOUS PROVISIONS.**

20 **TITLE IV—RAIL SAFETY**

21 **Subtitle A—Safety Improvement**

22 **SEC. 401. HIGHWAY-RAIL GRADE CROSSING SAFETY.**

23 (a) MODEL STATE HIGHWAY-RAIL GRADE CROSSING
 24 ACTION PLAN.—

1 (1) IN GENERAL.—Not later than 1 year after
2 the date of enactment of this Act, the Secretary
3 shall develop a model of a State-specific highway-rail
4 grade crossing action plan and distribute the model
5 plan to each State.

6 (2) CONTENTS.—The plan developed under
7 paragraph (1) shall include—

8 (A) methodologies, tools, and data sources
9 for identifying and evaluating highway-rail
10 grade crossing safety risks;

11 (B) best practices to reduce the risk of
12 highway-rail grade crossing accidents or inci-
13 dents, including strategies for—

14 (i) education, including model stake-
15 holder engagement plans or tools;

16 (ii) engineering, including the benefits
17 and costs of different designs and tech-
18 nologies used to mitigate highway-rail
19 grade crossing safety risks; and

20 (iii) enforcement, including the
21 strengths and weaknesses associated with
22 different enforcement methods;

23 (C) for each State, a customized list and
24 data set of the highway-rail grade crossing acci-
25 dents or incidents in that State over the past 3

1 years, including the location, number of deaths,
2 and number of injuries for each accident or in-
3 cident; and

4 (D) contact information of a Department
5 of Transportation safety official available to as-
6 sist the State in adapting the model plan to sat-
7 isfy the requirements under subsection (b).

8 (b) STATE HIGHWAY-RAIL GRADE CROSSING ACTION
9 PLANS.—

10 (1) REQUIREMENTS.—Not later than 18
11 months after the Secretary develops and distributes
12 the model plan under subsection (a), the Secretary
13 shall promulgate a rule that requires—

14 (A) each State, except the 10 States iden-
15 tified under section 202 of the Rail Safety Im-
16 provement Act of 2008 (49 U.S.C. 22501 note),
17 to develop and implement a State highway-rail
18 grade crossing action plan; and

19 (B) each State that was identified under
20 section 202 of the Rail Safety Improvement Act
21 of 2008 (49 U.S.C. 22501 note), to update its
22 State action plan under that section and submit
23 to the Secretary the updated State action plan
24 and a report describing what the State did to
25 implement its previous State action plan under

1 that section and how it will continue to reduce
2 highway-rail grade crossing safety risks.

3 ~~(2) CONTENTS.—~~Each State plan required
4 under this subsection shall—

5 (A) identify highway-rail grade crossings
6 that have experienced recent highway-rail grade
7 crossing accidents or incidents, or are at high-
8 risk for accidents or incidents;

9 ~~(B)~~ identify specific strategies for improv-
10 ing safety at highway-rail grade crossings, in-
11 cluding highway-rail grade crossing closures or
12 grade separations; and

13 ~~(C)~~ designate a State official responsible
14 for managing implementation of the State plan
15 under subparagraph ~~(A)~~ or ~~(B)~~ of paragraph
16 ~~(1)~~, as applicable.

17 ~~(3) ASSISTANCE.—~~The Secretary shall provide
18 assistance to each State in developing and carrying
19 out, as appropriate, the State plan under this sub-
20 section.

21 ~~(4) PUBLIC AVAILABILITY.—~~Each State shall
22 submit its final State plan under this subsection to
23 the Secretary for publication. The Secretary shall
24 make each approved State plan publicly available on
25 an official Internet Web site.

1 (5) CONDITIONS.—The Secretary may condition
2 the awarding of a grant to a State under chapter
3 244 of title 49, United States Code, on that State
4 submitting an acceptable State plan under this sub-
5 section.

6 (6) REVIEW OF ACTION PLANS.—Not later than
7 60 days after the date of receipt of a State plan
8 under this subsection, the Secretary shall—

9 (A) if the State plan is approved, notify
10 the State and publish the State plan under
11 paragraph (4); and

12 (B) if the State plan is incomplete or defi-
13 cient, notify the State of the specific areas in
14 which the plan is deficient and allow the State
15 to complete the plan or correct the deficiencies
16 and resubmit the plan under paragraph (1).

17 (7) DEADLINE.—Not later than 60 days after
18 the date of a notice under paragraph (6)(B), a State
19 shall complete the plan or correct the deficiencies
20 and resubmit the plan.

21 (8) FAILURE TO COMPLETE OR CORRECT
22 PLAN.—If a State fails to meet the deadline under
23 paragraph (7), the Secretary shall post on the Web
24 site under paragraph (4) a notice that the State has

1 an incomplete or deficient highway-rail grade cross-
2 ing action plan.

3 (c) ~~RAILWAY-HIGHWAY CROSSINGS FUNDS.~~—The
4 Secretary may use funds made available to carry out sec-
5 tion 130 of title 23, United States Code, to provide States
6 with funds to develop a State highway-rail grade crossing
7 action plan under subsection (b)(1)(A) of this section or
8 to update a State action plan under subsection (b)(1)(B)
9 of this section.

10 (d) ~~DEFINITIONS.~~—In this section:

11 (1) ~~HIGHWAY-RAIL GRADE CROSSING.~~—The
12 term “highway-rail grade crossing” means a location
13 within a State, other than a location where 1 or
14 more railroad tracks cross 1 or more railroad tracks
15 at grade where—

16 (A) a public highway, road, or street, or a
17 private roadway, including associated sidewalks
18 and pathways, crosses 1 or more railroad tracks
19 either at grade or grade-separated; or

20 (B) a pathway explicitly authorized by a
21 public authority or a railroad carrier that is
22 dedicated for the use of non-vehicular traffic,
23 including pedestrians, bicyclists, and others,
24 that is not associated with a public highway,
25 road, or street, or a private roadway, crosses 1

1 or more railroad tracks either at grade or
2 grade-separated.

3 (2) STATE.—The term “State” means a State
4 of the United States or the District of Columbia.

5 **SEC. 402. CONFIDENTIAL CLOSE CALL REPORTING SYSTEM.**

6 (a) IN GENERAL.—Not later than 3 years after the
7 date of enactment of this Act, the Secretary shall promul-
8 gate a rule to encourage and facilitate the voluntary par-
9 ticipation of railroad carriers, railroad carrier contractors,
10 and employees of railroad carriers or railroad carrier con-
11 tractors (including any non-profit labor organizations rep-
12 resenting a class or craft of directly affected employees
13 of railroads carriers or railroad carrier contractors) in a
14 confidential close call reporting system.

15 (b) PROGRAM ELEMENTS.—

16 (1) IN GENERAL.—The Secretary shall use any
17 information and experience gathered through re-
18 search and pilot programs on confidential close call
19 reporting systems in developing a rule for the vol-
20 untary adoption of confidential close call reporting
21 system programs under this section.

22 (2) RULEMAKING.—

23 (A) IN GENERAL.—Each confidential close
24 call reporting system program shall be designed
25 to improve railroad safety by facilitating greater

1 collection and analysis of reports that describe
2 unsafe conditions and events in the railroad in-
3 dustry, as reported voluntarily and confiden-
4 tially by employees.

5 (B) REQUIREMENTS.—The rule shall
6 specify—

7 (i) the use of independent third par-
8 ties for the collection of close call reports,
9 de-identification of data, and distribution
10 of close call data;

11 (ii) the criteria for participating vol-
12 untarily in the confidential close call re-
13 porting system;

14 (iii) the criteria for accepting con-
15 fidential close call reports;

16 (iv) the appropriate use and protec-
17 tion, including the information protections
18 described in subsection (d), of peer review
19 teams and participation of the Secretary's
20 representatives;

21 (v) the relief from specific railroad
22 safety regulatory provisions and the condi-
23 tions under which the relief will and will
24 not be granted; and

1 (vi) the appropriate use and protec-
2 tion, including the information protections
3 described in subsection (d), of confidential
4 data generated under voluntary participa-
5 tion in the confidential close call reporting
6 system.

7 (c) PROGRAM DEVELOPMENT.—

8 (1) IN GENERAL.—A railroad carrier voluntarily
9 participating in a confidential close call reporting
10 system program, pursuant to program elements con-
11 tained in the final rule promulgated under sub-
12 section (b) and in collaboration with the Secretary,
13 railroad carrier contractors (as appropriate), and
14 employees of railroad carriers or railroad carrier
15 contractors (including any non-profit labor organiza-
16 tion representing a class or craft of directly affected
17 employees of railroad carriers or railroad carrier
18 contractors), shall develop an implementing memo-
19 randum of understanding that establishes agreed-
20 upon terms for participation in the confidential close
21 call reporting system.

22 (2) SIGNATURES REQUIRED.—An implementing
23 memorandum of understanding under paragraph (1)
24 shall be signed by—

1 (A) the Secretary or the Secretary's des-
2 ignee;

3 (B) the participating railroad carrier or
4 the representative thereof;

5 (C) if appropriate, each participating rail-
6 road carrier contractor or the representative
7 thereof; and

8 (D) the participating employees and con-
9 tractors or the representative thereof (such as
10 1 or more non-profit labor organizations rep-
11 resenting a class or craft of directly affected
12 employees of the railroad carrier or railroad
13 carrier contractor).

14 (d) INFORMATION PROTECTION.—

15 (1) IN GENERAL.—For a confidential close call
16 reporting system program established through an
17 implementing memorandum of understanding de-
18 scribed in subsection (c), the rule shall include provi-
19 sions that withhold from discovery or admission into
20 evidence (in a Federal or State court proceeding for
21 damages involving personal injury, wrongful death,
22 or property damage against a railroad carrier or
23 railroad carrier contractor) any plan, document, re-
24 port, survey, schedule, list, or data compiled or col-
25 lected for the sole purpose of developing, evaluating,

1 planning, or implementing a confidential close call
2 reporting system program, including a railroad ear-
3 nier's analysis of its close calls or near misses.

4 (2) RETROACTIVE APPLICATIONS.—With regard
5 to a voluntary confidential close call reporting sys-
6 tem that was in effect prior to the date of final rule
7 under subsection (a), the Secretary—

8 (A) shall allow the parties participating in
9 that system to sign a new or revised imple-
10 menting memorandum of understanding that
11 prospectively entitles the parties to the informa-
12 tion protections under paragraph (1); and

13 (B) may retroactively apply the informa-
14 tion protections under paragraph (1) to any in-
15 formation and analyses that was generated
16 under that system prior to the date of the final
17 rule.

18 (3) CONFIDENTIALITY.—For a confidential
19 close call reporting system program established
20 through an implementing memorandum of under-
21 standing described in subsection (e), the Secretary
22 shall ensure that the Department of Transportation
23 and any entity collecting close call reports, de-identi-
24 fying data, or distributing close call data provide the
25 same level of confidentiality as contained in the Con-

1 confidential Information Protection and Statistical Effi-
2 ciency Act of 2002 (44 U.S.C. 3501 note), as ad-
3 ministered by the Bureau of Transportation Statis-
4 tics.

5 (e) SAVINGS CLAUSE.—Nothing in this section
6 shall—

7 (1) require a railroad carrier to adopt a con-
8 fidential close call reporting system program;

9 (2) prohibit a railroad carrier from voluntarily
10 adopting a confidential close call reporting system
11 program outside of the rulemaking framework; and

12 (3) require the Secretary to develop a confiden-
13 tial close call reporting system program with a rail-
14 road carrier, a railroad carrier contractor, employees
15 of the railroad carrier or railroad carrier contractor,
16 or any non-profit labor organizations representing a
17 class or craft of employees of a railroad carrier or
18 a railroad carrier contractor.

19 (f) DEFINITION OF RAILROAD CARRIER.—In this
20 section, the term “railroad carrier” has the meaning given
21 the term in section 20102 of title 49, United States Code.

22 (g) ADDITIONAL INFORMATION PROTECTIONS.—Sec-
23 tion 20118 is amended—

24 (1) in subsection (a)—

1 (A) in the matter preceding paragraph

2 (1)—

3 (i) by inserting “, confidential close
4 call reporting system program,” after
5 “safety risk reduction program”; and

6 (ii) by inserting “pursuant to section
7 552(b)(3) of that title,” after “section 552
8 of title 5”;

9 (B) in paragraph (1), by inserting “, con-
10 fidential close call reporting system program,”
11 after “safety risk reduction program”; and

12 (C) in paragraph (2), by inserting “, con-
13 fidential close call reporting system program,”
14 after “safety risk reduction program”;

15 (2) in subsection (b), by inserting “, confiden-
16 tial close call reporting system program,” after
17 “safety risk reduction program”; and

18 (3) in subsection (e), by inserting “, of any in-
19 formation or analyses generated as part of a con-
20 fidential close call reporting system program,” after
21 “risk mitigation analyses”.

22 **SEC. 403. SPEED LIMIT ACTION PLANS.**

23 (a) IN GENERAL.—Not later than 90 days after the
24 date of enactment of this Act, each railroad carrier pro-
25 viding intercity rail passenger transportation or commuter

1 rail passenger transportation, in consultation with any ap-
2 plicable host railroad carrier, shall survey its entire system
3 and identify each main track location where there is a re-
4 duction of more than 20 miles per hour from the approach
5 speed to a curve or bridge and the maximum authorized
6 operating speed for passenger trains at that curve or
7 bridge.

8 (b) ACTION PLANS.—Not later than 120 days after
9 the date that the survey under subsection (a) is complete,
10 a rail passenger carrier shall submit to the Secretary an
11 action plan that—

12 (1) identifies each main track location where
13 there is a reduction of more than 20 miles per hour
14 from the approach speed to a curve or bridge and
15 the maximum authorized operating speed for pas-
16 senger trains at that curve or bridge;

17 (2) describes appropriate actions, including
18 modification to automatic train control systems, if
19 applicable, other signal systems, or other practices,
20 including increased crew communication, to enable
21 warning and enforcement of the maximum author-
22 ized speed for passenger trains at each location iden-
23 tified under paragraph (1);

1 (3) contains milestones and target dates for im-
2 plementing each appropriate action described under
3 paragraph (2); and

4 (4) ensures compliance with the maximum au-
5 thorized speed at each location identified under
6 paragraph (1).

7 (c) APPROVAL.—Not later than 90 days after the
8 date an action plan is submitted under subsection (a), the
9 Secretary shall approve, approve with conditions, or dis-
10 approve the action plan.

11 (d) ALTERNATIVE SAFETY MEASURES.—The Sec-
12 retary may exempt from the requirements of this section
13 each segment of track for which operations are governed
14 by a positive train control system certified under section
15 20157 of title 49, United States Code, or any other safety
16 technology or practice that would achieve an equivalent
17 or greater level of safety in reducing derailment risk.

18 (e) SAVINGS CLAUSE.—Nothing in this section shall
19 prohibit the Secretary from applying the requirements of
20 this section to other segments of track at high risk of over-
21 speed derailment.

22 **SEC. 404. SIGNAGE.**

23 (a) IN GENERAL.—The Secretary shall promulgate
24 such regulations as the Secretary considers necessary to
25 require each railroad carrier providing intercity rail pas-

1 senger transportation or commuter rail passenger trans-
2 portation, in consultation with any applicable host railroad
3 carrier, to install signs to warn train crews before the
4 train approaches a location that the Secretary identifies
5 as having high risk of overspeed derailment.

6 (b) **ALTERNATIVE SAFETY MEASURES.**—The Sec-
7 retary may exempt from the requirements of this section
8 each segment of track for which operations are governed
9 by a positive train control system certified under section
10 20157 of title 49, United States Code, or any other safety
11 technology or practice that would achieve an equivalent
12 or greater level of safety in reducing derailment risk.

13 **SEC. 405. ALERTERS.**

14 (a) **IN GENERAL.**—The Secretary shall promulgate a
15 rule to require a working alerter in the controlling loco-
16 motive of each passenger train in intercity rail passenger
17 transportation (as defined in section 24102 of title 49,
18 United States Code) or commuter rail passenger transpor-
19 tation (as defined in section 24102 of title 49, United
20 States Code).

21 (b) **RULEMAKING.**—

22 (1) **IN GENERAL.**—The Secretary may promul-
23 gate a rule to specify the essential functionalities of
24 a working alerter, including the manner in which the
25 alerter can be reset.

1 (2) ALTERNATE PRACTICE OR TECHNOLOGY.—

2 The Secretary may require or allow a technology or
3 practice in lieu of a working alerter if the Secretary
4 determines that the technology or practice would
5 achieve an equivalent or greater level of safety in en-
6 hancing or ensuring appropriate locomotive control.

7 **SEC. 406. SIGNAL PROTECTION.**

8 (a) IN GENERAL.—The Secretary shall promulgate
9 such regulations as the Secretary considers necessary to
10 require that on-track safety regulations, whenever prac-
11 ticable and consistent with other safety requirements and
12 operational considerations, include requiring implementa-
13 tion of redundant signal protection, such as shunting or
14 other practices and technologies that achieve an equivalent
15 or greater level of safety, for maintenance-of-way work
16 crews who depend on a train dispatcher to provide signal
17 protection.

18 (b) ALTERNATIVE SAFETY MEASURES.—The Sec-
19 retary may exempt from the requirements of this section
20 each segment of track for which operations are governed
21 by a positive train control system certified under section
22 20157 of title 49, United States Code, or any other safety
23 technology or practice that would achieve an equivalent
24 or greater level of safety in providing additional signal pro-
25 tection.

1 **SEC. 407. TECHNOLOGY IMPLEMENTATION PLANS.**

2 Section 20156(e) is amended—

3 (1) in paragraph (4)—

4 (A) in subparagraph (A), by striking
5 “and” at the end; and

6 (B) in subparagraph (B), by striking the
7 period at the end and inserting “; and”; and

8 (2) by adding at the end the following:

9 “(C) each railroad carrier required to sub-
10 mit such a plan, until the implementation of a
11 positive train control system by the railroad
12 carrier, shall analyze and, as appropriate,
13 prioritize technologies and practices to mitigate
14 the risk of overspeed derailments.”.

15 **SEC. 408. COMMUTER RAIL TRACK INSPECTIONS.**

16 (a) IN GENERAL.—The Secretary shall evaluate track
17 inspection regulations to determine if a railroad carrier
18 providing commuter rail passenger transportation on high
19 density commuter railroad lines should be required to in-
20 spect the lines in the same manner as currently required
21 for other commuter railroad lines.

22 (b) RULEMAKING.—Considering safety, including
23 railroad carrier employee and contractor safety, and sys-
24 tem capacity, the Secretary may promulgate a rule for
25 high density commuter railroad lines. If, after the evalua-
26 tion under subsection (a), the Secretary determines that

1 it is necessary to promulgate a rule, the Secretary shall
2 specifically consider the following regulatory requirements
3 for high density commuter railroad lines:

4 (1) At least once every 2 weeks—

5 (A) traverse each main line by vehicle; or

6 (B) inspect each main line on foot.

7 (2) At least once each month, traverse and in-
8 spect each siding by vehicle or by foot.

9 (c) REPORT.—If, after the evaluation under sub-
10 section (a), the Secretary determines it is not necessary
11 to revise the regulations under this section, the Secretary,
12 not later than 2 years after the date of enactment of this
13 Act, shall transmit a report to the Committee on Com-
14 merce, Science, and Transportation of the Senate and the
15 Committee on Transportation and Infrastructure of the
16 House of Representatives explaining the reasons for not
17 revising the regulations.

18 (d) CONSTRUCTION.—Nothing in this section may be
19 construed to limit the authority of the Secretary to pro-
20 mulgate regulations or issue orders under any other law.

21 **SEC. 409. EMERGENCY RESPONSE.**

22 (a) IN GENERAL.—The Secretary, in consultation
23 with railroad carriers, shall conduct a study to determine
24 whether limitations or weaknesses exist in the emergency

1 response information carried by train crews transporting
2 hazardous materials.

3 (b) CONTENTS.—In conducting the study under sub-
4 section (a), the Secretary shall evaluate the differences be-
5 tween the emergency response information carried by train
6 crews transporting hazardous materials and the emer-
7 gency response guidance provided in the Emergency Re-
8 sponse Guidebook issued by the Department of Transpor-
9 tation.

10 (c) REPORT.—Not later than 1 year after the date
11 of enactment of this Act, the Secretary shall transmit to
12 the Committee on Commerce, Science, and Transportation
13 of the Senate and the Committee on Transportation and
14 Infrastructure of the House of Representatives a report
15 of the findings of the study under subsection (a) and any
16 recommendations for legislative action.

17 **SEC. 410. PRIVATE HIGHWAY-RAIL GRADE CROSSINGS.**

18 (a) IN GENERAL.—The Secretary, in consultation
19 with railroad carriers, shall conduct a study—

20 (1) to determine whether limitations or weak-
21 nesses exist regarding the availability and usefulness
22 for safety purposes of data on private highway-rail
23 grade crossings; and

24 (2) to evaluate existing engineering practices on
25 private highway-rail grade crossings.

1 (b) CONTENTS.—In conducting the study under sub-
 2 section (a), the Secretary shall make recommendations as
 3 necessary to improve—

4 (1) the utility of the data on private highway-
 5 rail grade crossings; and

6 (2) the implementation of private highway-rail
 7 crossing safety measures, including signage and
 8 warning systems.

9 (c) REPORT.—Not later than 1 year after the date
 10 of enactment of this Act, the Secretary shall transmit to
 11 the Committee on Commerce, Science, and Transportation
 12 of the Senate and the Committee on Transportation and
 13 Infrastructure of the House of Representatives a report
 14 of the findings of the study and any recommendations for
 15 further action.

16 **SEC. 411. REPAIR AND REPLACEMENT OF DAMAGED TRACK**
 17 **INSPECTION EQUIPMENT.**

18 (a) IN GENERAL.—Subchapter I of chapter 201 is
 19 amended by inserting after section 20120 the following:

20 **“§ 20121. Repair and replacement of damaged track**
 21 **inspection equipment**

22 “The Secretary of Transportation may receive and
 23 expend cash, or receive and utilize spare parts and similar
 24 items, from non-United States Government sources to re-
 25 pair damages to or replace United States Government

1 owned automated track inspection cars and equipment as
 2 a result of third-party liability for such damages, and any
 3 amounts collected under this section shall be credited di-
 4 rectly to the Railroad Safety and Operations account of
 5 the Federal Railroad Administration, and shall remain
 6 available until expended for the repair, operation, and
 7 maintenance of automated track inspection cars and
 8 equipment in connection with the automated track inspec-
 9 tion program.”.

10 (b) **CONFORMING AMENDMENT.**—The table of con-
 11 tents for subchapter I of chapter 201 is amended by add-
 12 ing after section 21020 the following:

“20121. Repair and replacement of damaged track inspection equipment.”.

6 “(d) APPLICATION PROCESS.—The Secretary shall
7 prescribe the form and manner of filing an application
8 under this section.

9 “(e) PROJECT SELECTION CRITERIA.—

10 “(1) IN GENERAL.—In selecting a recipient of
11 a grant for an eligible project, the Secretary shall—

12 “(A) give preference to a proposed project
13 for which the proposed Federal share of total
14 project costs does not exceed 50 percent; and

15 “(B) after factoring in preference to
16 projects under subparagraph (A), select projects
17 that will maximize the net benefits of the funds
18 appropriated for use under this section, consid-
19 ering the cost-benefit analysis of the proposed
20 project, including anticipated private and public
21 benefits relative to the costs of the proposed
22 project and factoring in the other consider-
23 ations described in paragraph (2).

24 “(2) OTHER CONSIDERATIONS.—The Secretary

1 “(b) ENVIRONMENTAL REVIEWS.—

2 “(1) COMPLETION OF NEPA REVIEW.—Before

5 grant or other funding under this subtitle, the Sec-
6 retary shall complete, if required, the review process
7 under the National Environmental Policy Act of
8 1969 (42 U.S.C. 4321 et seq.) with respect to the
9 acquisition.

10 “(2) COMPLETION OF SECTION 106.—An acqui-
11 sition of a real property interest involving an historic
12 site shall not occur unless the section 106 process,
13 if required, under the National Historic Preservation
14 Act (54 U.S.C. 306108) is complete.

17 be developed in anticipation of the proposed project
18 until all required environmental reviews for the
19 project have been completed.”.

12 cal rating organization (as defined in section 3(a)
13 of the Securities Exchange Act of 1934 (15 U.S.C.
14 78e(a))).

15 “(15) The term ‘substantial completion’
16 means—

17 “(A) the opening of a project to passenger
18 or freight traffic; or

19 “(B) a comparable event, as determined by
20 the Secretary and specified in the direct loan.”.

21 **SEC. 603. ELIGIBLE APPLICANTS.**

12 “(A) IN GENERAL.—The Secretary may
13 appoint a financial entity to assist the Secretary
14 in servicing a direct loan or loan guarantee

16 “(B) DUTIES.—A servicer appointed under
17 subparagraph (A) shall act as the agent of the
18 Secretary in serving a direct loan or loan guar-
19 antee under this section.

20 “(C) FEES.—A servicer appointed under
21 subparagraph (A) shall receive a servicing fee
22 from the obligor or other loan party, subject to
23 approval by the Secretary.

24 “(4) USE OF OTHER FEDERAL FUNDS.—Not-

23 “(2) *USE OF NORTHEAST CORRIDOR INVESTMENT*
24 *ACCOUNT.*—*Except as provided in subsection (f),*
25 *amounts deposited in the Northeast Corridor invest-*

1 *ment account shall be made available for the use of*
2 *Amtrak for its share of—*

3 *“(A) capital projects described in section*
4 *24904(a)(2)(E)(i), and developed under the plan-*
5 *ning process established under that section, to*
6 *bring Northeast Corridor infrastructure to a*
7 *state-of-good-repair;*

8 *“(B) capital projects described in clauses*
9 *(ii) and (iv) of section 24904(a)(2)(E) that are*
10 *developed under the planning process established*
11 *under that section intended to increase corridor*
12 *capacity, improve service reliability, and reduce*
13 *travel time on the Northeast Corridor;*

14 *“(C) capital projects to improve safety and*
15 *security;*

16 *“(D) capital projects to improve customer*
17 *service and amenities;*

18 *“(E) acquiring, rehabilitating, manufac-*
19 *turing, remanufacturing, overhauling, or im-*
20 *proving equipment and associated facilities used*
21 *for intercity rail passenger transportation by*
22 *Northeast Corridor train services;*

23 *“(F) retirement of principal and payment*
24 *of interest on loans for capital projects described*

1 *in this paragraph or for capital leases for equip-*
2 *ment and related to the Northeast Corridor;*

3 “(G) *participation in public-private part-*
4 *nerships, joint ventures, and other mechanisms*
5 *or arrangements that result in the completion of*
6 *capital projects described in this paragraph; and*

7 “(H) *indirect, common, corporate, or other*
8 *costs directly incurred by or allocated to the*
9 *Northeast Corridor.*

10 “(c) *STATE-SUPPORTED ACCOUNT.—*

11 “(1) *DEPOSITS.—Amtrak shall deposit in the*
12 *State-supported account established under subsection*
13 *(a)(2)—*

14 “(A) *a portion of the grant funds appro-*
15 *priated under the authorization in section*
16 *101(a) of the Railroad Reform, Enhancement,*
17 *and Efficiency Act, or any subsequent Act ap-*
18 *propriating funds for the use of Amtrak, as spec-*
19 *ified in a grant agreement entered into under*
20 *section 24318;*

21 “(B) *any compensation received from States*
22 *provided to Amtrak under section 209 of the*
23 *Passenger Rail Investment and Improvement Act*
24 *of 2008 (42 U.S.C. 24101 note); and*

1 “(C) any operating surplus from its State-
2 supported routes, as allocated under section
3 24317.

4 “(2) *USE OF STATE-SUPPORTED ACCOUNT.*—*Ex-*
5 *cept as provided in subsection (f), amounts deposited*
6 *in the State-supported account shall be made avail-*
7 *able for the use of Amtrak for capital expenses and*
8 *operating costs, including indirect, common, cor-*
9 *porate, or other costs directly incurred by or allocated*
10 *to State-supported routes, of its State-supported*
11 *routes and retirement of principal and payment of*
12 *interest on loans or capital leases attributable to its*
13 *State-supported routes.*

14 “(d) *LONG-DISTANCE ACCOUNT.*—

15 “(1) *DEPOSITS.*—*Amtrak shall deposit in the*
16 *long-distance account established under subsection*
17 *(a)(3)—*

18 “(A) *a portion of the grant funds appro-*
19 *priated under the authorization in section*
20 *101(a) of the Railroad Reform, Enhancement,*
21 *and Efficiency Act, or any subsequent Act ap-*
22 *propriating funds for the use of Amtrak, as spec-*
23 *ified in a grant agreement entered into under*
24 *section 24318;*

1 “(B) any compensation received from States
2 provided to Amtrak for costs associated with its
3 long-distance routes; and

4 “(C) any operating surplus from its long-
5 distance routes, as allocated under section 24317.

6 “(2) USE OF LONG-DISTANCE ACCOUNT.—Except
7 as provided in subsection (f), amounts deposited in
8 the long-distance account shall be made available for
9 the use of Amtrak for capital expenses and operating
10 costs, including indirect, common, corporate, or other
11 costs directly incurred by or allocated to long-distance
12 routes, of its long-distance routes and retirement of
13 principal and payment of interest on loans or capital
14 leases attributable to the long-distance routes.

15 “(e) OTHER NATIONAL NETWORK ACTIVITIES AC-
16 COUNT.—

17 “(1) DEPOSITS.—Amtrak shall deposit in the
18 other national network activities account established
19 under subsection (a)(4)—

20 “(A) a portion of the grant funds appro-
21 priated under the authorization in section
22 101(a) of the Railroad Reform, Enhancement,
23 and Efficiency Act, or any subsequent Act ap-
24 propriating funds for the use of Amtrak, as spec-

1 *ified in a grant agreement entered into under*
2 *section 24318;*

3 “(B) *any compensation received from States*
4 *provided to Amtrak for costs associated with its*
5 *other national network activities; and*

6 “(C) *any operating surplus from its other*
7 *national network activities.*

8 “(2) *USE OF OTHER NATIONAL NETWORK ACTIVI-*
9 *TIES ACCOUNT.—Except as provided in subsection (f),*
10 *amounts deposited into the other national network ac-*
11 *tivities account shall be made available for the use of*
12 *Amtrak for capital and operating costs not allocated*
13 *to the Northeast Corridor investment account, State-*
14 *supported account, or long-distance account, and re-*
15 *tirement of principal and payment of interest on*
16 *loans or capital leases attributable to other national*
17 *network activities.*

18 “(f) *TRANSFER AUTHORITY.—*

19 “(1) *AUTHORITY.—Amtrak may transfer any*
20 *funds appropriated under the authorization in section*
21 *101(a) of the Railroad Reform, Enhancement, and*
22 *Efficiency Act, or any subsequent Act appropriating*
23 *funds for the use of Amtrak for deposit into the ac-*
24 *counts described in that section, or any surplus gen-*
25 *erated by operations, between the Northeast Corridor,*

1 *State-supported, long-distance, and other national*
2 *network activities accounts—*

3 “(A) upon the expiration of 10 days after
4 the date that Amtrak notifies the Amtrak Board
5 of Directors, including the Secretary, of the
6 planned transfer; and

7 “(B) with the approval of the Secretary.

8 “(2) REPORT.—Not later than 5 days after the
9 date that Amtrak notifies the Amtrak Board of Direc-
10 tors of a planned transfer under paragraph (1), Am-
11 trak shall transmit to the Committee on Commerce,
12 Science, and Transportation and the Committee on
13 Appropriations of the Senate and the Committee on
14 Transportation and Infrastructure and the Committee
15 on Appropriations of the House of Representatives a
16 report that includes—

17 “(A) the amount of the transfer; and

18 “(B) a detailed explanation of the reason
19 for the transfer, including—

20 “(i) the effects on Amtrak services
21 funded by the account from which the trans-
22 fer is drawn, in comparison to a scenario
23 in which no transfer was made; and

24 “(ii) the effects on Amtrak services
25 funded by the account receiving the transfer,

1 *in comparison to a scenario in which no*
2 *transfer was made.*

3 “(3) *NOTIFICATIONS.—*

4 “(A) *STATE-SUPPORTED ACCOUNT.—Not*
5 *later than 5 days after the date that Amtrak no-*
6 *tifies the Amtrak Board of Directors of a*
7 *planned transfer under paragraph (1) of funds*
8 *to or from the State-supported account, Amtrak*
9 *shall transmit to each State that sponsors a*
10 *State-supported route a letter that includes the*
11 *information described under subparagraphs (A)*
12 *and (B) of paragraph (2).*

13 “(B) *NORTHEAST CORRIDOR ACCOUNT.—*
14 *Not later than 5 days after the date that Amtrak*
15 *notifies the Amtrak Board of Directors of a*
16 *planned transfer under paragraph (1) of funds*
17 *to or from the Northeast Corridor account, Am-*
18 *trak shall transmit to the Northeast Corridor*
19 *Commission a letter that includes the informa-*
20 *tion described under subparagraphs (A) and (B)*
21 *of paragraph (2).*

22 “(g) *ENFORCEMENT.—The Secretary shall enforce the*
23 *provisions of each grant agreement under section 24318(d),*
24 *including any deposit into an account under this section.*

25 “(h) *LETTERS OF INTENT.—*

1 “(1) *REQUIREMENT.*—*The Secretary may issue a*
2 *letter of intent to Amtrak announcing an intention to*
3 *obligate, for a major capital project described in*
4 *clauses (ii) and (iv) of section 24904(a)(2)(E), an*
5 *amount from future available budget authority speci-*
6 *fied in law that is not more than the amount stipu-*
7 *lated as the financial participation of the Secretary*
8 *in the project.*

9 “(2) *NOTICE TO CONGRESS.*—*At least 30 days*
10 *before issuing a letter under paragraph (1), the Sec-*
11 *retary shall notify in writing the Committee on Com-*
12 *merce, Science, and Transportation and the Com-*
13 *mittee on Appropriations of the Senate and the Com-*
14 *mittee on Transportation and Infrastructure and the*
15 *Committee on Appropriations of the House of Rep-*
16 *resentatives of the proposed letter. The Secretary shall*
17 *include with the notice a copy of the proposed letter,*
18 *the criteria used for selecting the project for a grant*
19 *award, and a description of how the project meets the*
20 *criteria under this section.*

21 “(3) *CONTINGENT NATURE OF OBLIGATION OR*
22 *COMMITMENT.*—*An obligation or administrative com-*
23 *mitment may be made only when amounts are appro-*
24 *priated. The letter of intent shall state that the con-*
25 *tingent commitment is not an obligation of the Fed-*

1 *eral Government, and is subject to the availability of*
 2 *appropriations under Federal law and to Federal*
 3 *laws in force or enacted after the date of the contin-*
 4 *gent commitment.”.*

5 *(b) CONFORMING AMENDMENTS.—The table of contents*

17 **SEC. 202. 5-YEAR BUSINESS LINE AND ASSETS PLANS.**

18 *(a) AMTRAK 5-YEAR BUSINESS LINE AND ASSET*
 19 *PLANS.—Chapter 243, as amended by section 201 of this*
 20 *Act, is further amended by inserting after section 24319 the*
 21 *following:*

22 **“§ 24320. Amtrak 5-year business line and asset plans**

23 *“(a) IN GENERAL.—*

1 “(1) *FINAL PLANS.*—Not later than February 15
 2 of each year, Amtrak shall submit to Congress and the
 3 Secretary final 5-year business line plans and 5-year
 4 asset plans prepared in accordance with this section.
 5 These final plans shall form the basis for Amtrak’s
 6 general and legislative annual report to the President
 7 and Congress required by section 24315(b).

8 “(2) *FISCAL CONSTRAINT.*—Each plan prepared
 9 under this section shall be based on funding levels au-
 10 thorized or otherwise available to Amtrak in a fiscal
 11 year. In the absence of an authorization or appro-
 12 priation of funds for a fiscal year, the plans shall be
 13 based on the amount of funding available in the pre-
 14 vious fiscal year, plus inflation. Amtrak may include
 15 an appendix to the asset plan required in subsection
 16 (c) that describes any capital funding requirements in
 17 excess of amounts authorized or otherwise available to
 18 Amtrak in a fiscal year for capital investment.

19 “(b) *AMTRAK 5-YEAR BUSINESS LINE PLANS.*—

20 “(1) *AMTRAK BUSINESS LINES.*—Amtrak shall
 21 prepare a 5-year business line plan for each of the fol-
 22 lowing business lines and services:

23 “(A) Northeast Corridor train services.

24 “(B) State-supported routes operated by
 25 Amtrak.

1 “(C) Long-distance routes operated by Am-
2 trak.

3 “(D) Ancillary services operated by Amtrak,
4 including commuter operations and other rev-
5 enue generating activities as determined by the
6 Secretary in consultation with Amtrak.

7 “(2) CONTENTS OF 5-YEAR BUSINESS LINE
8 PLANS.—The 5-year business line plan for each busi-
9 ness line shall include, at a minimum—

10 “(A) a statement of Amtrak’s vision, goals,
11 and service plan for the business line, coordi-
12 nated with any entities that are contributing
13 capital or operating funding to support pas-
14 senger rail services within those business lines,
15 and aligned with Amtrak’s Strategic Plan and
16 5-year asset plans under subsection (c);

17 “(B) all projected revenues and expenditures
18 for the business line, including identification of
19 revenues and expenditures incurred by—

20 “(i) passenger operations;

21 “(ii) non-passenger operations that are
22 directly related to the business line; and

23 “(iii) governmental funding sources,
24 including revenues and other funding re-
25 ceived from States;

1 “(C) projected ridership levels for all pas-
2 senger operations;

3 “(D) estimates of long-term and short-term
4 debt and associated principal and interest pay-
5 ments (both current and forecasts);

6 “(E) annual profit and loss statements and
7 forecasts and balance sheets;

8 “(F) annual cash flow forecasts;

9 “(G) a statement describing the methodolo-
10 gies and significant assumptions underlying esti-
11 mates and forecasts;

12 “(H) specific performance measures that
13 demonstrate year over year changes in the results
14 of Amtrak’s operations;

15 “(I) financial performance for each route
16 within each business line, including descriptions
17 of the cash operating loss or contribution and
18 labor productivity for each route;

19 “(J) specific costs and savings estimates re-
20 sulting from reform initiatives;

21 “(K) prior fiscal year and projected equip-
22 ment reliability statistics; and

23 “(L) an identification and explanation of
24 any major adjustments made from previously-
25 approved plans.

1 “(3) 5-YEAR BUSINESS LINE PLANS PROCESS.—
2 *In meeting the requirements of this section, Amtrak*
3 *shall—*

4 “(A) *coordinate the development of the busi-*
5 *ness line plans with the Secretary;*

6 “(B) *for the Northeast Corridor business*
7 *line plan, coordinate with the Northeast Corridor*
8 *Commission and transmit to the Commission the*
9 *final plan under subsection (a)(1), and consult*
10 *with other entities, as appropriate;*

11 “(C) *for the State-supported route business*
12 *line plan, coordinate with the State-Supported*
13 *Route Committee established under section*
14 *24712;*

15 “(D) *for the long-distance route business*
16 *line plan, coordinate with any States or Inter-*
17 *state Compacts that provide funding for such*
18 *routes, as appropriate;*

19 “(E) *ensure that Amtrak’s annual budget*
20 *request to Congress is consistent with the infor-*
21 *mation in the 5-year business line plans; and*

22 “(F) *identify the appropriate Amtrak offi-*
23 *cial s that are responsible for each business line.*

24 “(4) STANDARDS TO PROMOTE FINANCIAL STA-
25 *BILITY.—In meeting the requirements under this sub-*

1 *section, Amtrak shall use the categories specified in*
2 *the financial accounting and reporting system devel-*
3 *oped under section 203 of the Passenger Rail Invest-*
4 *ment and Improvement Act of 2008 (49 U.S.C. 24101*
5 *note) when preparing its 5-year business line plans.*

6 *“(c) AMTRAK 5-YEAR ASSET PLANS.—*

7 *“(1) ASSET CATEGORIES.—Amtrak shall prepare*
8 *a 5-year asset plan for each of the following asset cat-*
9 *egories:*

10 *“(A) Infrastructure, including all Amtrak-*
11 *controlled Northeast Corridor assets and other*
12 *Amtrak-owned infrastructure, and the associated*
13 *facilities that support the operation, mainte-*
14 *nance, and improvement of those assets.*

15 *“(B) Passenger rail equipment, including*
16 *all Amtrak-controlled rolling stock, locomotives,*
17 *and mechanical shop facilities that are used to*
18 *overhaul equipment.*

19 *“(C) Stations, including all Amtrak-con-*
20 *trolled passenger rail stations and elements of*
21 *other stations for which Amtrak has legal respon-*
22 *sibility or intends to make capital investments.*

23 *“(D) National assets, including national*
24 *reservations, security, training and training cen-*

1 *ters, and other assets associated with Amtrak's*
2 *national passenger rail transportation system.*

3 “(2) *CONTENTS OF 5-YEAR ASSET PLANS.—Each*
4 *asset plan shall include, at a minimum—*

5 “(A) *a summary of Amtrak's 5-year stra-*
6 *tegic plan for each asset category, including*
7 *goals, objectives, any relevant performance*
8 *metrics, and statutory or regulatory actions af-*
9 *fecting the assets;*

10 “(B) *an inventory of existing Amtrak cap-*
11 *ital assets, to the extent practicable, including*
12 *information regarding shared use or ownership,*
13 *if applicable;*

14 “(C) *a prioritized list of proposed capital*
15 *investments that—*

16 “(i) *categorizes each capital project as*
17 *being primarily associated with—*

18 “(I) *normalized capital replace-*
19 *ment;*

20 “(II) *backlog capital replacement;*

21 “(III) *improvements to support*
22 *service enhancements or growth;*

23 “(IV) *strategic initiatives that*
24 *will improve overall operational per-*

1 *formance, lower costs, or otherwise im-*
2 *prove Amtrak’s corporate efficiency; or*

3 “(V) *statutory, regulatory, or*
4 *other legal mandates;*

5 “(ii) *identifies each project or program*
6 *that is associated with more than 1 category*
7 *described in clause (i); and*

8 “(iii) *describes the anticipated business*
9 *outcome of each project or program identi-*
10 *fied under this subparagraph, including an*
11 *assessment of—*

12 “(I) *the potential effect on pas-*
13 *senger operations, safety, reliability,*
14 *and resilience;*

15 “(II) *the potential effect on Am-*
16 *trak’s ability to meet regulatory re-*
17 *quirements if the project or program is*
18 *not funded; and*

19 “(III) *the benefits and costs; and*

20 “(D) *annual profit and loss statements and*
21 *forecasts and balance sheets for each asset cat-*
22 *egory.*

23 “(3) *5-YEAR ASSET PLAN PROCESS.—In meeting*
24 *the requirements of this subsection, Amtrak shall—*

1 “(A) coordinate with each business line de-
2 scribed in subsection (b)(1) in the preparation of
3 each 5-year asset plan and ensure integration of
4 each 5-year asset plan with the 5-year business
5 line plans;

6 “(B) as applicable, coordinate with the
7 Northeast Corridor Commission, the State-Sup-
8 ported Route Committee, and owners of assets af-
9 fected by 5-year asset plans; and

10 “(C) identify the appropriate Amtrak offi-
11 cials that are responsible for each asset category.

12 “(4) *EVALUATION OF NATIONAL ASSETS*
13 *COSTS.—The Secretary shall—*

14 “(A) evaluate the costs and scope of all na-
15 tional assets; and

16 “(B) determine the activities and costs that
17 are—

18 “(i) required in order to ensure the ef-
19 ficient operations of a national passenger
20 rail system;

21 “(ii) appropriate for allocation to 1 of
22 the other Amtrak business lines; and

23 “(iii) extraneous to providing an effi-
24 cient national passenger rail system or are

1 *too costly relative to the benefits or perform-*
2 *ance outcomes they provide.*

3 “(5) *DEFINITION OF NATIONAL ASSETS.—In this*
4 *section, the term ‘national assets’ means the Nation’s*
5 *core rail assets shared among Amtrak services, includ-*
6 *ing national reservations, security, training and*
7 *training centers, and other assets associated with Am-*
8 *trak’s national passenger rail transportation system.*

9 “(6) *RESTRUCTURING OF NATIONAL ASSETS.—*
10 *Not later than 1 year after the date of completion of*
11 *the evaluation under paragraph (4), the Adminis-*
12 *trator of the Federal Railroad Administration, in*
13 *consultation with the Amtrak Board of Directors, the*
14 *governors of each relevant State, and the Mayor of the*
15 *District of Columbia, or their designees, shall restruc-*
16 *ture or reallocate, or both, the national assets costs in*
17 *accordance with the determination under that section,*
18 *including making appropriate updates to Amtrak’s*
19 *cost accounting methodology and system.”.*

20 (b) *EFFECTIVE DATE.—The requirements for Amtrak*
21 *to submit final 5-year business line plans and 5-year asset*
22 *plans under section 24320 of title 49, United States Code,*
23 *shall take effect 1 year after the date of enactment of this*
24 *Act.*

1 (c) *CONFORMING AMENDMENTS.*—*The table of contents*

8 (e) *IDENTIFICATION OF DUPLICATIVE REPORTING RE-*
 9 *QUIREMENTS.*—*Not later than 1 year after the date of en-*
 10 *actment of this Act, the Secretary shall—*

11 (1) *review existing Amtrak reporting require-*
 12 *ments and identify where the existing requirements*
 13 *are duplicative with the business line and capital*
 14 *plans required by section 24320 of title 49, United*
 15 *States Code;*

16 (2) *if the duplicative reporting requirements are*
 17 *administrative, the Secretary shall eliminate the du-*
 18 *plicative requirements; and*

19 (3) *submit to Congress a report with any rec-*
 20 *ommendations for repealing any other duplicative*
 21 *Amtrak reporting requirements.*

22 **SEC. 203. STATE-SUPPORTED ROUTE COMMITTEE.**

14 “(2) *MEMBERSHIP.*—

15 “(A) *IN GENERAL.*—The Committee shall
16 consist of—

17 “(i) members representing Amtrak;

18 “(ii) members representing the Depart-
19 ment of Transportation, including the Fed-
20 eral Railroad Administration; and

21 “(iii) members representing States, in-
22 cluding other public entities that sponsor
23 the operation of trains by Amtrak on a
24 State-supported route, designated by, and
25 serving at the pleasure of, the chief executive
26 officer thereof.

1 “(B) *NON-VOTING MEMBERS.*—*The Com-*
2 *mittee may invite and accept other non-voting*
3 *members to participate in Committee activities,*
4 *as appropriate.*

5 “(3) *DECISIONMAKING.*—*The Committee shall es-*
6 *tablish a bloc voting system under which, at a min-*
7 *imum—*

8 “(A) *there are 3 separate voting blocs to*
9 *represent the Committee’s voting members, in-*
10 *cluding—*

11 “(i) *1 voting bloc to represent the*
12 *members described in paragraph (2)(A)(i);*

13 “(ii) *1 voting bloc to represent the*
14 *members described in paragraph (2)(A)(ii);*
15 *and*

16 “(iii) *1 voting bloc to represent the*
17 *members described in paragraph (2)(A)(iii);*

18 “(B) *each voting bloc has 1 vote;*

19 “(C) *the vote of the voting bloc representing*
20 *the members described in paragraph (2)(A)(iii)*
21 *requires the support of at least two-thirds of that*
22 *voting bloc’s members; and*

23 “(D) *the Committee makes decisions by*
24 *unanimous consent of the 3 voting blocs.*

1 “(4) *MEETINGS; RULES AND PROCEDURES.*—*The*
2 *Committee shall convene a meeting and shall define*
3 *and implement the rules and procedures governing the*
4 *Committee’s proceedings not later than 180 days after*
5 *the date of establishment of the Committee by the Sec-*
6 *retary. The rules and procedures shall—*

7 “(A) *incorporate and further describe the*
8 *decisionmaking procedures to be used in accord-*
9 *ance with paragraph (3); and*

10 “(B) *be adopted in accordance with such de-*
11 *cisionmaking procedures.*

12 “(5) *COMMITTEE DECISIONS.*—*Decisions made*
13 *by the Committee in accordance with the Committee’s*
14 *rules and procedures, once established, are binding on*
15 *all Committee members.*

16 “(6) *COST ALLOCATION METHODOLOGY.*—

17 “(A) *IN GENERAL.*—*Subject to subpara-*
18 *graph (B), the Committee may amend the cost*
19 *allocation methodology required and previously*
20 *approved under section 209 of the Passenger*
21 *Rail Investment and Improvement Act of 2008*
22 *(49 U.S.C. 24101 note).*

23 “(B) *PROCEDURES FOR CHANGING METH-*
24 *ODOLOGY.*—*The rules and procedures imple-*
25 *mented under paragraph (4) shall include proce-*

1 *dures for changing the cost allocation method-*
2 *ology.*

3 “(C) *REQUIREMENTS.*—*The cost allocation*
4 *methodology shall—*

5 “(i) *ensure equal treatment in the pro-*
6 *vision of like services of all States and*
7 *groups of States; and*

8 “(ii) *allocate to each route the costs in-*
9 *curring only for the benefit of that route and*
10 *a proportionate share, based upon factors*
11 *that reasonably reflect relative use, of costs*
12 *incurred for the common benefit of more*
13 *than 1 route.*

14 “(b) *INVOICES AND REPORTS.*—*Not later than Feb-*
15 *ruary 15, 2016, and monthly thereafter, Amtrak shall pro-*
16 *vide to each State that sponsors a State-supported route a*
17 *monthly invoice of the cost of operating such route, includ-*
18 *ing fixed costs and third-party costs. The Committee shall*
19 *determine the frequency and contents of the financial and*
20 *performance reports that Amtrak shall provide to the*
21 *States, as well as the planning and demand reports that*
22 *the States shall provide to Amtrak.*

23 “(c) *DISPUTE RESOLUTION.*—

24 “(1) *REQUEST FOR DISPUTE RESOLUTION.*—*If a*
25 *dispute arises with respect to the rules and procedures*

1 *implemented under subsection (a)(4), an invoice or a*
2 *report provided under subsection (b), implementation*
3 *or compliance with the cost allocation methodology*
4 *developed under section 209 of the Passenger Rail In-*
5 *vestment and Improvement Act of 2008 (49 U.S.C.*
6 *24101 note) or amended under subsection (a)(6) of*
7 *this section, either Amtrak or the State may request*
8 *that the Surface Transportation Board conduct dis-*
9 *pute resolution under this subsection.*

10 *“(2) PROCEDURES.—The Surface Transportation*
11 *Board shall establish procedures for resolution of dis-*
12 *putes brought before it under this subsection, which*
13 *may include provision of professional mediation serv-*
14 *ices.*

15 *“(3) BINDING EFFECT.—A decision of the Sur-*
16 *face Transportation Board under this subsection shall*
17 *be binding on the parties to the dispute.*

18 *“(4) OBLIGATION.—Nothing in this subsection*
19 *shall affect the obligation of a State to pay an*
20 *amount not in dispute.*

21 *“(d) ASSISTANCE.—*

22 *“(1) IN GENERAL.—The Secretary may provide*
23 *assistance to the parties in the course of negotiations*
24 *for a contract for operation of a State-supported*
25 *route.*

1 “(2) *FINANCIAL ASSISTANCE.—From among*
2 *available funds, the Secretary shall—*

3 “(A) *provide financial assistance to Amtrak*
4 *or 1 or more States to perform requested inde-*
5 *pendent technical analysis of issues before the*
6 *Committee; and*

7 “(B) *reimburse Members for travel expenses,*
8 *including per diem in lieu of subsistence, in ac-*
9 *cordance with section 5703 of title 5.*

10 “(e) *PERFORMANCE METRICS.—In negotiating a con-*
11 *tract for operation of a State-supported route, Amtrak and*
12 *the State or States that sponsor the route shall consider in-*
13 *cluding provisions that provide penalties and incentives for*
14 *performance.*

15 “(f) *STATEMENT OF GOALS AND OBJECTIVES.—*

16 “(1) *IN GENERAL.—The Committee shall develop*
17 *a statement of goals, objectives, and associated rec-*
18 *ommendations concerning the future of State-sup-*
19 *ported routes operated by Amtrak. The statement*
20 *shall identify the roles and responsibilities of Com-*
21 *mittee members and any other relevant entities, such*
22 *as host railroads, in meeting the identified goals and*
23 *objectives, or carrying out the recommendations. The*
24 *Committee may consult with such relevant entities, as*

1 *the Committee considers appropriate, when developing*
2 *the statement.*

3 “(2) *TRANSMISSION OF STATEMENT OF GOALS*
4 *AND OBJECTIVES.—Not later than 2 years after the*
5 *date of enactment of the Railroad Reform, Enhance-*
6 *ment, and Efficiency Act the Committee shall trans-*
7 *mit the statement developed under paragraph (1) to*
8 *the Committee on Commerce, Science, and Transpor-*
9 *tation of the Senate and the Committee on Transpor-*
10 *tation and Infrastructure of the House of Representa-*
11 *tives.*

12 “(g) *RULE OF CONSTRUCTION.—The decisions of the*
13 *Committee—*

14 “(1) *shall pertain to the rail operations of Am-*
15 *trak and related activities of trains operated by Am-*
16 *trak on State-sponsored routes; and*

17 “(2) *shall not pertain to the rail operations or*
18 *related activities of services operated by other rail*
19 *passenger carriers on State-supported routes.*

20 “(h) *FEDERAL ADVISORY COMMITTEE ACT.—The Fed-*
21 *eral Advisory Committee Act (5 U.S.C. App.) shall not*
22 *apply to the Committee.*

23 “(i) *DEFINITION OF STATE.—In this section, the term*
24 *‘State’ means each of the 50 States, the District of Colum-*

1 *bia, and a public entity that sponsors the operation of*
 2 *trains by Amtrak on a State-supported route.”.*

3 (b) *TECHNICAL AND CONFORMING AMENDMENTS.—*
 4 *The table of contents for chapter 247 is amended by adding*
 5 *at the end the following:*

“24712. State-supported routes operated by Amtrak.”.

6 **SEC. 204. ROUTE AND SERVICE PLANNING DECISIONS.**

7 *Section 208 of the Passenger Rail Investment and Im-*
 8 *provement Act of 2008 (49 U.S.C. 24101 note) is amended*
 9 *to read as follows:*

10 **“SEC. 208. METHODOLOGIES FOR AMTRAK ROUTE AND**
 11 **SERVICE PLANNING DECISIONS.**

12 *“(a) METHODOLOGY DEVELOPMENT.—Not later than*
 13 *180 days after the date of enactment of the Railroad Re-*
 14 *form, Enhancement, and Efficiency Act, as a condition of*
 15 *receiving a grant under section 101 of that Act, Amtrak*
 16 *shall obtain the services of an independent entity to develop*
 17 *and recommend objective methodologies for Amtrak to use*
 18 *in determining what intercity rail passenger transportation*
 19 *routes and services it should provide, including the estab-*
 20 *lishment of new routes, the elimination of existing routes,*
 21 *and the contraction or expansion of services or frequencies*
 22 *over such routes.*

23 *“(b) CONSIDERATIONS.—Amtrak shall require the*
 24 *independent entity, in developing the methodologies de-*
 25 *scribed in subsection (a), to consider—*

1 “(1) the current and expected performance and
2 service quality of intercity rail passenger transpor-
3 tation operations, including cost recovery, on-time
4 performance, ridership, on-board services, stations, fa-
5 cilities, equipment, and other services;

6 “(2) the connectivity of a route with other routes;

7 “(3) the transportation needs of communities
8 and populations that are not well served by intercity
9 rail passenger transportation service or by other
10 forms of intercity transportation;

11 “(4) the methodologies of Amtrak and major
12 intercity rail passenger transportation service pro-
13 viders in other countries for determining intercity
14 passenger rail routes and services;

15 “(5) the financial and operational effects on the
16 overall network, including the effects on indirect costs;

17 “(6) the views of States and the recommenda-
18 tions described in State rail plans, rail carriers that
19 own infrastructure over which Amtrak operates,
20 Interstate Compacts established by Congress and
21 States, Amtrak employee representatives, stakeholder
22 organizations, and other interested parties; and

23 “(7) the funding levels that will be available
24 under authorization levels that have been enacted into
25 law.

1 “(c) *RECOMMENDATIONS.*—Not later than 1 year after
 2 the date of enactment of the Railroad Reform, Enhance-
 3 ment, and Efficiency Act, Amtrak shall transmit to the
 4 Committee on Commerce, Science, and Transportation of
 5 the Senate and the Committee on Transportation and In-
 6 frastructure of the House of Representatives recommenda-
 7 tions developed by the independent entity under subsection
 8 (a).

9 “(d) *CONSIDERATION OF RECOMMENDATIONS.*—Not
 10 later than 90 days after the date the recommendations are
 11 transmitted under subsection (c), Amtrak shall consider the
 12 adoption of each recommendation and transmit to the Com-
 13 mittee on Commerce, Science, and Transportation of the
 14 Senate and the Committee on Transportation and Infra-
 15 structure of the House of Representatives a report explain-
 16 ing the reasons for adopting or not adopting each rec-
 17 ommendation.”.

18 **SEC. 205. COMPETITION.**

19 (a) *ALTERNATE PASSENGER RAIL SERVICE PILOT*
 20 *PROGRAM.*—Section 24711 is amended to read as follows:

21 **“§24711. Alternate passenger rail service pilot pro-**
 22 **gram**

23 “(a) *IN GENERAL.*—Not later than 18 months after the
 24 date of enactment of the Railroad Reform, Enhancement,
 25 and Efficiency Act, the Secretary of Transportation shall

1 *promulgate a rule to implement a pilot program for com-*
2 *petitive selection of rail carriers for long-distance routes (as*
3 *defined in section 24102).*

4 “(b) *PILOT PROGRAM REQUIREMENTS.*—

5 “(1) *IN GENERAL.*—*The pilot program shall—*

6 “(A) *allow a party described in paragraph*
7 *(2) to petition the Secretary to provide intercity*
8 *rail passenger transportation over a long-dis-*
9 *tance route in lieu of Amtrak for an operations*
10 *period of 4 years from the date of commencement*
11 *of service by the winning bidder and, at the op-*
12 *tion of the Secretary, consistent with the rule*
13 *promulgated under subsection (a), allow the con-*
14 *tract to be renewed for an additional operations*
15 *period of 4 years, but not to exceed a total of 3*
16 *operations periods;*

17 “(B) *require the Secretary to—*

18 “(i) *notify the petitioner and Amtrak*
19 *of receipt of the petition under subpara-*
20 *graph (A) and to publish in the Federal*
21 *Register a notice of receipt not later than*
22 *30 days after the date of receipt; and*

23 “(ii) *establish a deadline, of not more*
24 *than 120 days after the notice of receipt is*
25 *published in the Federal Register under*

1 *clause (i), by which both the petitioner and*
2 *Amtrak, if Amtrak chooses to do so, would*
3 *be required to submit a complete bid to pro-*
4 *vide intercity rail passenger transportation*
5 *over the applicable route;*

6 “(C) require that each bid—

7 “(i) describe the capital needs, finan-
8 cial projections, and operational plans, in-
9 cluding staffing plans, for the service, and
10 such other factors as the Secretary considers
11 appropriate; and

12 “(ii) be made available by the winning
13 bidder to the public after the bid award;

14 “(D) for a route that receives funding from
15 a State or States, require that for each bid re-
16 ceived from a party described in paragraph (2),
17 other than a State, the Secretary have the con-
18 currence of the State or States that provide fund-
19 ing for that route;

20 “(E) for a winning bidder that is not or
21 does not include Amtrak, require the Secretary to
22 execute a contract not later than 270 days after
23 the deadline established under subparagraph
24 (B)(ii) and award to the winning bidder—

1 “(i) subject to paragraphs (3) and (4),
2 the right and obligation to provide intercity
3 rail passenger transportation over that
4 route subject to such performance standards
5 as the Secretary may require; and

6 “(ii) an operating subsidy, as deter-
7 mined by the Secretary, for—

8 “(I) the first year at a level that
9 does not exceed 90 percent of the level
10 in effect for that specific route during
11 the fiscal year preceding the fiscal year
12 in which the petition was received, ad-
13 justed for inflation; and

14 “(II) any subsequent years at the
15 level calculated under subclause (I),
16 adjusted for inflation; and

17 “(F) for a winning bidder that is or in-
18 cludes Amtrak, award to that bidder an oper-
19 ating subsidy, as determined by the Secretary,
20 over the applicable route that will not change
21 during the fiscal year in which the bid was sub-
22 mitted solely as a result of the winning bid.

23 “(2) *ELIGIBLE PETITIONERS.*—The following
24 parties are eligible to submit petitions under para-
25 graph (1):

1 “(A) A rail carrier or rail carriers that own
2 the infrastructure over which Amtrak operates a
3 long-distance route.

4 “(B) A rail passenger carrier with a writ-
5 ten agreement with the rail carrier or rail car-
6 riers that own the infrastructure over which Am-
7 trak operates a long-distance route and that host
8 or would host the intercity rail passenger trans-
9 portation.

10 “(C) A State, group of States, or State-sup-
11 ported joint powers authority or other sub-State
12 governance entity responsible for provision of
13 intercity rail passenger transportation with a
14 written agreement with the rail carrier or rail
15 carriers that own the infrastructure over which
16 Amtrak operates a long-distance route and that
17 host or would host the intercity rail passenger
18 transportation.

19 “(D) A State, group of States, or State-sup-
20 ported joint powers authority or other sub-State
21 governance entity responsible for provision of
22 intercity rail passenger transportation and a
23 rail passenger carrier with a written agreement
24 with the rail carrier or rail carriers that own the
25 infrastructure over which Amtrak operates a

1 *long-distance route and that host or would host*
2 *the intercity rail passenger transportation.*

3 “(3) *PERFORMANCE STANDARDS.—If the win-*
4 *ning bidder under paragraph (1)(E)(i) is not or does*
5 *not include Amtrak, the performance standards shall*
6 *be consistent with the performance required of or*
7 *achieved by Amtrak on the applicable route during*
8 *the last fiscal year.*

9 “(4) *AGREEMENT GOVERNING ACCESS ISSUES.—*
10 *Unless the winning bidder already has applicable ac-*
11 *cess agreements in place or includes a rail carrier*
12 *that owns the infrastructure used in the operation of*
13 *the route, the winning bidder under paragraph*
14 *(1)(E)(i) shall enter into a written agreement gov-*
15 *erning access issues between the winning bidder and*
16 *the rail carrier or rail carriers that own the infra-*
17 *structure over which the winning bidder would oper-*
18 *ate and that host or would host the intercity rail pas-*
19 *senger transportation.*

20 “(c) *ACCESS TO FACILITIES; EMPLOYEES.—If the Sec-*
21 *retary awards the right and obligation to provide rail pas-*
22 *senger transportation over a route under this section to an*
23 *entity in lieu of Amtrak—*

24 “(1) *the Secretary shall require Amtrak to pro-*
25 *vide access to the Amtrak-owned reservation system,*

1 *stations, and facilities directly related to operations of*
2 *the awarded routes to the rail passenger carrier*
3 *awarded a contract under this section, in accordance*
4 *with subsection (g), as necessary to carry out the pur-*
5 *poses of this section;*

6 *“(2) an employee of any person, except for a*
7 *freight railroad or a person employed or contracted*
8 *by a freight railroad, used by such rail passenger car-*
9 *rier in the operation of a route under this section*
10 *shall be considered an employee of that rail passenger*
11 *carrier and subject to the applicable Federal laws and*
12 *regulations governing similar crafts or classes of em-*
13 *ployees of Amtrak; and*

14 *“(3) the winning bidder shall provide hiring*
15 *preference to qualified Amtrak employees displaced by*
16 *the award of the bid, consistent with the staffing plan*
17 *submitted by the bidder, and shall be subject to the*
18 *grant conditions under section 24405.*

19 *“(d) CESSATION OF SERVICE.—If a rail passenger car-*
20 *rier awarded a route under this section ceases to operate*
21 *the service or fails to fulfill an obligation under the contract*
22 *required under subsection (b)(1)(E), the Secretary shall take*
23 *any necessary action consistent with this title to enforce the*
24 *contract and ensure the continued provision of service, in-*
25 *cluding—*

1 “(1) the installment of an interim rail passenger
2 carrier;

3 “(2) providing to the interim rail passenger car-
4 rier under paragraph (1) an operating subsidy nec-
5 essary to provide service; and

6 “(3) rebidding the contract to operate the rail
7 passenger transportation.

8 “(e) BUDGET AUTHORITY.—

9 “(1) IN GENERAL.—The Secretary shall provide
10 to a winning bidder that is not or does not include
11 Amtrak and that is selected under this section any
12 appropriations withheld under section 101(c) of the
13 Railroad Reform, Enhancement, and Efficiency Act,
14 or any subsequent appropriation for the same pur-
15 pose, necessary to cover the operating subsidy de-
16 scribed in subsection (b)(1)(E)(ii).

17 “(2) AMTRAK.—If the Secretary selects a win-
18 ning bidder that is not or does not include Amtrak,
19 the Secretary may provide to Amtrak an appropriate
20 portion of the appropriations under section 101(a) of
21 the Railroad Reform, Enhancement, and Efficiency
22 Act, or any subsequent appropriation for the same
23 purpose, to cover any cost directly attributable to the
24 termination of Amtrak service on the route and any
25 indirect costs to Amtrak imposed on other Amtrak

1 routes as a result of losing service on the route oper-
2 ated by the winning bidder. Any amount provided by
3 the Secretary to Amtrak under this paragraph shall
4 not be deducted from or have any effect on the oper-
5 ating subsidy described in subsection (b)(1)(E)(ii).

6 “(f) *DEADLINE.*—If the Secretary does not promulgate
7 the final rule and implement the program before the dead-
8 line under subsection (a), the Secretary shall submit to the
9 Committee on Commerce, Science, and Transportation of
10 the Senate and the Committee on Transportation and In-
11 frastructure of the House of Representatives a letter, signed
12 by the Secretary and Administrator of the Federal Railroad
13 Administration, each month until the rule is complete, in-
14 cluding—

15 “(1) the reasons why the rule has not been
16 issued;

17 “(2) an updated staffing plan for completing the
18 rule as soon as feasible;

19 “(3) the contact information of the official that
20 will be overseeing the execution of the staffing plan;
21 and

22 “(4) the estimated date of completion of the rule.

23 “(g) *DISPUTES.*—If Amtrak and the rail passenger
24 carrier awarded a route under this section cannot agree
25 upon terms to carry out subsection (c)(1), and the Surface

1 *Transportation Board finds that access to Amtrak's facili-*
2 *ties or equipment, or the provision of services by Amtrak,*
3 *is necessary under subsection (c)(1) and that the operation*
4 *of Amtrak's other services will not be impaired thereby, the*
5 *Surface Transportation Board shall issue an order that the*
6 *facilities and equipment be made available, and that serv-*
7 *ices be provided, by Amtrak, and shall determine reasonable*
8 *compensation, liability, and other terms for use of the facili-*
9 *ties and equipment and provision of the services.*

10 “(h) *LIMITATION.*—Not more than 3 long-distance
11 routes may be selected under this section for operation by
12 a winning bidder that is not or does not include Amtrak.

13 “(i) *PRESERVATION OF RIGHT TO COMPETITION ON*
14 *STATE-SUPPORTED ROUTES.*—Nothing in this section shall
15 be construed as prohibiting a State from introducing com-
16 petition for intercity rail passenger transportation or serv-
17 ices on its State-supported route or routes.”.

18 “(b) *REPORT.*—Not later than 4 years after the date
19 of implementation of the pilot program under section 24711
20 of title 49, United States Code, and quadrennially there-
21 after until the pilot program is discontinued, the Secretary
22 shall submit to the Committee on Commerce, Science, and
23 Transportation of the Senate and the Committee on Trans-
24 portation and Infrastructure of the House of Representa-

1 *tives a report on the results on the pilot program to date*
2 *and any recommendations for further action.*

3 **SEC. 206. ROLLING STOCK PURCHASES.**

4 *(a) IN GENERAL.—Prior to entering into any contract*
5 *in excess of \$100,000,000 for rolling stock and locomotive*
6 *procurements Amtrak shall submit a business case analysis*
7 *to the Secretary, the Committee on Commerce, Science, and*
8 *Transportation and the Committee on Appropriations of*
9 *the Senate and the Committee on Transportation and In-*
10 *frastructure and the Committee on Appropriations of the*
11 *House of Representatives, on the utility of such procure-*
12 *ments.*

13 *(b) CONTENTS.—The business case analysis shall—*

14 *(1) include a cost and benefit comparison that*
15 *describes the total lifecycle costs and the anticipated*
16 *benefits related to revenue, operational efficiency, reli-*
17 *ability, and other factors;*

18 *(2) set forth the total payments by fiscal year;*

19 *(3) identify the specific source and amounts of*
20 *funding for each payment, including Federal funds,*
21 *State funds, Amtrak profits, Federal, State, or pri-*
22 *ivate loans or loan guarantees, and other funding;*

23 *(4) include an explanation of whether any pay-*
24 *ment under the contract will increase Amtrak's grant*
25 *request, as required under section 24318 of title 49,*

1 *United States Code, in that particular fiscal year;*
2 *and*

3 *(5) describe how Amtrak will adjust the procure-*
4 *ment if future funding is not available.*

5 *(c) RULE OF CONSTRUCTION.—Nothing in this section*
6 *shall be construed as requiring Amtrak to disclose confiden-*
7 *tial information regarding a potential vendor’s proposed*
8 *pricing or other sensitive business information prior to con-*
9 *tract execution.*

10 **SEC. 207. FOOD AND BEVERAGE POLICY.**

11 *(a) IN GENERAL.—Chapter 243, as amended in section*
12 *202 of this Act, is further amended by adding after section*
13 *24320 the following:*

14 **“§24321. Food and beverage reform**

15 *“(a) PLAN.—Not later than 90 days after the date of*
16 *enactment of the Railroad Reform, Enhancement, and Effi-*
17 *ciency Act, Amtrak shall develop and begin implementing*
18 *a plan to eliminate, not later than 4 years after the date*
19 *of enactment of that Act, the operating loss associated with*
20 *providing food and beverage service on board Amtrak*
21 *trains.*

22 *“(b) CONSIDERATIONS.—In developing and imple-*
23 *menting the plan under subsection (a), Amtrak shall con-*
24 *sider a combination of cost management and revenue gen-*
25 *eration initiatives, including—*

1 “(1) *scheduling optimization;*

2 “(2) *onboard logistics;*

3 “(3) *product development and supply chain effi-*
4 *ciency;*

5 “(4) *training, awards, and accountability;*

6 “(5) *technology enhancements and process im-*
7 *provements; and*

8 “(6) *ticket revenue allocation.*

9 “(c) *SAVINGS CLAUSE.—Amtrak shall ensure that no*
10 *Amtrak employee holding a position as of the date of enact-*
11 *ment of the Railroad Reform, Enhancement, and Efficiency*
12 *Act is involuntarily separated because of—*

13 “(1) *the development and implementation of the*
14 *plan required under subsection (a); or*

15 “(2) *any other action taken by Amtrak to imple-*
16 *ment this section.*

17 “(d) *NO FEDERAL FUNDING FOR OPERATING*
18 *LOSSES.—Beginning on the date that is 4 years after the*
19 *date of enactment of the Railroad Reform, Enhancement,*
20 *and Efficiency Act, no Federal funds may be used to cover*
21 *any operating loss associated with providing food and bev-*
22 *erage service on a route operated by Amtrak or an alter-*
23 *native passenger rail service provider that operates a route*
24 *in lieu of Amtrak under section 24711.*

1 “(e) *REPORT.*—Not later than 120 days after the date
 2 of enactment of the *Railroad Reform, Enhancement, and*
 3 *Efficiency Act*, and annually thereafter for a period of 4
 4 years, Amtrak shall transmit to the Committee on Com-
 5 merce, Science, and Transportation of the Senate and the
 6 Committee on Transportation and Infrastructure of the
 7 House of Representatives a report on the plan developed
 8 under subsection (a) and a description of progress in the
 9 implementation of the plan.”.

10 (b) *CONFORMING AMENDMENT.*—The table of contents
 11 for chapter 243, as amended in section 202 of this Act, is
 12 amended by adding at the end the following:

“24321. *Food and beverage reform.*”.

13 **SEC. 208. LOCAL PRODUCTS AND PROMOTIONAL EVENTS.**

14 (a) *IN GENERAL.*—Not later than 6 months after the
 15 date of enactment of this Act, Amtrak shall establish a pilot
 16 program for a State or States that sponsor a State-sup-
 17 ported route operated by Amtrak to facilitate—

18 (1) onboard purchase and sale of local food and
 19 beverage products; and

20 (2) partnerships with local entities to hold pro-
 21 motional events on trains or in stations.

22 (b) *PROGRAM DESIGN.*—The pilot program under
 23 paragraph (1) shall allow a State or States—

1 (1) to nominate and select a local food and bev-
2 erage products supplier or suppliers or local pro-
3 motional event partner;

4 (2) to charge a reasonable price or fee for local
5 food and beverage products or promotional events and
6 related activities to help defray the costs of program
7 administration and State-supported routes; and

8 (3) a mechanism to ensure that State products
9 can effectively be handled and integrated into existing
10 food and beverage services, including compliance with
11 all applicable regulations and standards governing
12 such services.

13 (c) *PROGRAM ADMINISTRATION.*—The pilot program
14 shall—

15 (1) for local food and beverage products, ensure
16 the products are integrated into existing food and bev-
17 erage services, including compliance with all applica-
18 ble regulations and standards;

19 (2) for promotional events, ensure the events are
20 held in compliance with all applicable regulations
21 and standards, including terms to address insurance
22 requirements; and

23 (3) require an annual report that documents rev-
24 enues and costs and indicates whether the products or
25 events resulted in a reduction in the financial con-

1 *tribution of a State or States to the applicable State-*
2 *supported route.*

3 *(d) REPORT.—Not later than 4 years after the date*
4 *of establishment of the pilot programs under this section,*
5 *Amtrak shall report to the Committee on Commerce,*
6 *Science, and Transportation of the Senate and the Com-*
7 *mittee on Transportation and Infrastructure of the House*
8 *of Representatives on which States have participated in the*
9 *pilot programs under this section. The report shall summa-*
10 *rize the financial and operational outcomes of the pilot pro-*
11 *grams.*

12 *(e) RULE OF CONSTRUCTION.—Nothing in this sub-*
13 *section shall be construed as limiting Amtrak’s ability to*
14 *operate special trains in accordance with section 216 of the*
15 *Passenger Rail Investment and Improvement Act of 2008*
16 *(49 U.S.C. 24308 note).*

17 **SEC. 209. RIGHT-OF-WAY LEVERAGING.**

18 *(a) REQUEST FOR PROPOSALS.—*

19 *(1) IN GENERAL.—Not later than 1 year after*
20 *the date of enactment of this Act, Amtrak shall issue*
21 *a Request for Proposals seeking qualified persons or*
22 *entities to utilize right-of-way and real estate owned,*
23 *controlled, or managed by Amtrak for telecommuni-*
24 *cations systems, energy distribution systems, and*
25 *other activities considered appropriate by Amtrak.*

1 (2) *CONTENTS.*—*The Request for Proposals shall*
2 *provide sufficient information on the right-of-way*
3 *and real estate assets to enable respondents to propose*
4 *an arrangement that will monetize or generate addi-*
5 *tional revenue from such assets through revenue shar-*
6 *ing or leasing agreements with Amtrak, to the extent*
7 *possible.*

8 (b) *CONSIDERATION OF PROPOSALS.*—*Not later than*
9 *180 days following the deadline for the receipt of proposals*
10 *under subsection (a), Amtrak shall review and consider each*
11 *qualified proposal. Amtrak may enter into such agreements*
12 *as are necessary to implement any qualified proposal.*

13 (c) *REPORT.*—*Not later than 270 days following the*
14 *deadline for the receipt of proposals under subsection (a),*
15 *Amtrak shall transmit to the Committee on Commerce,*
16 *Science, and Transportation of the Senate and the Com-*
17 *mittee on Transportation and Infrastructure of the House*
18 *of Representatives a report on the Request for Proposals re-*
19 *quired by this section, including summary information of*
20 *any proposals submitted to Amtrak and any proposals ac-*
21 *cepted by Amtrak.*

22 (d) *SAVINGS CLAUSE.*—*Nothing in this section shall*
23 *be construed to limit Amtrak's ability to utilize right-of-*
24 *way or real estate assets that it currently owns, controls,*

1 *or manages or constrain Amtrak's ability to enter into*
2 *agreements with other parties to utilize such assets.*

3 **SEC. 210. STATION DEVELOPMENT.**

4 *(a) REPORT ON DEVELOPMENT OPTIONS.—Not later*
5 *than 1 year after the date of the enactment of this Act, Am-*
6 *trak shall submit a report to the Committee on Commerce,*
7 *Science, and Transportation of the Senate and the Com-*
8 *mittee on Transportation and Infrastructure of the House*
9 *of Representatives that describes—*

10 *(1) options to enhance economic development and*
11 *accessibility of and around Amtrak stations and ter-*
12 *minals, for the purposes of—*

13 *(A) improving station condition,*
14 *functionality, capacity, and customer amenities;*

15 *(B) generating additional investment cap-*
16 *ital and development-related revenue streams;*

17 *(C) increasing ridership and revenue;*

18 *(D) complying with the applicable sections*
19 *of the Americans with Disabilities Act of 1990*
20 *(42 U.S.C. 12101 et seq.) and the Rehabilitation*
21 *Act of 1973 (29 U.S.C. 701 et seq.); and*

22 *(E) strengthening multimodal connections,*
23 *including transit, intercity buses, roll-on and*
24 *roll-off bicycles, and airports, as appropriate;*
25 *and*

1 (2) *options for additional Amtrak stops that*
2 *would have a positive incremental financial impact*
3 *to Amtrak, based on Amtrak feasibility studies that*
4 *demonstrate a financial benefit to Amtrak by gener-*
5 *ating additional revenue that exceeds any incremental*
6 *costs.*

7 (b) *REQUEST FOR INFORMATION.—Not later than 90*
8 *days after the date the report is transmitted under sub-*
9 *section (a), Amtrak shall issue a Request of Information*
10 *for 1 or more owners of stations served by Amtrak to for-*
11 *mally express an interest in completing the requirements*
12 *of this section.*

13 (c) *PROPOSALS.—*

14 (1) *REQUEST FOR PROPOSALS.—Not later than*
15 *180 days after the date the Request for Information*
16 *is issued under subsection (a), Amtrak shall issue a*
17 *Request for Proposals from qualified persons, includ-*
18 *ing small business concerns owned and controlled by*
19 *socially and economically disadvantaged individuals*
20 *and veteran-owned small businesses, to lead, partici-*
21 *pate, or partner with Amtrak, a station owner that*
22 *responded under subsection (b), and other entities in*
23 *enhancing development in and around such stations*
24 *and terminals using applicable options identified*
25 *under subsection (a) at facilities selected by Amtrak.*

1 (2) *CONSIDERATION OF PROPOSALS.*—Not later
2 than 1 year after the date the Request for Proposals
3 are issued under paragraph (1), Amtrak shall review
4 and consider qualified proposals submitted under
5 paragraph (1). Amtrak or a station owner that re-
6 sponded under subsection (b) may enter into such
7 agreements as are necessary to implement any quali-
8 fied proposal.

9 (d) *REPORT.*—Not later than 3 years after the date
10 of enactment of this Act, Amtrak shall transmit to the Com-
11 mittee on Commerce, Science, and Transportation of the
12 Senate and the Committee on Transportation and Infra-
13 structure of the House of Representatives a report on the
14 Request for Proposals process required under this section,
15 including summary information of any qualified proposals
16 submitted to Amtrak and any proposals acted upon by Am-
17 trak or a station owner that responded under subsection (b).

18 (e) *DEFINITIONS.*—In this section, the terms “small
19 business concern”, “socially and economically disadvan-
20 taged individual”, and “veteran-owned small business”
21 have the meanings given the terms in section 304(c) of this
22 Act.

23 (f) *SAVINGS CLAUSE.*—Nothing in this section shall be
24 construed to limit Amtrak’s ability to develop its stations,
25 terminals, or other assets, to constrain Amtrak’s ability to

1 *enter into and carry out agreements with other parties to*
 2 *enhance development at or around Amtrak stations or ter-*
 3 *minals, or to affect any station development initiatives on-*
 4 *going as of the date of enactment of this Act.*

5 **SEC. 211. AMTRAK DEBT.**

6 *Section 205 of the Passenger Rail Investment and Im-*
 7 *provement Act of 2008 (49 U.S.C. 24101 note) is amend-*
 8 *ed—*

9 *(1) by striking “as of the date of enactment of*
 10 *this Act” each place it appears;*

11 *(2) in subsection (a)—*

12 *(A) by inserting “, to the extent provided in*
 13 *advance in appropriations Acts” after “Amtrak’s*
 14 *indebtedness”; and*

15 *(B) by striking the second sentence;*

16 *(3) in subsection (b), by striking “The Secretary*
 17 *of the Treasury, in consultation” and inserting “To*
 18 *the extent amounts are provided in advance in appro-*
 19 *priations Acts, the Secretary of the Treasury, in con-*
 20 *sultation”;*

21 *(4) in subsection (d), by inserting “, to the extent*
 22 *provided in advance in appropriations Acts” after*
 23 *“as appropriate”;*

24 *(5) in subsection (e)—*

1 (A) in paragraph (1), by striking “by sec-
2 tion 102 of this division”; and

3 (B) in paragraph (2), by striking “by sec-
4 tion 102” and inserting “for Amtrak”;

5 (6) in subsection (g), by inserting “, unless that
6 debt receives credit assistance, including direct loans
7 and loan guarantees, under chapter 6 of title 23,
8 United States Code or title V of the Railroad Revital-
9 ization and Regulatory Act of 1976 (45 U.S.C. 821
10 et seq.)” after “Secretary”; and

11 (7) by striking subsection (h).

12 **SEC. 212. AMTRAK PILOT PROGRAM FOR PASSENGERS**
13 **TRANSPORTING DOMESTICATED CATS AND**
14 **DOGS.**

15 (a) *IN GENERAL.*—Not later than 1 year after the date
16 of enactment of this Act, Amtrak shall develop a pilot pro-
17 gram that allows passengers to transport domesticated cats
18 or dogs on certain trains operated by Amtrak.

19 (b) *PET POLICY.*—In developing the pilot program re-
20 quired under subsection (a), Amtrak shall—

21 (1) in the case of a passenger train that is com-
22 prised of more than 1 car, designate, where feasible,
23 at least 1 car in which a ticketed passenger may
24 transport a domesticated cat or dog in the same man-
25 ner as carry-on baggage if—

1 (A) the cat or dog is contained in a pet ken-
2 nel;

3 (B) the pet kennel complies with Amtrak
4 size requirements for carriage of carry-on bag-
5 gage;

6 (C) the passenger is traveling on a train op-
7 erating on a route described in subparagraph
8 (A), (B), or (D) of section 24102(6) of title 49,
9 United States Code; and

10 (D) the passenger pays a fee described in
11 paragraph (3);

12 (2) allow a ticketed passenger to transport a do-
13 mesticated cat or dog on a train in the same manner
14 as cargo if—

15 (A) the cat or dog is contained in a pet ken-
16 nel;

17 (B) the pet kennel is stowed in accordance
18 with Amtrak requirements for cargo stowage;

19 (C) the passenger is traveling on a train op-
20 erating on a route described in subparagraph
21 (A), (B), or (D) of section 24102(6) of title 49,
22 United States Code;

23 (D) the cargo area is temperature controlled
24 in a manner protective of cat and dog safety and
25 health; and

1 (E) the passenger pays a fee described in
2 paragraph (3); and

3 (3) collect fees for each cat or dog transported by
4 a ticketed passenger in an amount that, in the aggregate
5 and at a minimum, covers the full costs of the
6 pilot program.

7 (c) *REPORT.*—Not later than 1 year after the pilot pro-
8 gram required under subsection (a) is first implemented,
9 Amtrak shall transmit to the Committee on Commerce,
10 Science, and Transportation of the Senate and the Com-
11 mittee on Transportation and Infrastructure of the House
12 of Representatives a report containing an evaluation of the
13 pilot program.

14 (d) *LIMITATION ON STATUTORY CONSTRUCTION.*—

15 (1) *SERVICE ANIMALS.*—The pilot program
16 under subsection (a) shall be separate from and in
17 addition to the policy governing Amtrak passengers
18 traveling with service animals. Nothing in this sec-
19 tion may be interpreted to limit or waive the rights
20 of passengers to transport service animals.

21 (2) *ADDITIONAL TRAIN CARS.*—Nothing in this
22 section may be interpreted to require Amtrak to add
23 additional train cars or modify existing train cars.

1 (3) *FEDERAL FUNDS.*—No Federal funds may be
2 used to implement the pilot program required under
3 this section.

4 **SEC. 213. AMTRAK BOARD OF DIRECTORS.**

5 (a) *IN GENERAL.*—Section 24302(a) is amended to
6 read as follows:

7 “(a) *COMPOSITION AND TERMS.*—

8 “(1) *IN GENERAL.*—The Amtrak Board of Direc-
9 tors (referred to in this section as the ‘Board’) is com-
10 posed of the following 9 directors, each of whom must
11 be a citizen of the United States:

12 “(A) *The Secretary of Transportation.*

13 “(B) *The President of Amtrak.*

14 “(C) *7 individuals appointed by the Presi-*
15 *dent of the United States, by and with the advice*
16 *and consent of the Senate, with general business*
17 *and financial experience, experience or qualifica-*
18 *tions in transportation, freight and passenger*
19 *rail transportation, travel, hospitality, or pas-*
20 *senger air transportation businesses, or rep-*
21 *resentatives of employees or users of passenger*
22 *rail transportation or a State government.*

23 “(2) *SELECTION.*—In selecting individuals de-
24 scribed in paragraph (1)(C) for nominations for ap-
25 pointments to the Board, the President shall consult

1 *with the Speaker of the House of Representatives, the*
2 *minority leader of the House of Representatives, the*
3 *majority leader of the Senate, and the minority leader*
4 *of the Senate. The individuals appointed to the Board*
5 *under paragraph (1)(C) shall be composed of the fol-*
6 *lowing;*

7 “(A) 2 individuals from the Northeast Cor-

8 ridor.

9 “(B) 4 individuals from regions of the coun-

10 try outside of the Northeast Corridor and geo-

11 graphically distributed with—

12 “(i) 2 individuals from States with

13 long-distance routes operated by Amtrak;

14 and

15 “(ii) 2 individuals from States with

16 State-supported routes operated by Amtrak.

17 “(C) 1 individual from the Northeast Cor-

18 ridor or a State with long-distance or State-sup-

19 ported routes.

20 “(3) *TERM.*—An individual appointed under

21 paragraph (1)(C) shall be appointed for a term of 5

22 years. The term may be extended until the individ-

23 ual’s successor is appointed and qualified. Not more

24 than 4 individuals appointed under paragraph (1)(C)

25 may be members of the same political party.

1 “(4) *CHAIRPERSON AND VICE CHAIRPERSON.*—
 2 *The Board shall elect a chairperson and vice chair-*
 3 *person, other than the President of Amtrak, from*
 4 *among its membership. The vice chairperson shall*
 5 *serve as chairperson in the absence of the chairperson.*

6 “(5) *SECRETARY’S DESIGNEE.*—*The Secretary*
 7 *may be represented at Board meetings by the Sec-*
 8 *retary’s designee.”.*

9 **(b) *RULE OF CONSTRUCTION.***—*Nothing in this section*
 10 *shall be construed as affecting the term of any director serv-*
 11 *ing on the Amtrak Board of Directors under section*
 12 *24302(a)(1)(C) of title 49, United States Code, on the day*
 13 *preceding the date of enactment of this Act.*

14 **TITLE III—INTERCITY**
 15 **PASSENGER RAIL POLICY**

16 **SEC. 301. COMPETITIVE OPERATING GRANTS.**

17 **(a) *IN GENERAL.***—*Chapter 244 is amended—*

18 **(1)** *by striking section 24406; and*

19 **(2)** *by inserting after section 24405 the fol-*
 20 *lowing:*

21 **“§24406. Competitive operating grants**

22 **“(a) *APPLICANT DEFINED.***—*In this section, the term*
 23 *‘applicant’ means—*

24 **“(1)** *a State;*

25 **“(2)** *a group of States;*

1 “(3) *an Interstate Compact;*

2 “(4) *a public agency or publicly chartered au-*
3 *thority established by 1 or more States and having re-*
4 *sponsibility for providing intercity rail passenger*
5 *transportation or commuter rail passenger transpor-*
6 *tation;*

7 “(5) *a political subdivision of a State;*

8 “(6) *Amtrak or another rail passenger carrier*
9 *that provides intercity rail passenger transportation;*

10 “(7) *Any rail carrier in partnership with at*
11 *least 1 of the entities described in paragraphs (1)*
12 *through (5); and*

13 “(8) *any combination of the entities described in*
14 *paragraphs (1) through (7).*

15 “(b) *GRANTS AUTHORIZED.—The Secretary of Trans-*
16 *portation shall develop and implement a program for*
17 *issuing 3-year operating assistance grants to applicants, on*
18 *a competitive basis, for the purpose of initiating, restoring,*
19 *or enhancing intercity rail passenger service.*

20 “(c) *APPLICATION.—An applicant for a grant under*
21 *this section shall submit to the Secretary—*

22 “(1) *a capital and mobilization plan that—*

23 “(A) *describes any capital investments,*
24 *service planning actions (such as environmental*
25 *reviews), and mobilization actions (such as qual-*

1 *ification of train crews) required for initiation*
2 *of service; and*

3 *“(B) includes the timeline for undertaking*
4 *and completing each of the investments and ac-*
5 *tions referred to in subparagraph (A);*

6 *“(2) an operating plan that describes the*
7 *planned operation of the service, including—*

8 *“(A) the identity and qualifications of the*
9 *train operator;*

10 *“(B) the identity and qualifications of any*
11 *other service providers;*

12 *“(C) service frequency;*

13 *“(D) the planned routes and schedules;*

14 *“(E) the station facilities that will be uti-*
15 *lized;*

16 *“(F) projected ridership, revenues, and*
17 *costs;*

18 *“(G) descriptions of how the projections*
19 *under subparagraph (F) were developed;*

20 *“(H) the equipment that will be utilized,*
21 *how such equipment will be acquired or refur-*
22 *bished, and where such equipment will be main-*
23 *tained; and*

24 *“(I) a plan for ensuring safe operations and*
25 *compliance with applicable safety regulations;*

1 “(3) a funding plan that—

2 “(A) describes the funding of initial capital
3 costs and operating costs for the first 3 years of
4 operation;

5 “(B) includes a commitment by the appli-
6 cant to provide the funds described in subpara-
7 graph (A) to the extent not covered by Federal
8 grants and revenues; and

9 “(C) describes the funding of operating costs
10 and capital costs, to the extent necessary, after
11 the first 3 years of operation; and

12 “(4) a description of the status of negotiations
13 and agreements with—

14 “(A) each of the railroads or regional trans-
15 portation authorities whose tracks or facilities
16 would be utilized by the service;

17 “(B) the anticipated rail passenger carrier,
18 if such entity is not part of the applicant group;
19 and

20 “(C) any other service providers or entities
21 expected to provide services or facilities that will
22 be used by the service, including any required
23 access to Amtrak systems, stations, and facilities
24 if Amtrak is not part of the applicant group.

1 “(d) *PRIORITIES.*—*In awarding grants under this sec-*
2 *tion, the Secretary shall give priority to applications—*

3 “(1) *for which planning, design, any environ-*
4 *mental reviews, negotiation of agreements, acquisition*
5 *of equipment, construction, and other actions nec-*
6 *essary for initiation of service have been completed or*
7 *nearly completed;*

8 “(2) *that would restore service over routes for-*
9 *merly operated by Amtrak, including routes with*
10 *international connections;*

11 “(3) *that would provide daily or daytime service*
12 *over routes where such service did not previously*
13 *exist;*

14 “(4) *that include private funding (including*
15 *funding from railroads), and funding or other signifi-*
16 *cant participation by State, local, and regional gov-*
17 *ernmental and private entities;*

18 “(5) *that include a funding plan that dem-*
19 *onstrates the intercity rail passenger service will be*
20 *financially sustainable beyond the 3-year grant pe-*
21 *riod;*

22 “(6) *that would provide service to regions and*
23 *communities that are underserved or not served by*
24 *other intercity public transportation;*

1 “(7) that would foster economic development,
2 particularly in rural communities and for disadvan-
3 taged populations;

4 “(8) that would provide other non-transportation
5 benefits; and

6 “(9) that would enhance connectivity and geo-
7 graphic coverage of the existing national network of
8 intercity passenger rail service.

9 “(e) *LIMITATIONS.*—

10 “(1) *DURATION.*—Federal operating assistance
11 grants authorized under this section for any indi-
12 vidual intercity rail passenger transportation route
13 may not provide funding for more than 3 years and
14 may not be renewed.

15 “(2) *LIMITATION.*—Not more than 6 of the oper-
16 ating assistance grants awarded pursuant to sub-
17 section (b) may be simultaneously active.

18 “(3) *MAXIMUM FUNDING.*—Grants described in
19 paragraph (1) may not exceed—

20 “(A) 80 percent of the projected net oper-
21 ating costs for the first year of service;

22 “(B) 60 percent of the projected net oper-
23 ating costs for the second year of service; and

24 “(C) 40 percent of the projected net oper-
25 ating costs for the third year of service.

1 “(f) *USE WITH CAPITAL GRANTS AND OTHER FED-*
2 *ERAL FUNDING.*—A recipient of an operating assistance
3 grant under subsection (b) may use that grant in combina-
4 tion with other grants awarded under this chapter or any
5 other Federal funding that would benefit the applicable
6 service.

7 “(g) *AVAILABILITY.*—Amounts appropriated for car-
8 rying out this section shall remain available until ex-
9 pended.

10 “(h) *COORDINATION WITH AMTRAK.*—If the Secretary
11 awards a grant under this section to a rail passenger car-
12 rier other than Amtrak, Amtrak may be required under sec-
13 tion 24711(c)(1) of this title to provide access to its reserva-
14 tion system, stations, and facilities that are directly related
15 to operations to such carrier, to the extent necessary to
16 carry out the purposes of this section. The Secretary may
17 award an appropriate portion of the grant to Amtrak as
18 compensation for this access.

19 “(i) *CONDITIONS.*—

20 “(1) *GRANT AGREEMENT.*—The Secretary shall
21 require grant recipients under this section to enter
22 into a grant agreement that requires them to provide
23 similar information regarding the route performance,
24 financial, and ridership projections, and capital and
25 business plans that Amtrak is required to provide,

1 *and such other data and information as the Secretary*
2 *deems necessary.*

3 “(2) *INSTALLMENTS; TERMINATION.*—*The Sec-*
4 *retary may—*

5 “(A) *award grants under this section in in-*
6 *stallments, as the Secretary considers appro-*
7 *priate; and*

8 “(B) *terminate any grant agreement*
9 *upon—*

10 “(i) *the cessation of service; or*

11 “(ii) *the violation of any other term of*
12 *the grant agreement.*

13 “(3) *GRANT CONDITIONS.*—*Except as specifically*
14 *provided in this section, the use of any amounts ap-*
15 *propriated for grants under this section shall be sub-*
16 *ject to the requirements under this chapter.*

17 “(j) *REPORT.*—*Not later than 4 years after the date*
18 *of enactment of the Railroad Reform, Enhancement, and*
19 *Efficiency Act, the Secretary, after consultation with grant*
20 *recipients under this section, shall submit a report to Con-*
21 *gress that describes—*

22 “(1) *the implementation of this section;*

23 “(2) *the status of the investments and operations*
24 *funded by such grants;*

1 “(3) the performance of the routes funded by
2 such grants;

3 “(4) the plans of grant recipients for continued
4 operation and funding of such routes; and

5 “(5) any legislative recommendations.”.

6 (b) *CONFORMING AMENDMENTS.*—Chapter 244 is
7 amended—

8 (1) in the table of contents, by inserting after the
9 item relating to section 24405 the following:

“24406. *Competitive operating grants.*”;

10 (2) in the chapter title, by striking “**INTER-**
11 **CITY PASSENGER RAIL SERVICE COR-**
12 **RIDOR CAPITAL**” and inserting “**RAIL CAP-**
13 **ITAL AND OPERATING**”;

14 (3) in section 24401—

15 (A) by striking paragraph (1); and

15 project’ means—

20 stations, and other assets, as determined by the
21 Secretary; or

22 “(B) a project primarily intended to im-

8 “(B) *the branch rail lines connecting to*

14 *vate sector participation in the financing, con-*
15 *struction, or operation of the proposed project;*

16 “(C) *the applicant’s past performance in*
17 *developing and delivering similar projects, and*
18 *previous financial contributions;*

19 “(D) *whether the applicant has, or will*
20 *have—*

21 “(i) *the legal, financial, and technical*
22 *capacity to carry out the project;*

23 “(ii) *satisfactory continuing control*
24 *over the use of the equipment or facilities;*
25 *and*

1 “(iii) *the capability and willingness to*
2 *maintain the equipment or facilities;*

3 “(E) *if applicable, the consistency of the*
4 *project with planning guidance and documents*
5 *set forth by the Secretary or required by law;*
6 *and*

7 “(F) *any other relevant factors, as deter-*
8 *mined by the Secretary.*

9 “(e) *PLANNING REQUIREMENTS.—A project is not eli-*
10 *gible for a grant under this section unless the project is spe-*
11 *cifically identified—*

12 “(1) *on a State rail plan prepared in accordance*
13 *with chapter 227; or*

14 “(2) *if the project is located on the Northeast*
15 *Corridor, on the Northeast Corridor Capital Invest-*
16 *ment Plan developed pursuant to section 24904(a).*

17 “(f) *NORTHEAST CORRIDOR PROJECTS.—*

18 “(1) *COMPLIANCE WITH USAGE AGREEMENTS.—*
19 *Grant funds may not be provided under this section*
20 *to an eligible recipient for an eligible project located*
21 *on the Northeast Corridor unless Amtrak and the*
22 *public authorities providing commuter rail passenger*
23 *transportation on the Northeast Corridor are in com-*

18 *economically disadvantaged individuals for purposes*
19 *of this section.*

20 (3) *VETERAN-OWNED SMALL BUSINESS.*—*The*
21 *term “veteran-owned small business” has the meaning*
22 *given the term “small business concern owned and*
23 *controlled by veterans” in section 3(q)(3) of the Small*
24 *Business Act (15 U.S.C. 632(q)(3)), except that the*
25 *term does not include any concern or group of con-*

1 *cerns controlled by the same veterans that have aver-*
2 *age annual gross receipts during the preceding 3 fis-*
3 *cal years in excess of \$22,410,000, as adjusted annu-*
4 *ally by the Secretary for inflation.*

5 **SEC. 305. GULF COAST RAIL SERVICE WORKING GROUP.**

6 *(a) IN GENERAL.—Not later than 90 days after the*
7 *date of enactment of this Act, the Secretary shall convene*
8 *a working group to evaluate the restoration of intercity rail*
9 *passenger service in the Gulf Coast region between New Or-*
10 *leans, Louisiana, and Orlando, Florida.*

12 *suant to subsection (a) shall consist of representatives of—*

14 *shall serve as chair of the working group;*

17 *(4) regional transportation planning organiza-*
18 *tions and metropolitan planning organizations, mu-*

20 *route or routes, which shall be selected by the Admin-*
21 *istrator;*

22 *(5) the Southern Rail Commission;*

23 *(6) freight railroad carriers whose tracks may be*
24 *used for such service; and*

1 (7) *other entities determined appropriate by the*
2 *Secretary, which may include independent passenger*
3 *rail operators that express an interest in Gulf Coast*
4 *service.*

5 (c) *RESPONSIBILITIES.—The working group shall—*

6 (1) *evaluate all options for restoring intercity*
7 *rail passenger service in the Gulf Coast region, in-*
8 *cluding options outlined in the report transmitted to*
9 *Congress pursuant to section 226 of the Passenger*
10 *Rail Investment and Improvement Act of 2008 (divi-*
11 *sion B of Public Law 110–432);*

12 (2) *select a preferred option for restoring such*
13 *service;*

14 (3) *develop a prioritized inventory of capital*
15 *projects and other actions required to restore such*
16 *service and cost estimates for such projects or actions;*
17 *and*

18 (4) *identify Federal and non-Federal funding*
19 *sources required to restore such service, including op-*
20 *tions for entering into public-private partnerships to*
21 *restore such service.*

22 (d) *REPORT.—Not later than 9 months after the date*
23 *of enactment of this Act, the working group shall submit*
24 *a report to the Committee on Commerce, Science, and*
25 *Transportation of the Senate and the Committee on Trans-*

1 *portation and Infrastructure of the House of Representa-*
 2 *tives that includes—*

3 (1) *the preferred option selected under subsection*
 4 *(c)(2) and the reasons for selecting such option;*

5 (2) *the information described in subsection*
 6 *(c)(3);*

7 (3) *the funding sources identified under sub-*
 8 *section (c)(4);*

9 (4) *the costs and benefits of restoring intercity*
 10 *rail passenger transportation in the region; and*

11 (5) *any other information the working group de-*
 12 *termines appropriate.*

13 **SEC. 306. INTEGRATED PASSENGER RAIL WORKING GROUP.**

14 (a) *IN GENERAL.*—*Not later than 180 days after the*
 15 *date of enactment of this Act, the Secretary shall convene*
 16 *a working group to review issues relating to—*

17 (1) *the potential operation of State-supported*
 18 *routes by rail passenger carriers other than Amtrak;*
 19 *and*

20 (2) *their role in establishing an integrated inter-*
 21 *city passenger rail network in the United States.*

22 (b) *MEMBERSHIP.*—*The working group shall consist of*
 23 *a balanced representation of—*

24 (1) *the Federal Railroad Administration, who*
 25 *shall chair the Working Group;*

- 1 (2) *States that fund State-sponsored routes;*
- 2 (3) *independent passenger rail operators, includ-*
3 *ing those that carry at least 5,000,000 passengers an-*
4 *nually in United States or international rail service;*
- 5 (4) *Amtrak;*
- 6 (5) *railroads that host intercity State-supported*
7 *routes;*
- 8 (6) *employee representatives from railroad*
9 *unions and building trade unions with substantial*
10 *engagement in railroad rights of way construction*
11 *and maintenance; and*
- 12 (7) *other entities determined appropriate by the*
13 *Secretary.*

14 (c) *RESPONSIBILITIES.—The working group shall*
15 *evaluate options for improving State-supported routes and*
16 *may make recommendations, as appropriate, regarding—*

- 17 (1) *best practices for State or State authority*
18 *governance of State-supported routes;*
- 19 (2) *future sources of Federal and non-Federal*
20 *funding sources for State-supported routes;*
- 21 (3) *best practices in obtaining passenger rail op-*
22 *erations and services on a competitive basis with the*
23 *objective of creating the highest quality service at the*
24 *lowest cost to the taxpayer;*

1 (4) *ensuring potential interoperability of State-*
2 *supported routes as a part of a national network with*
3 *multiple providers providing integrated services in-*
4 *cluding ticketing, scheduling, and route planning;*
5 *and*

6 (5) *the interface between State-supported routes*
7 *and connecting commuter rail operations, including*
8 *maximized intra-modal and intermodal connections*
9 *and common sources of funding for capital projects.*

10 (d) *MEETINGS.*—*Not later than 60 days after the es-*
11 *tablishment of the working group by the Secretary under*
12 *subsection (a), the working group shall convene an organi-*
13 *zational meeting outside of the District of Columbia and*
14 *shall define the rules and procedures governing the pro-*
15 *ceedings of the working group. The working group shall hold*
16 *at least 3 meetings per year in States that fund State-sup-*
17 *ported routes.*

18 (e) *REPORTS.*—

19 (1) *PRELIMINARY REPORT.*—*Not later than 1*
20 *year after the date the working group is established,*
21 *the working group shall submit a preliminary report*
22 *to the Secretary, the Governors of States funding*
23 *State-supported routes, the Committee on Commerce,*
24 *Science, and Transportation of the Senate, and the*

1 *Committee on Transportation and Infrastructure of*
2 *the House of Representatives that includes—*

3 *(A) administrative recommendations that*
4 *can be implemented by a State and State au-*
5 *thority or by the Secretary; and*

6 *(B) preliminary legislative recommenda-*
7 *tions.*

8 *(2) FINAL LEGISLATIVE RECOMMENDATIONS.—*
9 *Not later than 2 years after the date the working*
10 *group is established, the working group shall submit*
11 *a report to the Committee on Commerce, Science, and*
12 *Transportation of the Senate and the Committee on*
13 *Transportation and Infrastructure of the House of*
14 *Representatives that includes final legislative rec-*
15 *ommendations.*

16 **SEC. 307. SHARED-USE STUDY.**

17 *(a) IN GENERAL.—Not later than 3 years after the*
18 *date of enactment of this Act, the Secretary, in consultation*
19 *with Amtrak, commuter rail authorities, and other pas-*
20 *senger rail operators, railroad carriers that own rail infra-*
21 *structure over which both passenger and freight trains oper-*
22 *ate, States, the Surface Transportation Board, the North-*
23 *east Corridor Commission established under section 24905,*
24 *the State-Supported Route Committee established under sec-*
25 *tion 24712, and groups representing rail passengers and*

1 *customers, as appropriate, shall complete a study that eval-*
2 *uates—*

3 *(1) the shared use of right-of-way by passenger*
4 *and freight rail systems; and*

5 *(2) the operational, institutional, and legal*
6 *structures that would best support improvements to*
7 *the systems referred to in paragraph (1).*

8 *(b) AREAS OF STUDY.—In conducting the study under*
9 *subsection (a), the Secretary shall evaluate—*

10 *(1) the access and use of railroad right-of-way by*
11 *a rail carrier that does not own the right-of-way, such*
12 *as passenger rail services that operate over privately-*
13 *owned right-of-way, including an analysis of—*

14 *(A) access agreements;*

15 *(B) costs of access; and*

16 *(C) the resolution of disputes relating to*
17 *such access or costs;*

18 *(2) the effectiveness of existing contractual, statu-*
19 *tory, and regulatory mechanisms for establishing,*
20 *measuring, and enforcing train performance stand-*
21 *ards, including—*

22 *(A) the manner in which passenger train*
23 *delays are recorded;*

24 *(B) the assignment of responsibility for such*
25 *delays; and*

1 (C) the use of incentives and penalties for
2 performance;

2 *ing intercity passenger rail service, proposals shall*
3 *also be designed to achieve a reduction of existing*
4 *minimum intercity rail service trip times between the*
5 *main corridor city pairs by a minimum of 25 per-*
6 *cent. In the case of a proposal submitted with respect*
7 *to paragraph (1)(A), the proposal shall be designed to*
8 *achieve a 2-hour or less express service between Wash-*
9 *ington, District of Columbia, and New York City,*
10 *New York.*

11 *(4) CONTENTS.—A proposal submitted under*
12 *this subsection shall include—*

13 *(A) the names and qualifications of the per-*
14 *sons submitting the proposal and the entities*
15 *proposed to finance, design, construct, operate,*
16 *and maintain the railroad, railroad equipment,*
17 *and related facilities, stations, and infrastruc-*
18 *ture;*

19 *(B) a detailed description of the proposed*
20 *rail service, including possible routes, required*
21 *infrastructure investments and improvements,*
22 *equipment needs and type, train frequencies,*
23 *peak and average operating speeds, and trip*
24 *times;*

1 (C) a description of how the project would
2 comply with all applicable Federal rail safety
3 and security laws, orders, and regulations;

4 (D) the locations of proposed stations, which
5 maximize the usage of existing infrastructure to
6 the extent possible, and the populations such sta-
7 tions are intended to serve;

8 (E) the type of equipment to be used, in-
9 cluding any technologies, to achieve trip time
10 goals;

11 (F) a description of any proposed legisla-
12 tion needed to facilitate all aspects of the project;

13 (G) a financing plan identifying—

14 (i) projected revenue, and sources
15 thereof;

16 (ii) the amount of any requested public
17 contribution toward the project, and pro-
18 posed sources;

19 (iii) projected annual ridership projec-
20 tions for the first 10 years of operations;

21 (iv) annual operations and capital
22 costs;

23 (v) the projected levels of capital in-
24 vestments required both initially and in
25 subsequent years to maintain a state-of-

1 *good-repair necessary to provide the ini-*
2 *tially proposed level of service or higher lev-*
3 *els of service;*

4 *(vi) projected levels of private invest-*
5 *ment and sources thereof, including the*
6 *identity of any person or entity that has*
7 *made or is expected to make a commitment*
8 *to provide or secure funding and the*
9 *amount of such commitment; and*

10 *(vii) projected funding for the full fair*
11 *market compensation for any asset, prop-*
12 *erty right or interest, or service acquired*
13 *from, owned, or held by a private person or*
14 *Federal entity that would be acquired, im-*
15 *paired, or diminished in value as a result*
16 *of a project, except as otherwise agreed to by*
17 *the private person or entity;*

18 *(H) a description of how the project would*
19 *contribute to the development of the intercity*
20 *passenger rail system and an intermodal plan*
21 *describing how the system will facilitate conven-*
22 *ient travel connections with other transportation*
23 *services;*

24 *(I) a description of how the project will en-*
25 *sure compliance with Federal laws governing the*

1 *rights and status of employees associated with*
2 *the route and service, including those specified in*
3 *section 24405 of title 49, United States Code;*

4 *(J) a description of how the design, con-*
5 *struction, implementation, and operation of the*
6 *project will accommodate and allow for future*
7 *growth of existing and projected intercity, com-*
8 *muter, and freight rail service;*

9 *(K) a description of how the project would*
10 *comply with Federal and State environmental*
11 *laws and regulations, of what environmental im-*
12 *pacts would result from the project, and of how*
13 *any adverse impacts would be mitigated; and*

14 *(L) a description of the project's impacts on*
15 *highway and aviation congestion, energy con-*
16 *sumption, land use, and economic development*
17 *in the service area.*

18 ***(b) DETERMINATION AND ESTABLISHMENT OF COM-***
19 ***MISSIONS.—Not later than 90 days after receipt of the pro-***
20 ***posals under subsection (a), the Secretary shall—***

21 ***(1) make a determination as to whether any such***
22 ***proposals—***

23 ***(A) contain the information required under***
24 ***paragraphs (3) and (4) of subsection (a);***

1 (B) are sufficiently credible to warrant fur-
2 ther consideration;

3 (C) are likely to result in a positive impact
4 on the Nation's transportation system; and

5 (D) are cost-effective and in the public in-
6 terest;

7 (2) establish a commission under subsection (c)
8 for each corridor with 1 or more proposals that the
9 Secretary determines satisfy the requirements of para-
10 graph (1); and

11 (3) forward to each commission established
12 under paragraph (2) the applicable proposals for re-
13 view and consideration.

14 (c) COMMISSIONS.—

15 (1) MEMBERS.—Each commission established
16 under subsection (b)(2) shall include—

17 (A) the governors of the affected States, or
18 their respective designees;

19 (B) mayors of appropriate municipalities
20 with stops along the proposed corridor, or their
21 respective designees;

22 (C) a representative from each freight rail-
23 road carrier using the relevant corridor, if appli-
24 cable;

1 (D) a representative from each transit au-
2 thority using the relevant corridor, if applicable;

3 (E) representatives of nonprofit employee
4 labor organizations representing affected railroad
5 employees; and

6 (F) the President of Amtrak or his or her
7 designee.

8 (2) *APPOINTMENT AND SELECTION.*—The Sec-
9 retary shall appoint the members under paragraph
10 (1). In selecting each commission’s members to fulfill
11 the requirements under subparagraphs (B) and (E) of
12 paragraph (1), the Secretary shall consult with the
13 Chairperson and Ranking Member of the Committee
14 on Commerce, Science, and Transportation of the
15 Senate and of the Committee on Transportation and
16 Infrastructure of the House of Representatives.

17 (3) *CHAIRPERSON AND VICE-CHAIRPERSON SE-*
18 *LECTION.*—The Chairperson and Vice-Chairperson
19 shall be elected from among members of each commis-
20 sion.

21 (4) *QUORUM AND VACANCY.*—

22 (A) *QUORUM.*—A majority of the members
23 of each commission shall constitute a quorum.

24 (B) *VACANCY.*—Any vacancy in each com-
25 mission shall not affect its powers and shall be

1 *filled in the same manner in which the original*
 2 *appointment was made.*

3 (5) *APPLICATION OF LAW.—Except where other-*
 4 *wise provided by this section, the Federal Advisory*
 5 *Committee Act (5 U.S.C. App.) shall apply to each*
 6 *commission created under this section.*

7 (d) *COMMISSION CONSIDERATION.—*

8 (1) *IN GENERAL.—Each commission established*
 9 *under subsection (b)(2) shall be responsible for review-*
 10 *ing the proposal or proposals forwarded to it under*
 11 *that subsection and not later than 90 days after the*
 12 *establishment of the commission, shall transmit to the*
 13 *Secretary a report, including—*

14 (A) *a summary of each proposal received;*

15 (B) *services to be provided under each pro-*
 16 *posal, including projected ridership, revenues,*
 17 *and costs;*

18 (C) *proposed public and private contribu-*
 19 *tions for each proposal;*

20 (D) *the advantages offered by the proposal*
 21 *over existing intercity passenger rail services;*

22 (E) *public operating subsidies or assets*
 23 *needed for the proposed project;*

24 (F) *possible risks to the public associated*
 25 *with the proposal, including risks associated*

1 with project financing, implementation, comple-
2 tion, safety, and security;

3 (G) a ranked list of the proposals rec-
4 ommended for further consideration under sub-
5 section (e) in accordance with each proposal's
6 projected positive impact on the Nation's trans-
7 portation system;

8 (H) an identification of any proposed Fed-
9 eral legislation that would facilitate implementa-
10 tion of the projects and Federal legislation that
11 would be required to implement the projects; and

12 (I) any other recommendations by the com-
13 mission concerning the proposed projects.

14 (2) *VERBAL PRESENTATION.*—Proposers shall be
15 given an opportunity to make a verbal presentation
16 to the commission to explain their proposals.

17 (3) *AUTHORIZATION OF APPROPRIATIONS.*—
18 There is authorized to be appropriated to the Sec-
19 retary for the use of each commission established
20 under subsection (b)(2) such sums as are necessary to
21 carry out this section.

22 (e) *SELECTION BY SECRETARY.*—

23 (1) *IN GENERAL.*—Not later than 60 days after
24 receiving the recommended proposals of the commis-

1 *sions established under subsection (b)(2), the Sec-*
2 *retary shall—*

3 *(A) review such proposals and select any*
4 *proposal that provides substantial benefits to the*
5 *public and the national transportation system, is*
6 *cost-effective, offers significant advantages over*
7 *existing services, and meets other relevant factors*
8 *determined appropriate by the Secretary; and*

9 *(B) submit to the Committee on Commerce,*
10 *Science, and Transportation of the Senate and*
11 *the Committee on Transportation and Infra-*
12 *structure of the House of Representatives a re-*
13 *port containing any proposal with respect to*
14 *subsection (a)(1)(A) that is selected by the Sec-*
15 *retary under subparagraph (A) of this para-*
16 *graph, all the information regarding the pro-*
17 *posal provided to the Secretary under subsection*
18 *(d), and any other information the Secretary*
19 *considers relevant.*

20 *(2) SUBSEQUENT REPORT.—Following the sub-*
21 *mission of the report under paragraph (1)(B), the*
22 *Secretary shall submit to the Committee on Com-*
23 *merce, Science, and Transportation of the Senate and*
24 *the Committee on Transportation and Infrastructure*
25 *of the House of Representatives a report containing*

1 *any proposal with respect to subparagraphs (B)*
2 *through (K) of subsection (a)(1) that are selected by*
3 *the Secretary under paragraph (1) of this subsection,*
4 *all the information regarding the proposal provided*
5 *to the Secretary under subsection (d), and any other*
6 *information the Secretary considers relevant.*

7 (3) *LIMITATION ON REPORT SUBMISSION.—The*
8 *report required under paragraph (2) shall not be sub-*
9 *mitted by the Secretary until the report submitted*
10 *under paragraph (1)(B) has been considered through*
11 *a hearing by the Committee on Commerce, Science,*
12 *and Transportation of the Senate and the Committee*
13 *on Transportation and Infrastructure of the House of*
14 *Representatives on the report submitted under para-*
15 *graph (1)(B).*

16 (f) *NO ACTIONS WITHOUT ADDITIONAL AUTHORITY.—*
17 *No Federal agency may take any action to implement, es-*
18 *tablish, facilitate, or otherwise act upon any proposal sub-*
19 *mitted under this section, other than those actions specifi-*
20 *cally authorized by this section, without explicit statutory*
21 *authority enacted after the date of enactment of this Act.*

22 (g) *DEFINITIONS.—In this section:*

23 (1) *INTERCITY PASSENGER RAIL.—The term*
24 *“intercity passenger rail” means intercity rail pas-*

1 *senger transportation as defined in section 24102 of*
2 *title 49, United States Code.*

3 (2) *STATE.*—*The term “State” means any of the*
4 *50 States or the District of Columbia.*

5 **SEC. 313. AMTRAK INSPECTOR GENERAL.**

6 (a) *AUTHORITY.*—

7 (1) *IN GENERAL.*—*The Inspector General of Am-*
8 *trak shall have the authority available to other In-*
9 *spectors General, as necessary in carrying out the du-*
10 *ties specified in the Inspector General Act of 1978 (5*
11 *U.S.C. App.), to investigate any alleged violation of*
12 *sections 286, 287, 371, 641, 1001, 1002 and 1516 of*
13 *title 18, United States Code.*

14 (2) *AGENCY.*—*For purposes of sections 286, 287,*
15 *371, 641, 1001, 1002, and 1516 of title 18, United*
16 *States Code, Amtrak and the Amtrak Office of Inspec-*
17 *tor General, shall be considered a corporation in*
18 *which the United States has a proprietary interest as*
19 *set forth in section 6 of that title.*

20 (b) *ASSESSMENT.*—*The Inspector General of Amtrak*
21 *shall—*

22 (1) *not later than 60 days after the date of en-*
23 *actment of this Act, initiate an assessment to deter-*
24 *mine whether current expenditures or procurements*
25 *involving Amtrak’s fulfillment of the Americans with*

1 *Disabilities Act of 1990 (42 U.S.C. 12101 et seq.) uti-*
2 *lize competitive, market-driven provisions that are*
3 *applicable throughout the entire term of such related*
4 *expenditures or procurements; and*

5 *(2) not later than 6 months after the date of en-*
6 *actment of this Act, transmit to the Committee on*
7 *Commerce, Science, and Transportation of the Senate*
8 *and the Committee on Transportation and Infrastruc-*
9 *ture of the House of Representatives the assessment*
10 *under paragraph (1).*

11 *(c) LIMITATION.—The authority provided by sub-*
12 *sections (a) and (b) shall be effective only with respect to*
13 *a fiscal year for which Amtrak receives a Federal subsidy.*

 11 ***Subtitle A—Safety Improvement***

12 ***SEC. 401. HIGHWAY-RAIL GRADE CROSSING SAFETY.***

13 *(a) MODEL STATE HIGHWAY-RAIL GRADE CROSSING*
 14 *ACTION PLAN.—*

15 *(1) IN GENERAL.—Not later than 1 year after*
 16 *the date of enactment of this Act, the Secretary shall*
 17 *develop a model of a State-specific highway-rail grade*
 18 *crossing action plan and distribute the model plan to*
 19 *each State.*

20 *(2) CONTENTS.—The plan developed under para-*
 21 *graph (1) shall include—*

22 *(A) methodologies, tools, and data sources*
 23 *for identifying and evaluating highway-rail*
 24 *grade crossing safety risks, including the public*

1 *safety risks posed by blocked highway-rail grade*
2 *crossings due to idling trains;*

3 *(B) best practices to reduce the risk of high-*
4 *way-rail grade crossing accidents or incidents*
5 *and to alleviate the blockage of highway-rail*
6 *grade crossings due to idling trains, including*
7 *strategies for—*

8 *(i) education, including model stake-*
9 *holder engagement plans or tools;*

10 *(ii) engineering, including the benefits*
11 *and costs of different designs and tech-*
12 *nologies used to mitigate highway-rail*
13 *grade crossing safety risks; and*

14 *(iii) enforcement, including the*
15 *strengths and weaknesses associated with*
16 *different enforcement methods;*

17 *(C) for each State, a customized list and*
18 *data set of the highway-rail grade crossing acci-*
19 *idents or incidents in that State over the past 3*
20 *years, including the location, number of deaths,*
21 *and number of injuries for each accident or inci-*
22 *dent; and*

23 *(D) contact information of a Department of*
24 *Transportation safety official available to assist*

1 *the State in adapting the model plan to satisfy*
2 *the requirements under subsection (b).*

3 **(b) STATE HIGHWAY-RAIL GRADE CROSSING ACTION**
4 *PLANS.—*

5 **(1) REQUIREMENTS.—***Not later than 18 months*
6 *after the Secretary develops and distributes the model*
7 *plan under subsection (a), the Secretary shall promul-*
8 *gate a rule that requires—*

9 **(A)** *each State, except the 10 States identi-*
10 *fied under section 202 of the Rail Safety Im-*
11 *provement Act of 2008 (49 U.S.C. 22501 note),*
12 *to develop and implement a State highway-rail*
13 *grade crossing action plan; and*

14 **(B)** *each State that was identified under*
15 *section 202 of the Rail Safety Improvement Act*
16 *of 2008 (49 U.S.C. 22501 note), to update its*
17 *State action plan under that section and submit*
18 *to the Secretary the updated State action plan*
19 *and a report describing what the State did to*
20 *implement its previous State action plan under*
21 *that section and how it will continue to reduce*
22 *highway-rail grade crossing safety risks.*

23 **(2) CONTENTS.—***Each State plan required under*
24 *this subsection shall—*

1 (A) identify highway-rail grade crossings
2 that have experienced recent highway-rail grade
3 crossing accidents or incidents, or are at high-
4 risk for accidents or incidents;

5 (B) identify specific strategies for improv-
6 ing safety at highway-rail grade crossings, in-
7 cluding highway-rail grade crossing closures or
8 grade separations; and

9 (C) designate a State official responsible for
10 managing implementation of the State plan
11 under subparagraph (A) or (B) of paragraph
12 (1), as applicable.

13 (3) ASSISTANCE.—The Secretary shall provide
14 assistance to each State in developing and carrying
15 out, as appropriate, the State plan under this sub-
16 section.

17 (4) PUBLIC AVAILABILITY.—Each State shall
18 submit its final State plan under this subsection to
19 the Secretary for publication. The Secretary shall
20 make each approved State plan publicly available on
21 an official Internet Web site.

22 (5) CONDITIONS.—The Secretary may condition
23 the awarding of a grant to a State under chapter 244
24 of title 49, United States Code, on that State submit-
25 ting an acceptable State plan under this subsection.

1 (6) *REVIEW OF ACTION PLANS.*—Not later than
2 60 days after the date of receipt of a State plan under
3 this subsection, the Secretary shall—

4 (A) if the State plan is approved, notify the
5 State and publish the State plan under para-
6 graph (4); and

7 (B) if the State plan is incomplete or defi-
8 cient, notify the State of the specific areas in
9 which the plan is deficient and allow the State
10 to complete the plan or correct the deficiencies
11 and resubmit the plan under paragraph (1).

12 (7) *DEADLINE.*—Not later than 60 days after the
13 date of a notice under paragraph (6)(B), a State shall
14 complete the plan or correct the deficiencies and re-
15 submit the plan.

16 (8) *FAILURE TO COMPLETE OR CORRECT*
17 *PLAN.*—If a State fails to meet the deadline under
18 paragraph (7), the Secretary shall post on the Web
19 site under paragraph (4) a notice that the State has
20 an incomplete or deficient highway-rail grade cross-
21 ing action plan.

22 (c) *RAILWAY-HIGHWAY CROSSINGS FUNDS.*—The Sec-
23 retary may use funds made available to carry out section
24 130 of title 23, United States Code, to provide States with
25 funds to develop a State highway-rail grade crossing action

1 *plan under subsection (b)(1)(A) of this section or to update*
2 *a State action plan under subsection (b)(1)(B) of this sec-*
3 *tion.*

4 *(d) DEFINITIONS.—In this section:*

5 *(1) HIGHWAY-RAIL GRADE CROSSING.—The term*
6 *“highway-rail grade crossing” means a location with-*
7 *in a State, other than a location where 1 or more*
8 *railroad tracks cross 1 or more railroad tracks at*
9 *grade where—*

10 *(A) a public highway, road, or street, or a*
11 *private roadway, including associated sidewalks*
12 *and pathways, crosses 1 or more railroad tracks*
13 *either at grade or grade-separated; or*

14 *(B) a pathway explicitly authorized by a*
15 *public authority or a railroad carrier that is*
16 *dedicated for the use of non-vehicular traffic, in-*
17 *cluding pedestrians, bicyclists, and others, that is*
18 *not associated with a public highway, road, or*
19 *street, or a private roadway, crosses 1 or more*
20 *railroad tracks either at grade or grade-sepa-*
21 *rated.*

22 *(2) STATE.—The term “State” means a State of*
23 *the United States or the District of Columbia.*

1 **SEC. 402. CONFIDENTIAL CLOSE CALL REPORTING SYSTEM.**

2 (a) *IN GENERAL.*—Not later than 3 years after the
3 date of enactment of this Act, the Secretary shall promul-
4 gate a rule to encourage and facilitate the voluntary par-
5 ticipation of railroad carriers, railroad carrier contractors,
6 and employees of railroad carriers or railroad carrier con-
7 tractors (including any non-profit labor organizations rep-
8 resenting a class or craft of directly affected employees of
9 railroads carriers or railroad carrier contractors) in a con-
10 fidential close call reporting system.

11 (b) *PROGRAM ELEMENTS.*—

12 (1) *IN GENERAL.*—The Secretary shall use any
13 information and experience gathered through research
14 and pilot programs on confidential close call report-
15 ing systems in developing a rule for the voluntary
16 adoption of confidential close call reporting system
17 programs under this section.

18 (2) *RULEMAKING.*—

19 (A) *IN GENERAL.*—Each confidential close
20 call reporting system program shall be designed
21 to improve railroad safety by facilitating greater
22 collection and analysis of reports that describe
23 unsafe conditions and events in the railroad in-
24 dustry, as reported voluntarily and confiden-
25 tially by employees.

1 (B) *REQUIREMENTS.*—*The rule shall speci-*
2 *fy—*

3 (i) *the use of independent third parties*
4 *for the collection of close call reports, de-*
5 *identification of data, and distribution of*
6 *close call data;*

7 (ii) *the criteria for participating vol-*
8 *untarily in the confidential close call re-*
9 *porting system;*

10 (iii) *the criteria for accepting con-*
11 *fidential close call reports;*

12 (iv) *the appropriate use and protec-*
13 *tion, including the information protections*
14 *described in subsection (d), of peer review*
15 *teams and participation of the Secretary's*
16 *representatives;*

17 (v) *the relief from specific railroad*
18 *safety regulatory provisions and the condi-*
19 *tions under which the relief will and will*
20 *not be granted; and*

21 (vi) *the appropriate use and protec-*
22 *tion, including the information protections*
23 *described in subsection (d), of confidential*
24 *data generated under voluntary participa-*

1 *tion in the confidential close call reporting*
2 *system.*

3 *(c) PROGRAM DEVELOPMENT.—*

4 *(1) IN GENERAL.—A railroad carrier voluntarily*
5 *participating in a confidential close call reporting*
6 *system program, pursuant to program elements con-*
7 *tained in the final rule promulgated under subsection*
8 *(b) and in collaboration with the Secretary, railroad*
9 *carrier contractors (as appropriate), and employees of*
10 *railroad carriers or railroad carrier contractors (in-*
11 *cluding any non-profit labor organization rep-*
12 *resenting a class or craft of directly affected employees*
13 *of railroad carriers or railroad carrier contractors),*
14 *shall develop an implementing memorandum of un-*
15 *derstanding that establishes agreed-upon terms for*
16 *participation in the confidential close call reporting*
17 *system.*

18 *(2) SIGNATURES REQUIRED.—An implementing*
19 *memorandum of understanding under paragraph (1)*
20 *shall be signed by—*

21 *(A) the Secretary or the Secretary's des-*
22 *ignee;*

23 *(B) the participating railroad carrier or the*
24 *representative thereof;*

1 (C) if appropriate, each participating rail-
2 road carrier contractor or the representative
3 thereof; and

4 (D) the participating employees and con-
5 tractors or the representative thereof (such as 1
6 or more non-profit labor organizations rep-
7 resenting a class or craft of directly affected em-
8 ployees of the railroad carrier or railroad carrier
9 contractor).

10 (d) *INFORMATION PROTECTION.*—

11 (1) *IN GENERAL.*—For a confidential close call
12 reporting system program established through an im-
13 plementing memorandum of understanding described
14 in subsection (c), the rule shall include provisions
15 that withhold from discovery or admission into evi-
16 dence (in a Federal or State court proceeding for
17 damages involving personal injury, wrongful death,
18 or property damage against a railroad carrier or
19 railroad carrier contractor) any plan, document, re-
20 port, survey, schedule, list, or data compiled or col-
21 lected for the sole purpose of developing, evaluating,
22 planning, or implementing a confidential close call
23 reporting system program, including a railroad car-
24 rier’s analysis of its close calls or near misses.

1 (2) *RETROACTIVE APPLICATIONS.*—*With regard*
2 *to a voluntary confidential close call reporting system*
3 *that was in effect prior to the date of final rule under*
4 *subsection (a), the Secretary—*

5 (A) *shall allow the parties participating in*
6 *that system to sign a new or revised imple-*
7 *menting memorandum of understanding that*
8 *prospectively entitles the parties to the informa-*
9 *tion protections under paragraph (1); and*

10 (B) *may retroactively apply the informa-*
11 *tion protections under paragraph (1) to any in-*
12 *formation and analyses that was generated*
13 *under that system prior to the date of the final*
14 *rule.*

15 (3) *CONFIDENTIALITY.*—*For a confidential close*
16 *call reporting system program established through an*
17 *implementing memorandum of understanding de-*
18 *scribed in subsection (c), the Secretary shall ensure*
19 *that the Department of Transportation and any enti-*
20 *ty collecting close call reports, de-identifying data, or*
21 *distributing close call data provide the same level of*
22 *confidentiality as contained in the Confidential Infor-*
23 *mation Protection and Statistical Efficiency Act of*
24 *2002 (44 U.S.C. 3501 note), as administered by the*
25 *Bureau of Transportation Statistics.*

1 (e) *SAVINGS CLAUSE.*—*Nothing in this section shall—*

2 (1) *require a railroad carrier to adopt a con-*
3 *fidential close call reporting system program;*

4 (2) *prohibit a railroad carrier from voluntarily*
5 *adopting a confidential close call reporting system*
6 *program outside of the rulemaking framework; and*

7 (3) *require the Secretary to develop a confiden-*
8 *tial close call reporting system program with a rail-*
9 *road carrier, a railroad carrier contractor, employees*
10 *of the railroad carrier or railroad carrier contractor,*
11 *or any non-profit labor organizations representing a*
12 *class or craft of employees of a railroad carrier or a*
13 *railroad carrier contractor.*

14 (f) *DEFINITION OF RAILROAD CARRIER.*—*In this sec-*
15 *tion, the term “railroad carrier” has the meaning given the*
16 *term in section 20102 of title 49, United States Code.*

17 (g) *ADDITIONAL INFORMATION PROTECTIONS.*—*Sec-*
18 *tion 20118 is amended—*

19 (1) *in subsection (a)—*

20 (A) *in the matter preceding paragraph*

21 (1)—

22 (i) *by inserting “, confidential close*
23 *call reporting system program,” after “safe-*
24 *ty risk reduction program”; and*

1 (ii) by inserting “pursuant to section
2 552(b)(3) of that title,” after “section 552 of
3 title 5”;

4 (B) in paragraph (1), by inserting “, con-
5 fidential close call reporting system program,”
6 after “safety risk reduction program”; and

14 *applicable, other signal systems, increased crew size,*
15 *improved signage, or other practices, including in-*
16 *creased crew communication, to enable warning and*
17 *enforcement of the maximum authorized speed for*
18 *passenger trains at each location identified under*
19 *paragraph (1);*

20 (3) *contains milestones and target dates for im-*
21 *plementing each appropriate action described under*
22 *paragraph (2); and*

23 (4) *ensures compliance with the maximum au-*
24 *thorized speed at each location identified under para-*
25 *graph (1).*

1 (c) *APPROVAL.*—Not later than 90 days after the date
2 an action plan is submitted under subsection (a), the Sec-
3 retary shall approve, approve with conditions, or dis-
4 approve the action plan.

5 (d) *ALTERNATIVE SAFETY MEASURES.*—The Secretary
6 may exempt from the requirements of this section each seg-
7 ment of track for which operations are governed by a posi-
8 tive train control system certified under section 20157 of
9 title 49, United States Code, or any other safety technology
10 or practice that would achieve an equivalent or greater level
11 of safety in reducing derailment risk.

12 (e) *REPORT.*—Not later than 6 months after the date
13 of the enactment of this Act, the Secretary shall submit a
14 report to the Committee on Commerce, Science, and Trans-
15 portation of the Senate and the Committee on Transpor-
16 tation and Infrastructure of the House of Representatives
17 that describes—

18 (1) the actions the railroad carriers have taken
19 in response to Safety Advisory 2013–08, entitled
20 “Operational Tests and Inspections for Compliance
21 With Maximum Authorized Train Speeds and Other
22 Speed Restrictions”;

23 (2) the actions the railroad carriers have taken
24 in response to Safety Advisory 2015–03, entitled
25 “Operational and Signal Modifications for Compli-

1 *ance with Maximum Authorized Passenger Train*
2 *Speeds and Other Speed Restrictions”;* and

3 *(3) the actions the Federal Railroad Administra-*
4 *tion has taken to evaluate or incorporate the informa-*
5 *tion and findings arising from the safety advisories*
6 *referred to in paragraphs (1) and (2) into the devel-*
7 *opment of regulatory action and oversight activities.*

8 *(f) SAVINGS CLAUSE.—Nothing in this section shall*
9 *prohibit the Secretary from applying the requirements of*
10 *this section to other segments of track at high risk of over-*
11 *speed derailment.*

12 **SEC. 404. SIGNAGE.**

 6 *motive of each passenger train in intercity rail passenger*
 7 *transportation (as defined in section 24102 of title 49,*
 8 *United States Code) or commuter rail passenger transpor-*
 9 *tation (as defined in section 24102 of title 49, United States*
 10 *Code).*

11 *(b) RULEMAKING.—*

12 *(1) IN GENERAL.—The Secretary may promul-*
 13 *gate a rule to specify the essential functionalities of*
 14 *a working alerter, including the manner in which the*
 15 *alerter can be reset.*

16 *(2) ALTERNATE PRACTICE OR TECHNOLOGY.—*
 17 *The Secretary may require or allow a technology or*
 18 *practice in lieu of a working alerter if the Secretary*
 19 *determines that the technology or practice would*
 20 *achieve an equivalent or greater level of safety in en-*
 21 *hancing or ensuring appropriate locomotive control.*

22 **SEC. 406. SIGNAL PROTECTION.**

23 *(a) IN GENERAL.—The Secretary shall promulgate*
 24 *regulations to require, not later than 18 months after the*
 25 *date of the enactment of this Act, that on-track safety regu-*

1 *lations, whenever practicable and consistent with other safe-*
 2 *ty requirements and operational considerations, include re-*
 3 *quiring implementation of redundant signal protection,*
 4 *such as shunting or other practices and technologies that*
 5 *achieve an equivalent or greater level of safety, for mainte-*
 6 *nance-of-way work crews who depend on a train dispatcher*
 7 *to provide signal protection.*

8 **(b) ALTERNATIVE SAFETY MEASURES.**—*The Secretary*
 9 *may exempt from the requirements of this section each seg-*
 10 *ment of track for which operations are governed by a posi-*
 11 *tive train control system certified under section 20157 of*
 12 *title 49, United States Code, or any other safety technology*
 13 *or practice that would achieve an equivalent or greater level*
 14 *of safety in providing additional signal protection.*

15 **SEC. 407. TECHNOLOGY IMPLEMENTATION PLANS.**

20 **(B) in subparagraph (B), by striking the**

4 **SEC. 408. COMMUTER RAIL TRACK INSPECTIONS.**

2 *than 18 months after the date of enactment of this Act, shall*
3 *transmit a report to the Committee on Commerce, Science,*
4 *and Transportation of the Senate and the Committee on*
5 *Transportation and Infrastructure of the House of Rep-*
6 *resentatives explaining the reasons for not revising the regu-*
7 *lations.*

8 (d) *CONSTRUCTION.*—*Nothing in this section may be*
9 *construed to limit the authority of the Secretary to promul-*
10 *gate regulations or issue orders under any other law.*

11 **SEC. 409. EMERGENCY RESPONSE.**

12 (a) *IN GENERAL.*—*The Secretary, in consultation with*
13 *railroad carriers, shall conduct a study to determine wheth-*
14 *er limitations or weaknesses exist in the emergency response*
15 *information carried by train crews transporting hazardous*
16 *materials.*

17 (b) *CONTENTS.*—*In conducting the study under sub-*
18 *section (a), the Secretary shall evaluate the differences be-*
19 *tween the emergency response information carried by train*
20 *crews transporting hazardous materials and the emergency*
21 *response guidance provided in the Emergency Response*
22 *Guidebook issued by the Department of Transportation.*

23 (c) *REPORT.*—*Not later than 1 year after the date of*
24 *enactment of this Act, the Secretary shall transmit to the*
25 *Committee on Commerce, Science, and Transportation of*

1 *the Senate and the Committee on Transportation and In-*
2 *frastructure of the House of Representatives a report of the*
3 *findings of the study under subsection (a) and any rec-*
4 *ommendations for legislative action.*

5 **SEC. 410. PRIVATE HIGHWAY-RAIL GRADE CROSSINGS.**

6 (a) *IN GENERAL.*—*The Secretary, in consultation with*
7 *railroad carriers, shall conduct a study—*

8 (1) *to determine whether limitations or weak-*
9 *nesses exist regarding the availability and usefulness*
10 *for safety purposes of data on private highway-rail*
11 *grade crossings; and*

12 (2) *to evaluate existing engineering practices on*
13 *private highway-rail grade crossings.*

14 (b) *CONTENTS.*—*In conducting the study under sub-*
15 *section (a), the Secretary shall make recommendations as*
16 *necessary to improve—*

21 *warning systems.*

22 (c) *REPORT.*—*Not later than 1 year after the date of*
23 *enactment of this Act, the Secretary shall transmit to the*
24 *Committee on Commerce, Science, and Transportation of*
25 *the Senate and the Committee on Transportation and In-*

1 *frastructure of the House of Representatives a report of the*
 2 *findings of the study and any recommendations for further*
 3 *action.*

4 **SEC. 411. REPAIR AND REPLACEMENT OF DAMAGED TRACK**
 5 **INSPECTION EQUIPMENT.**

6 (a) *IN GENERAL.*—*Subchapter I of chapter 201 is*

9 *in paragraphs (1) and (2) to meet the needs of the*
10 *passengers involved in the crash and their families,*
11 *including—*

12 *(A) notification of emergency contacts;*

13 *(B) dedicated and trained staff to manage*
14 *family assistance;*

15 *(C) the establishment of a family assistance*
16 *center at the accident locale or other appropriate*
17 *location;*

18 *(D) a system for identifying and recovering*
19 *items belonging to passengers that were lost in*
20 *the crash; and*

21 *(E) the establishment of a single customer*
22 *service entity within Amtrak to coordinate the*
23 *response to the needs of the passengers involved*
24 *in the crash and their families;*

1 (4) *recommendations for any additional training*
2 *needed by Amtrak staff to better implement the plans*
3 *referred to in paragraphs (1) and (2), including the*
4 *establishment of a regular schedule for training drills*
5 *and exercises.*

6 (c) *REPORT TO CONGRESS.*—*Not later than 1 year*
7 *after the date of the enactment of this Act, Amtrak shall*
8 *submit a report to the Committee on Commerce, Science,*
9 *and Transportation of the Senate and the Committee on*
10 *Transportation and Infrastructure of the House of Rep-*
11 *resentatives that describes—*

12 (1) *its plan to achieve the recommendations re-*
13 *ferred to in subsection (b)(4); and*

14 (2) *steps that have been taken to address any de-*
15 *ficiencies identified through the assessment.*

17 *pendent evaluation under paragraph (1), the Govern-*
18 *ment Accountability Office shall examine the fol-*
19 *lowing issues related to ECP brake systems:*

20 (A) *Data and modeling results on safety*
21 *benefits relative to conventional brakes and to*
22 *other braking technologies or systems, such as*
23 *distributed power and 2-way end-of-train de-*
24 *vices.*

1 (B) *Data and modeling results on business*
2 *benefits, including the effects of dynamic brak-*
3 *ing.*

4 (C) *Data on costs, including up-front cap-*
5 *ital costs and on-going maintenance costs.*

6 (D) *Analysis of potential operational chal-*
7 *lenges, including the effects of potential loco-*
8 *motive and car segregation, technical reliability*
9 *issues, and network disruptions.*

10 (E) *Analysis of potential implementation*
11 *challenges, including installation time, positive*
12 *train control integration complexities, compo-*
13 *nent availability issues, and tank car shop capa-*
14 *bilities.*

15 (F) *Analysis of international experiences*
16 *with the use of advanced braking technologies.*

17 (3) *DEADLINE.*—*Not later than 2 years after the*
18 *date of enactment of this Act, the Government Ac-*
19 *countability Office shall transmit to the Committee on*
20 *Commerce, Science, and Transportation of the Senate*
21 *and the Committee on Transportation and Infrastruc-*
22 *ture of the House of Representatives a report on the*
23 *results of the independent evaluation under para-*
24 *graph (1).*

25 (b) *EMERGENCY BRAKING APPLICATION TESTING.*—

1 (1) *IN GENERAL.*—*The Secretary of Transportation shall enter into an agreement with the NCRRP Board—*

17 (2) *INDEPENDENT EXPERTS.*—*In completing the testing under paragraph (1), the NCRRP Board may contract with 1 or more engineering or rail experts, as appropriate, with relevant experience in conducting railroad safety technology tests or similar crash tests.*

23 (3) *TESTING FRAMEWORK.*—*In completing the testing under paragraph (1), the NCRRP Board and each contractor described in paragraph (2) shall en-*

1 *sure that the testing objectively, accurately, and reli-*
2 *ably measures the performance of ECP brake systems*
3 *relative to other braking technologies or systems, such*
4 *as distributed power and 2-way end-of-train devices,*
5 *including differences in—*

6 *(A) the number of cars derailed;*

7 *(B) the number of cars punctured;*

8 *(C) the measures of in-train forces; and*

9 *(D) the stopping distance.*

10 *(4) FUNDING.—The Secretary shall require, as*
11 *part of the agreement under paragraph (1), that the*
12 *NCRRP Board fund the testing required under this*
13 *section—*

14 *(A) using such sums made available under*
15 *section 24910 of title 49, United States Code;*
16 *and*

17 *(B) to the extent funding under subpara-*
18 *graph (A) is insufficient or unavailable to fund*
19 *the testing required under this section, using*
20 *such sums as are necessary from the amounts*
21 *appropriated to the Office of the Secretary.*

22 *(5) EQUIPMENT.—The NCRRP Board and each*
23 *contractor described in paragraph (2) may receive or*
24 *use rolling stock, track, and other equipment or infra-*

1 *structure from a private entity for the purposes of*
2 *conducting the testing required under this section.*

3 *(c) PHASED APPROACH.—*

4 *(1) PHASE 1.—Not later than 60 days after the*
5 *date of enactment of this Act, the Secretary shall re-*
6 *quire each new tank car built to meet the DOT-117*
7 *specification and each tank car modified to meet the*
8 *DOT-117R specification to have an ECP-ready con-*
9 *figuration if the DOT-117 or DOT-117R specification*
10 *tank car will be used in high-hazard flammable unit*

12 *(2) PHASE 2.—After the reports are transmitted*

5 brake mode.

6 (e) SAVINGS CLAUSE.—

7 (1) ECP BRAKE MODE.—Nothing in this section
8 may be construed as prohibiting or requiring a rail-
9 road carrier from operating its trains in ECP brake
10 mode.

11 (2) HARMONIZATION.—Nothing in this section
12 may be construed to require or allow the Secretary to
13 prescribe an implementation deadline for the require-
14 ment under subsection (c)(1) that is earlier than the
15 applicable implementation deadline for other tank car
16 modifications necessary to meet the DOT-117R speci-
17 fication for tank cars that will be used in high-hazard
18 flammable unit train service.

19 (f) DEFINITIONS.—In this section:

20 (1) CLASS 3 FLAMMABLE LIQUID.—The term
21 “Class 3 flammable liquid” has the meaning given the
22 term in section 173.120(a) of title 49, Code of Federal
23 Regulations.

1 (2) *ECP*.—The term “*ECP*” means *electroni-*
2 *cally-controlled pneumatic when applied to a brake or*
3 *brakes.*

4 (3) *ECP BRAKE MODE*.—The term “*ECP brake*
5 *mode*” includes any operation of a rail car or an *en-*
6 *tire train using an ECP brake system.*

7 (4) *ECP BRAKE SYSTEM*.—

8 (A) *IN GENERAL*.—The term “*ECP brake*
9 *system*” means a train power braking system *ac-*
10 *tuated by compressed air and controlled by elec-*
11 *tronic signals from the locomotive or an ECP-*
12 *EOT to the cars in the consist for service and*
13 *emergency applications in which the brake pipe*
14 *is used to provide a constant supply of com-*
15 *pressed air to the reservoirs on each car but does*
16 *not convey braking signals to the car.*

17 (B) *INCLUSIONS*.—The term “*ECP brake*
18 *system*” includes *dual mode and stand-alone*
19 *ECP brake systems.*

20 (5) *ECP-READY CONFIGURATION*.—The term
21 “*ECP-ready configuration*” means *mounting brackets*
22 *and fixed conduit on the tank car to facilitate the fu-*
23 *ture application of additional ECP componentry and*
24 *required cables.*

1 “(b) *DEVICE STANDARDS.*—Each inward- and out-
2 ward-facing image recording device shall—

3 “(1) have a minimum 12-hour continuous re-
4 cording capability;

5 “(2) have crash and fire protections for any in-
6 cab image recordings that are stored only within a
7 controlling locomotive cab or cab car operating com-
8 partment; and

9 “(3) have recordings accessible for review during
10 an accident investigation.

11 “(c) *REVIEW.*—The Secretary shall establish a process
12 to review and approve or disapprove an inward- or out-
13 ward-facing recording device for compliance with the stand-
14 ards described in subsection (b).

15 “(d) *USES.*—A rail carrier that has installed an
16 inward- or outward-facing image recording device approved
17 under subsection (c) may use recordings from that inward-
18 or outward-facing image recording device for the following
19 purposes:

20 “(1) Verifying that train crew actions are in ac-
21 cordance with applicable safety laws and the rail car-
22 rier’s operating rules and procedures.

23 “(2) Assisting in an investigation into the cau-
24 sation of a reportable accident or incident.

1 “(3) *Carrying out efficiency testing and system-*
2 *wide performance monitoring programs.*

3 “(4) *Documenting a criminal act or monitoring*
4 *unauthorized occupancy of the controlling locomotive*
5 *cab or car operating compartment.*

6 “(e) *VOLUNTARY IMPLEMENTATION.—*

7 “(1) *IN GENERAL.—Each rail carrier operating*
8 *freight rail service may implement any inward- or*
9 *outward-facing image recording devices approved*
10 *under subsection (c).*

11 “(2) *AUTHORIZED USES.—Notwithstanding any*
12 *other provision of law, each rail carrier may use re-*
13 *cordings from an inward- or outward-facing image*
14 *recording device approved under subsection (c) for*
15 *any of the purposes described in subsection (d).*

16 “(f) *DISCRETION.—*

17 “(1) *IN GENERAL.—The Secretary may—*

18 “(A) *require in-cab audio recording devices*
19 *for the purposes described in paragraphs (1)*
20 *through (4) of subsection (d); and*

21 “(B) *define in appropriate technical detail*
22 *the essential features of the devices required*
23 *under subparagraph (A).*

24 “(2) *EXEMPTIONS.—The Secretary may exempt*
25 *any rail passenger carrier or any part of a rail pas-*

1 *senger carrier’s operations from the requirements*
2 *under subsection (a) if the Secretary determines that*
3 *the rail passenger carrier has implemented an alter-*
4 *native technology or practice that provides an equiva-*
5 *lent or greater safety benefit or is better suited to the*
6 *risks of the operation.*

7 *“(g) TAMPERING.—A rail carrier may take appro-*
8 *priate enforcement or administrative action against any*
9 *employee that tampers with or disables an audio or inward-*
10 *or outward-facing image recording device installed by the*
11 *rail carrier.*

12 *“(h) PRESERVATION OF DATA.—Each rail passenger*
13 *carrier subject to the requirements of subsection (a) shall*
14 *preserve recording device data for 1 year after the date of*
15 *a reportable accident or incident.*

16 *“(i) INFORMATION PROTECTIONS.—*

17 *“(1) SECTION 552(B)(3) OF TITLE 5 EXEMPTION.—*
18 *An in-cab audio or image recording, and any part*
19 *thereof, that the Secretary obtains as part of an acci-*
20 *dent or incident investigated by the Department of*
21 *Transportation shall be exempt from disclosure under*
22 *section 552(b)(3) of title 5.*

23 *“(2) RESTRICTIONS ON DISCLOSURE.—The Sec-*
24 *retary may allow an audio or image recordings de-*
25 *rived from an audio or inward- or outward-facing*

1 *image recording device to receive any of the informa-*
2 *tion and legal protections available to any report,*
3 *survey, schedule, list, or data compiled or collected as*
4 *part of the Department of Transportation railroad*
5 *safety risk reduction program if—*

6 *“(A) the recording is derived from—*

7 *“(i) an audio or inward- or outward-*
8 *facing image recording device that was im-*
9 *plemented pursuant to its railroad safety*
10 *risk reduction program under section*
11 *20156; and*

12 *“(ii) an inward- or outward-facing*
13 *image recording device that was approved*
14 *under subsection (c); or*

15 *“(B) an audio recording device that is com-*
16 *pliant with the requirements under subsection*
17 *(f)(1).*

18 *“(j) PROHIBITED USE.—An in-cab audio or image re-*
19 *ording obtained by a rail carrier under this section may*
20 *not be used to retaliate against an employee.*

21 *“(k) SAVINGS CLAUSE.—Nothing in this section may*
22 *be construed as requiring a rail carrier to cease or restrict*
23 *operations upon a technical failure of an inward- or out-*
24 *ward-facing image recording device. Such rail carrier shall*

1 *repair or replace the failed inward- or outward-facing*
 2 *image recording device as soon as practicable.”.*

3 (b) *CONFORMING AMENDMENT.—The table of contents*

3 eted DOT-111, jacketed DOT-111, non-jacketed
4 DOT-111 meeting the CPC-1232 standard, or
5 jacketed DOT-111 meeting the CPC-1232 stand-
6 ard; and

7 (B) the identification number of each Class
8 3 flammable liquid carried by each tank car in
9 the past year;

10 (2) the total number of tank cars built to meet
11 the DOT-117 specification, or equivalent; and

12 (3) the total number of tank cars used or likely
13 to be used in high-hazard flammable train service
14 that have not been modified, specifying—

15 (A) the type or specification of each tank
16 car not modified, including the non-jacketed
17 DOT-111, jacketed DOT-111, non-jacketed DOT-
18 111 meeting the CPC-1232 standard, or jacketed
19 DOT-111 meeting the CPC-1232 standard; and

20 (B) the identification number of each Class
21 3 flammable liquid carried by each tank car in
22 the past year.

23 (c) *TANK CAR SHOP DATA.*—The Secretary shall con-
24 duct a survey of tank car facilities modifying tank cars to
25 the DOT-117R specification, or equivalent, or building new

1 *tank cars to the DOT-117 specification, or equivalent, to*
2 *generate statistically-valid estimates of the expected number*
3 *of tank cars those facilities expect to modify to DOT-117R*
4 *specification, or equivalent, or build to the DOT-117 speci-*
5 *fication, or equivalent.*

6 (d) *FREQUENCY.—The Secretary shall collect the data*
7 *under subsection (b) and conduct the survey under sub-*
8 *section (c) annually until May 1, 2025.*

9 (e) *INFORMATION PROTECTIONS.—*

10 (1) *IN GENERAL.—The Secretary shall only re-*
11 *port data in industry-wide totals and shall treat com-*
12 *pany-specific information as confidential business in-*
13 *formation.*

14 (2) *LEVEL OF CONFIDENTIALITY.—The Secretary*
15 *shall ensure the data collected under subsection (b)*
16 *and the survey data under subsection (c) have the*
17 *same level of confidentiality as contained in the Con-*
18 *fidential Information Protection and Statistical Effi-*
19 *ciency Act of 2002 (44 U.S.C. 3501 note), as adminis-*
20 *tered by the Bureau of Transportation Statistics.*

21 (3) *SECTION 552(B)(3) OF TITLE 5.—Any infor-*
22 *mation that the Secretary obtains under subsection*
23 *(b) or subsection (c) by the Department of Transpor-*
24 *tation shall be exempt from disclosure under section*
25 *552(b)(3) of title 5.*

1 (4) *DESIGNEE.*—*The Secretary may designate*
2 *the Director of the Bureau of Transportation Statis-*
3 *tics to collect data under subsection (b) and the sur-*
4 *vey data under subsection (c) and direct the Director*
5 *to ensure the confidentiality of company-specific infor-*
6 *mation to the maximum extent permitted by law.*

7 (f) *REPORT.*—*Each year, not later than 60 days after*
8 *the date that both the collection of the data under subsection*
9 *(b) and the survey under subsection (c) are complete, the*
10 *Secretary shall report on the aggregate results, without com-*
11 *pany-specific information, to—*

12 (1) *the Committee on Commerce, Science, and*
13 *Transportation of the Senate; and*

14 (2) *the Committee on Transportation and Infra-*
15 *structure of the House of Representatives.*

16 (g) *DEFINITIONS.*—*In this section:*

17 (1) *CLASS 3 FLAMMABLE LIQUID.*—*The term*
18 *“Class 3 flammable liquid” has the meaning given the*
19 *term in section 173.120(a) of title 49, Code of Federal*
20 *Regulations.*

21 (2) *HIGH-HAZARD FLAMMABLE TRAIN.*—*The*
22 *term “high-hazard flammable train” means a single*
23 *train transporting 20 or more tank cars loaded with*
24 *a Class 3 flammable liquid in a continuous block or*
25 *a single train transporting 35 or more tank cars*

1 loaded with a Class 3 flammable liquid throughout
2 the train consist.

12 tion, and mitigation or enhancement measures incor-
13 porated into the program or project” after “historic
14 site”; and

15 (2) by adding at the end the following:

16 “(c) *RAIL AND TRANSIT*.—Improvements to, or the
17 maintenance, rehabilitation, or operation of, railroad or
18 rail transit lines or elements of such lines, with the excep-
19 tion of stations, that are in use or were historically used
20 for the transportation of goods or passengers, shall not be
21 considered a use of an historic site under subsection (a),
22 regardless of whether the railroad or rail transit line or ele-
23 ment of such line is listed on, or eligible for listing on, the
24 National Register of Historic Places.”.

1 (b) *TRANSPORTATION PROJECTS.*—Section 303 is
2 amended—

3 (1) in subsection (c), by striking “subsection (d)”
4 and inserting “subsections (d) and (e)”;

5 (2) in subsection (d)(2)(A)(i), by inserting “,
6 taking into consideration any avoidance, minimiza-
7 tion, and mitigation or enhancement measures incor-
8 porated into the program or project” after “historic
9 site”; and

10 (3) by adding at the end the following:

11 “(e) *RAIL AND TRANSIT.*—Improvements to, or the
12 maintenance, rehabilitation, or operation of, railroad or
13 rail transit lines or elements of such lines, with the excep-
14 tion of stations, that are in use or were historically used
15 for the transportation of goods or passengers, shall not be
16 considered a use of an historic site under subsection (c),
17 regardless of whether the railroad or rail transit line or ele-
18 ment of such line is listed on, or eligible for listing on, the
19 National Register of Historic Places.”.

20 **SEC. 503. EFFICIENT ENVIRONMENTAL REVIEWS.**

21 (a) *IN GENERAL.*—Section 304 is amended—

22 (1) in the heading, by striking “**for**
23 **multimodal projects**” and inserting “**and in-**
24 **creasing the efficiency of environmental**
25 **reviews**”; and

1 (2) *by adding at the end the following:*

2 “(e) *EFFICIENT ENVIRONMENTAL REVIEWS.*—

3 “(1) *IN GENERAL.*—*The Secretary of Transpor-*
4 *tation shall apply the project development procedures,*
5 *to the greatest extent feasible, described in section 139*
6 *of title 23, United States Code, to any rail project*
7 *that requires the approval of the Secretary of Trans-*
8 *portation under the National Environmental Policy*
9 *Act of 1969 (42 U.S.C. 4321 et seq.).*

10 “(2) *REGULATIONS AND PROCEDURES.*—*The Sec-*
11 *retary of Transportation shall incorporate such*
12 *project development procedures into the agency regu-*
13 *lations and procedures pertaining to rail projects.*

14 “(f) *APPLICABILITY OF NEPA DECISIONS.*—

15 “(1) *IN GENERAL.*—*A Department of Transpor-*
16 *tation operating administration may apply a cat-*
17 *egorical exclusion designated by another Department*
18 *of Transportation operating administration under the*
19 *National Environmental Policy Act of 1969 (42*
20 *U.S.C. 4321 et seq.).*

21 “(2) *FINDINGS.*—*A Department of Transpor-*
22 *tation operating administration may adopt, in whole*
23 *or in part, another Department of Transportation op-*
24 *erating administration’s Record of Decision, Finding*
25 *of No Significant Impact, and any associated evalua-*

1 *tions, determinations, or findings demonstrating com-*
 2 *pliance with any law related to environmental review*
 3 *or historic preservation.”.*

4 **SEC. 504. ADVANCE ACQUISITION.**

5 *(a) IN GENERAL.—Chapter 241 is amended by insert-*
 6 *ing after section 24105 the following—*

7 **“§ 24106. Advance acquisition**

8 *“(a) RAIL CORRIDOR PRESERVATION.—The Secretary*
 9 *may assist a recipient of funding in acquiring right-of-way*
 10 *and adjacent real property interests before or during the*
 11 *completion of the environmental reviews for any project re-*
 12 *ceiving funding under subtitle V of title 49, United States*
 13 *Code, that may use such property interests if the acquisition*
 14 *is otherwise permitted under Federal law, and the recipient*
 15 *requesting Federal funding for the acquisition certifies, with*
 16 *the concurrence of the Secretary, that—*

17 *“(1) the recipient has authority to acquire the*
 18 *right-of-way or adjacent real property interest; and*

19 *“(2) the acquisition of the right-of-way or adja-*
 20 *cent real property interest—*

21 *“(A) is for a transportation or transpor-*
 22 *tation-related purpose;*

23 *“(B) will not cause significant adverse envi-*
 24 *ronmental impact;*

1 “(C) will not limit the choice of reasonable
2 alternatives for the proposed project or otherwise
3 influence the decision of the Secretary on any
4 approval required for the proposed project;

5 “(D) does not prevent the lead agency for
6 the review process from making an impartial de-
7 cision as to whether to accept an alternative that
8 is being considered;

9 “(E) complies with other applicable Federal
10 law, including regulations;

11 “(F) will be acquired through negotiation
12 and without the threat of condemnation; and

13 “(G) will not result in the elimination or
14 reduction of benefits or assistance to a displaced
15 person under the Uniform Relocation Assistance
16 and Real Property Acquisition Policies Act of
17 1970 (42 U.S.C. 4601 et seq.) and title VI of the
18 Civil Rights Act of 1964 (42 U.S.C. 2000d et
19 seq.).

20 “(b) ENVIRONMENTAL REVIEWS.—

21 “(1) COMPLETION OF NEPA REVIEW.—Before au-
22 thORIZING any Federal funding for the acquisition of
23 a real property interest that is the subject of a grant
24 or other funding under this subtitle, the Secretary
25 shall complete, if required, the review process under

1 *the National Environmental Policy Act of 1969 (42*
 2 *U.S.C. 4321 et seq.) with respect to the acquisition.*

 24 *“The head of any Federal agency having direct” and*
 25 *indenting accordingly; and*

1 (3) *by adding at the end the following:*

2 “(c) **EXEMPTION FOR RAILROAD RIGHTS-OF-WAY.**—

3 “(1) **IN GENERAL.**—*Not later than 1 year after*
 4 *the date of enactment of the Track, Railroad, and In-*
 5 *frastructure Network Act, the Secretary of Transpor-*
 6 *tation shall submit a proposed exemption of railroad*
 7 *rights-of-way from the review under this chapter to*
 8 *the Council for its consideration, consistent with the*
 9 *exemption for interstate highways approved on March*
 10 *10, 2005 (70 Fed. Reg. 11,928).*

11 “(2) **FINAL EXEMPTION.**—*Not later than 180*

12 *projects, or program.*

14 *for which funds may be provided under subsection (a) in-*
15 *clude transportation planning activities that precede the*
16 *initiation of the environmental review process, activities di-*
17 *rectly related to the environmental review process, dedicated*
18 *staffing, training of agency personnel, information gath-*
19 *ering and mapping, and development of programmatic*
20 *agreements.*

21 “(c) *AMOUNTS.—Requests under subsection (a) may be*
22 *approved only for the additional amounts that the Sec-*
23 *retary determines are necessary for the Federal agencies,*
24 *State agencies, or Indian tribes participating in the envi-*

1 *ronmental planning and review process to timely conduct*
 2 *the reviews in an expedited manner.*

3 “(d) *AGREEMENTS.*—*Prior to providing funds ap-*
 4 *proved by the Secretary for dedicated staffing at an affected*
 5 *Federal agency under subsections (a) and (b), the affected*
 6 *Federal agency, State agency or Indian tribe, as appro-*
 7 *priate, and the requesting entity shall enter into an agree-*
 8 *ment that establishes a process to identify the projects or*
 9 *priorities to be addressed by the use of the funds.*

10 “(e) *RULE OF CONSTRUCTION.*—*Nothing in this sec-*
 11 *tion shall be construed to be inconsistent with or to interfere*
 12 *with section 139(j) of title 23.”.*

11 “(11) *The term ‘obligor’ means a party that—*

12 “(A) *is primarily liable for payment of the*
13 *principal of or interest on a direct loan or loan*
14 *guarantee under this section; and*

15 “(B) *may be a corporation, limited liability*
16 *company, partnership, joint venture, trust, or*
17 *governmental entity, agency, or instrumentality.*

18 “(12) *The term ‘project obligation’ means a note,*
19 *bond, debenture, or other debt obligation issued by a*
20 *borrower in connection with the financing of a*
21 *project, other than a direct loan or loan guarantee*
22 *under this title.*

23 “(13) *The term ‘railroad’ has the meaning given*
24 *the term ‘railroad carrier’ in section 20102 of title 49,*
25 *United States Code.*

1 “(14) The term ‘rating agency’ means a credit
2 rating agency registered with the Securities and Ex-
3 change Commission as a nationally recognized statis-
4 tical rating organization (as defined in section 3(a)
5 of the Securities Exchange Act of 1934 (15 U.S.C.
6 78c(a))).

7 “(15) The term ‘substantial completion’ means—
8 “(A) the opening of a project to passenger
9 or freight traffic; or
10 “(B) a comparable event, as determined by
11 the Secretary and specified in the direct loan.”.

12 **SEC. 603. ELIGIBLE APPLICANTS.**

13 Section 502(a) (45 U.S.C. 822(a)) is amended—

14 (1) in paragraph (5), by striking “one railroad;
15 and” and inserting “1 of the entities described in
16 paragraph (1), (2), (3), (4), or (6);”;

20 connection between a plant or facility and a rail car-
21 rier, limited option freight shippers that own or oper-

5 “(ii) is physically or functionally re-
6 lated to a passenger rail station or
7 multimodal station that includes rail serv-
8 ice;

9 “(iii) has a high probability of the ap-
10 plicant commencing the contracting process
11 for construction not later than 90 days after
12 the date on which the direct loan or loan
13 guarantee is obligated for the project under
14 this title; and

15 “(iv) has a high probability of reduc-
16 ing the need for financial assistance under
17 any other Federal program for the relevant
18 passenger rail station or service by increas-
19 ing ridership, tenant lease payments, or
20 other activities that generate revenue exceed-
21 ing costs.”.

22 **SEC. 605. PROGRAM ADMINISTRATION.**

16 “(C) *a brief description of the project, in-*
17 *cluding its purpose;*

18 “(D) *the requested direct loan or loan guar-*
19 *antee amount;*

20 “(E) *the date on which the Secretary pro-*
21 *vided application status notice under paragraph*
22 *(1); and*

23 “(F) *the date that the Secretary provided*
24 *notice of approval or disapproval under para-*
25 *graph (3).”.*

1 **(b) ADMINISTRATION OF DIRECT LOANS AND LOAN**
2 **GUARANTEES.—***Section 503 (45 U.S.C. 823) is amended—*

3 *(1) in subsection (a), by striking the period at*
4 *the end and inserting “, including a program guide*
5 *and standard term sheet and specific timetables.”;*

6 *(2) by redesignating subsections (c) through (l)*
7 *as subsections (d) through (m), respectively;*

8 *(3) by striking “(b) ASSIGNMENT OF LOAN*
9 *GUARANTEES.—” and inserting “(c) ASSIGNMENT OF*
10 *LOAN GUARANTEES.—”;*

11 *(4) in subsection (d), as redesignated—*

12 *(A) in paragraph (1), by striking “; and”*
13 *and inserting a semicolon;*

14 *(B) in paragraph (2), by striking the period*
15 *at the end and inserting “; and”; and*

16 *(C) by adding at the end the following:*

17 *“(3) the modification cost has been covered under*
18 *section 502(f).”;* and

19 *(5) by amending subsection (l), as redesignated,*
20 *to read as follows:*

21 **“(l) CHARGES AND LOAN SERVICING.—**

22 **“(1) PURPOSES.—***The Secretary may collect and*
23 *spend from each applicant, obligor, or loan party a*
24 *reasonable charge for—*

1 “(A) *the cost of evaluating the application,*
2 *amendments, modifications, and waivers, includ-*
3 *ing for evaluating project viability, applicant*
4 *creditworthiness, and the appraisal of the value*
5 *of the equipment or facilities for which the direct*
6 *loan or loan guarantee is sought, and for making*
7 *necessary determinations and findings;*

8 “(B) *the cost of award management and*
9 *project management oversight;*

10 “(C) *the cost of services from expert firms,*
11 *including counsel, and independent financial ad-*
12 *visors to assist in the underwriting, auditing,*
13 *servicing, and exercise of rights with respect to*
14 *direct loans and loan guarantees; and*

15 “(D) *the cost of all other expenses incurred*
16 *as a result of a breach of any term or condition*
17 *or any event of default on a direct loan or loan*
18 *guarantee.*

19 “(2) *STANDARDS.—The Secretary may charge*
20 *different amounts under this subsection based on the*
21 *different costs incurred under paragraph (1).*

22 “(3) *SERVICER.—*

23 “(A) *IN GENERAL.—The Secretary may ap-*
24 *point a financial entity to assist the Secretary*

1 *in servicing a direct loan or loan guarantee*
 2 *under this section.*

3 “(B) *DUTIES.*—*A servicer appointed under*
 4 *subparagraph (A) shall act as the agent of the*
 5 *Secretary in serving a direct loan or loan guar-*
 6 *antee under this section.*

7 “(C) *FEES.*—*A servicer appointed under*
 8 *subparagraph (A) shall receive a servicing fee*
 9 *from the obligor or other loan party, subject to*
 10 *approval by the Secretary.*

11 “(4) *USE OF OTHER FEDERAL FUNDS.*—*Notwith-*
 12 *standing any other provision of law, an applicant*
 13 *may use grants under chapter 244 of title 49, United*
 14 *States Code, to pay any charge under this subsection.*

15 “(5) *SAFETY AND OPERATIONS ACCOUNT.*—
 16 *Amounts collected under this subsection shall—*

17 “(A) *be credited directly to the Safety and*
 18 *Operations account of the Federal Railroad Ad-*
 19 *ministration; and*

20 “(B) *remain available until expended to*
 21 *pay for the costs described in this subsection.”.*

22 **SEC. 606. LOAN TERMS AND REPAYMENT.**

23 (a) *PREREQUISITES FOR ASSISTANCE.*—*Section*
 24 *502(g)(1) (45 U.S.C. 822(g)(1)) is amended by striking “35*
 25 *years from the date of its execution” and inserting “the less-*

1 *er of 35 years after the date of substantial completion of*
 2 *the project or the estimated useful life of the rail equipment*
 3 *or facilities to be acquired, rehabilitated, improved, devel-*
 4 *oped, or established”.*

5 *(b) REPAYMENT SCHEDULES.—Section 502(j) (45*
 6 *U.S.C. 822(j)) is amended—*

7 *(1) in paragraph (1), by striking “the sixth an-*
 8 *niversary date of the original loan disbursement” and*
 9 *inserting “5 years after the date of substantial com-*
 10 *pletion”; and*

11 *(2) by adding at the end the following:*

12 *“(3) DEFERRED PAYMENTS.—*

13 *“(A) IN GENERAL.—If at any time after the*
 14 *date of substantial completion the project is un-*
 15 *able to generate sufficient revenues to pay the*
 16 *scheduled loan repayments of principal and in-*
 17 *terest on the direct loan, the Secretary, subject to*
 18 *subparagraph (B), may allow, for a maximum*
 19 *aggregate time of 1 year over the duration of the*
 20 *direct loan, the obligor to add unpaid principal*
 21 *and interest to the outstanding balance of the di-*
 22 *rect loan.*

23 *“(B) INTEREST.—A payment deferred*
 24 *under subparagraph (A) shall—*

8 cess revenues that remain after satisfying sched-

14 prepay the direct loan without penalty.

10 *822), as amended in subsection (c), is further amended by*

12 “(l) *NONSUBORDINATION.*—

13 “(1) *IN GENERAL.*—*Except as provided in para-*
14 *graph (2)(B), a direct loan shall not be subordinated*
15 *to the claims of any holder of project obligations in*
16 *the event of bankruptcy, insolvency, or liquidation of*
17 *the obligor.*

18 “(2) *PREEXISTING INDENTURES.*—

19 “(A) *IN GENERAL.*—*The Secretary may*
20 *waive the requirement under paragraph (1) for*
21 *a public agency borrower that is financing ongo-*
22 *ing capital programs and has outstanding senior*
23 *bonds under a preexisting indenture if—*

24 “(i) *the direct loan is rated in the A*
25 *category or higher;*

1 “(ii) the direct loan is secured and
2 payable from pledged revenues not affected
3 by project performance, such as a tax-based
4 revenue pledge or a system-backed pledge of
5 project revenues; and

6 “(iii) the program share, under this
7 title, of eligible project costs is 50 percent or
8 less.

9 “(B) *LIMITATION.*—The Secretary may im-
10 pose limitations for the waiver of the non-
11 subordination requirement under this paragraph
12 if the Secretary determines that such limitations
13 would be in the financial interest of the Federal
14 Government.”.

15 **SEC. 607. CREDIT RISK PREMIUMS.**

3 *fund in whole or in part credit risk premiums and*
4 *modification costs with respect to the loan that is the*
5 *subject of the application or modification.”;*

6 *(2) in paragraph (2)—*

7 *(A) in subparagraph (D), by adding “and”*
8 *after the semicolon;*

9 *(B) by striking subparagraph (E); and*

10 *(C) by redesignating subparagraph (F) as*
11 *subparagraph (E);*

12 *(3) by striking paragraph (4);*

13 *(4) by redesignating paragraph (3) as para-*
14 *graph (4);*

15 *(5) by inserting after paragraph (2) the fol-*
16 *lowing:*

17 *“(3) CREDITWORTHINESS.—An applicant may*
18 *propose and the Secretary may accept as a basis for*
19 *determining the amount of the credit risk premium*
20 *under paragraph (2) any of the following in addition*
21 *to the value of any tangible asset:*

22 *“(A) The net present value of a future*
23 *stream of State or local subsidy income or other*
24 *dedicated revenues/revenue pledges to secure the*
25 *direct loan or loan guarantee.*

1 “(B) Adequate coverage requirements to en-
 2 sure repayment, on a non-recourse basis, from
 3 cash flows generated by the project or any other
 4 dedicated revenue source, including—

5 “(i) tolls;

6 “(ii) user fees; or

7 “(iii) payments owing to the obligor
 8 under a public-private partnership.

9 “(C) An investment-grade rating on the di-
 10 rect loan or loan guarantee, as applicable, except
 11 that if the total amount of the direct loan or loan
 12 guarantee is greater than \$75,000,000, the appli-
 13 cant shall have an investment-grade rating from
 14 at least 2 rating agencies on the direct loan or
 15 loan guarantee.”;

16 (6) in paragraph (4), as redesignated, by strik-
 17 ing “amounts” and inserting “amounts (and in the
 18 case of a modification, before the modification is exe-
 19 cuted), to the extent appropriations are not available
 20 to the Secretary to meet the costs of direct loans and
 21 loan guarantees, including costs of modifications
 22 thereof”; and

23 (7) by adding at the end the following:

24 “(5) USE OF OTHER FEDERAL FUNDS.—Notwith-
 25 standing any other provision of law, an applicant

1 *may use grants under chapter 244 of title 49, United*
 2 *States Code, to pay part or all of a credit risk pre-*
 3 *mium or modification cost under this subsection.”.*

8 *“(m) MASTER CREDIT AGREEMENTS.—*

9 *“(1) IN GENERAL.—Subject to section 502(d)*
 10 *and paragraph (2) of this subsection, the Secretary*
 11 *may enter into a master credit agreement that pro-*
 12 *vides for all of the conditions for the provision of a*
 13 *direct loan or loan guarantee, as applicable, under*
 14 *this title and other applicable requirements to be sat-*
 15 *isfied prior to the issuance of the direct loan or loan*
 16 *guarantee.*

17 *“(2) CONDITIONS.—Each master credit agree-*
 18 *ment shall—*

19 *“(A) establish the maximum amount and*
 20 *general terms and conditions of each applicable*
 21 *direct loan or loan guarantee;*

22 *“(B) identify 1 or more dedicated non-Fed-*
 23 *eral revenue sources that will secure the repay-*
 24 *ment of each applicable direct loan or loan guar-*
 25 *antee;*

1 “(C) provide for the obligation of funds for
2 the direct loans or loan guarantees after all re-
3 quirements have been met for the projects subject
4 to the master credit agreement; and

5 “(D) provide 1 or more dates, as determined
6 by the Secretary, before which the master credit
7 agreement results in each of the direct loans or
8 loan guarantees or in the release of the master
9 credit agreement.”.

10 **SEC. 609. PRIORITIES AND CONDITIONS.**

11 (a) *PRIORITY PROJECTS.*—Section 502(c) (45 U.S.C.
12 822(c)) is amended—

13 (1) in paragraph (1), by inserting “, including
14 projects for the installation of a positive train control
15 system (as defined in section 20157(i) of title 49,
16 United States Code)” after “public safety”;

17 (2) by redesignating paragraphs (2) and (3) as
18 paragraphs (3) and (2), respectively;

19 (3) in paragraph (5), by inserting “or chapter
20 227 of title 49” after “section 135 of title 23”;

21 (4) by redesignating paragraphs (6) through (8)
22 as paragraphs (7) through (9), respectively; and

23 (5) by inserting after paragraph (5) the fol-
24 lowing:

1 “(6) improve railroad stations and passenger fa-
2 cilities and increase transit-oriented development;”.

3 (b) *CONDITIONS OF ASSISTANCE*.—Section 502(h) (45
4 *U.S.C. 822(h)*) is amended—

5 (1) in paragraph (2), by inserting “, if applica-
6 ble” after “project”; and

7 (2) by adding at the end the following:

8 “(4) For a project described in subsection
9 (b)(1)(E), the Secretary shall require the applicant,
10 obligor, or other loan party, in addition to the inter-
11 est required under subsection (e), to provide the spon-
12 sor of the intercity passenger rail service or its des-
13 ignee, a fee or payment in an amount determined ap-
14 propriate by the Secretary to provide an equitable
15 share of project revenue to support the capital or op-
16 erating costs of the routes serving the passenger rail
17 station or multimodal station where the development
18 is located.”.

19 **SEC. 610. SAVINGS PROVISION.**

20 (a) *IN GENERAL*.—Except as provided in subsection
21 (b), this Act, and the amendments made by this Act, shall
22 not affect any direct loan (or direct loan obligation) or an
23 outstanding loan guarantee (or loan guarantee commit-
24 ment) that was in effect prior to the date of enactment of
25 this Act. Any such transaction entered into before the date

1 *of enactment of this Act shall be administered until comple-*
2 *tion under its terms as if this Act were not enacted.*

3 **(b) MODIFICATION COSTS.**—*At the discretion of the*
4 *Secretary, the authority to accept modification costs on be-*
5 *half of an applicant under section 502(f) of the Railroad*
6 *Revitalization and Regulatory Reform Act of 1976 (45*
7 *U.S.C. 822(f)), as amended by section 607 of this Act, may*
8 *apply with respect to any direct loan (or direct loan obliga-*
9 *tion) or an outstanding loan guarantee (or loan guarantee*
10 *commitment) that was in effect prior to the date of enact-*
11 *ment of this Act.*
