## **AN ACT**

To designate the area between the intersections of International Drive, Northwest and Van Ness Street, Northwest and International Drive, Northwest and International Place, Northwest in Washington, District of Columbia, as “Liu Xiaobo Plaza”, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. DESIGNATION OF LIU XIAOBO PLAZA.**

4        (a) DESIGNATION OF PLAZA.—

5            (1) IN GENERAL.—The area between the inter-  
6 sections of International Drive, Northwest and Van  
7 Ness Street, Northwest and International Drive,  
8 Northwest and International Place, Northwest in  
9 Washington, District of Columbia, shall be known  
10 and designated as “Liu Xiaobo Plaza”.

11            (2) REFERENCES.—Any reference in a law,  
12 map, regulation, document, paper, or other record of  
13 the area referred to in paragraph (1) shall be  
14 deemed to be a reference to Liu Xiaobo Plaza.

15        (b) DESIGNATION OF ADDRESS.—

16            (1) DESIGNATION.—The address of 3505 Inter-  
17 national Place, Northwest, Washington, District of  
18 Columbia, shall be redesignated as 1 Liu Xiaobo  
19 Plaza.

20            (2) REFERENCES.—Any reference in a law,  
21 map, regulation, document, paper, or other record of  
22 the United States to the address referred to in para-  
23 graph (1) shall be deemed to be a reference to 1 Liu  
24 Xiaobo Plaza.

1 (c) SIGNS.—The Administrator of General Services  
2 shall construct street signs that shall—

3 (1) contain the phrase “Liu Xiaobo Plaza”;

4 (2) be similar in design to the signs used by  
5 Washington, District of Columbia, to designate the  
6 location of Metro stations; and

7 (3) be placed on—

8 (A) the parcel of Federal property that is  
9 closest to 1 Liu Xiaobo Plaza (as redesignated  
10 by subsection (b)); and

11 (B) the street corners of International  
12 Drive, Northwest and Van Ness Street, North-  
13 west and International Drive, Northwest and  
14 International Place, Northwest, Washington,  
15 District of Columbia.
