A BILL

To amend the Safe Drinking Water Act to reauthorize technical assistance to small public water systems, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Grassroots Rural and
5 Small Community Water Systems Assistance Act”.

6 **SEC. 2. FINDINGS.**

7 Congress finds that—

1 (1) the Safe Drinking Water Act Amendments
2 of 1996 (Public Law 104–182) authorized technical
3 assistance for small and rural communities to assist
4 those communities in complying with regulations
5 promulgated pursuant to the Safe Drinking Water
6 Act (42 U.S.C. 300f et seq.);

7 (2) technical assistance and compliance train-
8 ing—

9 (A) ensures that Federal regulations do
10 not overwhelm the resources of small and rural
11 communities; and

12 (B) provides small and rural communities
13 lacking technical resources with the necessary
14 skills to improve and protect water resources;

15 (3) across the United States, more than 90 per-
16 cent of the community water systems serve a popu-
17 lation of less than 10,000 individuals;

18 (4) small and rural communities have the great-
19 est difficulty providing safe, affordable public drink-
20 ing water and wastewater services due to limited
21 economies of scale and lack of technical expertise;
22 and

23 (5) in addition to being the main source of com-
24 pliance assistance, small and rural water technical

1 assistance has been the main source of emergency
2 response assistance in small and rural communities.

3 **SEC. 3. SENSE OF CONGRESS.**

4 It is the sense of Congress that—

5 (1) to assist small and rural communities most
6 effectively, the Administrator of the Environmental
7 Protection Agency should prioritize the types of
8 technical assistance that are most beneficial to those
9 communities, based on input from those commu-
10 nities; and

11 (2) local support is the key to making Federal
12 assistance initiatives work in small and rural com-
13 munities to the maximum benefit.

14 **SEC. 4. FUNDING PRIORITIES.**

15 Section 1442(e) of the Safe Drinking Water Act (42
16 U.S.C. 300j-1(e)) is amended—

17 (1) by designating the first through seventh
18 sentences as paragraphs (1) through (7), respec-
19 tively;

20 (2) in paragraph (5) (as so designated), by
21 striking “1997 through 2003” and inserting “2015
22 through 2020”; and

23 (3) by adding at the end the following:

24 “(8) NONPROFIT ORGANIZATIONS.—

1 “(A) IN GENERAL.—The Administrator
2 may use amounts made available to carry out
3 this section to provide grants or cooperative
4 agreements to nonprofit organizations that pro-
5 vide to small public water systems onsite tech-
6 nical assistance, circuit-rider technical assist-
7 ance programs, multistate, regional technical
8 assistance programs, onsite and regional train-
9 ing, assistance with implementing source water
10 protection plans, and assistance with imple-
11 menting monitoring plans, rules, regulations,
12 and water security enhancements.

13 “(B) PREFERENCE.—To ensure that tech-
14 nical assistance funding is used in a manner
15 that is most beneficial to the small and rural
16 communities of a State, the Administrator shall
17 give preference under this paragraph to non-
18 profit organizations that, as determined by the
19 Administrator, are the most qualified and expe-
20 rienced in providing training and technical as-
21 sistance to small public water systems and that
22 the small community water systems in that
23 State find to be the most beneficial and effec-
24 tive.

1 “(C) LIMITATION.—No grant or coopera-
2 tive agreement provided or otherwise made
3 available under this section may be used for liti-
4 gation pursuant to section 1449.”.
