**AN ACT**

To authorize the National Emergency Medical Services Memorial Foundation to establish a commemorative work in the District of Columbia and its environs, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2        *tives of the United States of America in Congress assembled,*

3        **SECTION 1. AUTHORIZATION TO ESTABLISH COMMEMORA-**  
4        **TIVE WORK.**

5        (a) IN GENERAL.—The National Emergency Medical  
6        Services Memorial Foundation may establish a commemo-  
7        rative work on Federal land in the District of Columbia  
8        and its environs to commemorate the commitment and  
9        service represented by emergency medical services.

1 (b) COMPLIANCE WITH STANDARDS FOR COMMEMO-  
2 RATIVE WORKS.—The establishment of the commemora-  
3 tive work under this section shall be in accordance with  
4 chapter 89 of title 40, United States Code (commonly  
5 known as the “Commemorative Works Act”).

6 (c) PROHIBITION ON THE USE OF FEDERAL  
7 FUNDS.—

8 (1) IN GENERAL.—Federal funds may not be  
9 used to pay any expense of the establishment of the  
10 commemorative work under this section.

11 (2) RESPONSIBILITY OF NATIONAL EMERGENCY  
12 MEDICAL SERVICES MEMORIAL FOUNDATION.—The  
13 National Emergency Medical Services Memorial  
14 Foundation shall be solely responsible for acceptance  
15 of contributions for, and payment of the expenses of,  
16 the establishment of the commemorative work under  
17 this section.

18 (d) DEPOSIT OF EXCESS FUNDS.—

19 (1) IN GENERAL.—If upon payment of all ex-  
20 penses for the establishment of the memorial (in-  
21 cluding the maintenance and preservation amount  
22 required by section 8906(b)(1) of title 40, United  
23 States Code), there remains a balance of funds re-  
24 ceived for the establishment of the commemorative  
25 work, the Foundation shall transmit the amount of

1 the balance to the Secretary of the Interior for de-  
2 posit in the account provided for in section  
3 8906(b)(3) of title 40, United States Code.

4 (2) ON EXPIRATION OF AUTHORITY.—If upon  
5 expiration of the authority for the commemorative  
6 work under section 8903(e) of title 40, United  
7 States Code, there remains a balance of funds re-  
8 ceived for the establishment of the commemorative  
9 work, the Foundation shall transmit the amount of  
10 the balance to a separate account with the National  
11 Park Foundation for memorials, to be available to  
12 the Secretary of the Interior or Administrator (as  
13 appropriate) following the process provided in sec-  
14 tion 8906(b)(4) of title 40, United States Code, for  
15 accounts established under 8906(b)(2) or (3) of title  
16 40, United States Code.
