A BILL

To amend title XVIII of the Social Security Act to prohibit prescription drug plan sponsors and MA–PD organizations under the Medicare program from retroactively reducing payment on clean claims submitted by pharmacies.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Improving Trans-
3 parency and Accuracy in Medicare Part D Spending Act”.

4 **SEC. 2. PROHIBITING MEDICARE PDP SPONSORS AND MA-
5 PD ORGANIZATIONS FROM RETROACTIVELY
6 REDUCING PAYMENT ON CLEAN CLAIMS SUB-
7 MITTED BY PHARMACIES.**

8 (a) IN GENERAL.—Section 1860D–12(b)(4)(A) of
9 the Social Security Act (42 U.S.C. 1395w–112(b)(4)(A))
10 is amended by adding at the end the following new clause:

11 “(iv) PROHIBITING RETROACTIVE RE-
12 Ductions IN PAYMENTS ON CLEAN
13 CLAIMS.—Each contract entered into with
14 a PDP sponsor under this part with re-
15 spect to a prescription drug plan offered
16 by such sponsor shall provide that after
17 the date of receipt of a clean claim sub-
18 mitted by a pharmacy, the PDP sponsor
19 (or an agent of the PDP sponsor) may not
20 retroactively reduce payment on such claim
21 directly or indirectly through aggregated
22 effective rate or otherwise except in the
23 case such claim is found to not be a clean
24 claim (such as in the case of a claim lack-
25 ing required substantiating documentation)
26 during the course of a routine audit as

1 permitted pursuant to written agreement
2 between the PDP sponsor (or such an
3 agent) and such pharmacy. The previous
4 sentence shall not prohibit any retroactive
5 increase in payment to a pharmacy pursu-
6 ant to a written agreement between a PDP
7 sponsor (or an agent of such sponsor) and
8 such pharmacy.”.

9 (b) EFFECTIVE DATE.—The amendment made by
10 subsection (a) shall apply with respect to contracts entered
11 into on or after January 1, 2018.
