A BILL

To amend title 38, United States Code, to authorize the Secretary of Veterans Affairs to provide for an operation on a live donor for purposes of conducting a transplant procedure for a veteran, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Veterans Transplant
3 Coverage Act of 2017”.

4 **SEC. 2. AUTHORIZATION TO PROVIDE FOR OPERATIONS ON**
5 **LIVE DONORS FOR PURPOSES OF CON-**
6 **DUCTING TRANSPLANT PROCEDURES FOR**
7 **VETERANS.**

8 (a) IN GENERAL.—Subchapter VIII of chapter 17 of
9 title 38, United States Code, is amended by adding at the
10 end the following new section:

11 **“§ 1788. Transplant procedures with live donors and**
12 **related services**

13 “(a) IN GENERAL.—In a case in which a veteran is
14 eligible for a transplant procedure from the Department,
15 the Secretary may provide for an operation on a live donor
16 to carry out such procedure for such veteran, notwith-
17 standing that the live donor may not be eligible for health
18 care from the Department.

19 “(b) OTHER SERVICES.—The Secretary shall furnish
20 to a live donor any care or services before and after con-
21 ducting the transplant procedure under subsection (a)
22 that may be required in connection with such procedure.

23 “(c) USE OF DEPARTMENT OR NON-DEPARTMENT
24 FACILITIES.—The Secretary may provide for the oper-
25 ation described in subsection (a) on a live donor and fur-
26 nish to the live donor the care and services described in

1 subsection (b) at a facility of the Department or at a non-
2 Department facility pursuant to an agreement entered
3 into by the Secretary under section 1703 or 8153 of this
4 title, section 101 of the Veterans Access, Choice, and Ac-
5 countability Act of 2014 (Public Law 113–146; 38 U.S.C.
6 1701 note), or any other authority of the Secretary to fur-
7 nish care at non-Department facilities. The live donor
8 shall be deemed to be an individual eligible for hospital
9 care and medical services at a non-Department facility
10 pursuant to such an agreement solely for the purposes of
11 receiving such operation, care, and services at the non-
12 Department facility.”.

13 (b) CLERICAL AMENDMENT.—The table of sections
14 at the beginning of chapter 17 of such title is amended
15 by inserting after the item relating to section 1787 the
16 following new item:

“1788. Transplant procedures with live donors and related services.”.
