1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. HISTORICALLY BLACK COLLEGES AND UNIVER-**  
4               **SITIES HISTORIC PRESERVATION PROGRAM**  
5               **REAUTHORIZED.**

6       Section 507(d)(2) of the Omnibus Parks and Public  
7       Lands Management Act of 1996 (54 U.S.C. 302101 note)  
8       is amended by striking the period at the end and inserting  
9       “and each of fiscal years 2018 through 2024.”.
