## **AN ACT**

To amend the Employee Retirement Income Security Act of 1974, the Public Health Service Act, and the Internal Revenue Code of 1986 to exclude from the definition of health insurance coverage certain medical stop-loss insurance obtained by certain plan sponsors of group health plans.

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Self-Insurance Protec-
- 5 tion Act".
- 6 SEC. 2. CERTAIN MEDICAL STOP-LOSS INSURANCE OB-
- 7 TAINED BY CERTAIN PLAN SPONSORS OF
- 8 GROUP HEALTH PLANS NOT INCLUDED
- 9 UNDER THE DEFINITION OF HEALTH INSUR-
- 10 ANCE COVERAGE.
- 11 (a) ERISA.—Section 733(b)(1) of the Employee Re-
- 12 tirement Income Security Act of 1974 (29 U.S.C.
- 13 1191b(b)(1)) is amended by adding at the end the fol-
- 14 lowing sentence: "Such term shall not include a stop-loss
- 15 policy obtained by a self-insured health plan or a plan
- 16 sponsor of a group health plan that self-insures the health
- 17 risks of its plan participants to reimburse the plan or
- 18 sponsor for losses that the plan or sponsor incurs in pro-
- 19 viding health or medical benefits to such plan participants
- 20 in excess of a predetermined level set forth in the stop-
- 21 loss policy obtained by such plan or sponsor.".
- 22 (b) PHSA.—Section 2791(b)(1) of the Public Health
- 23 Service Act (42 U.S.C. 300gg-91(b)(1)) is amended by
- 24 adding at the end the following new sentence: "Such term
- 25 shall not include a stop-loss policy obtained by a self-in-

- 1 sured health plan or a plan sponsor of a group health plan
- 2 that self-insures the health risks of its plan participants
- 3 to reimburse the plan or sponsor for losses that the plan
- 4 or sponsor incurs in providing health or medical benefits
- 5 to such plan participants in excess of a predetermined level
- 6 set forth in the stop-loss policy obtained by such plan or
- 7 sponsor.".
- 8 (c) IRC.—Section 9832(b)(1)(A) of the Internal Rev-
- 9 enue Code of 1986 is amended by adding at the end the
- 10 following new sentence: "Such term shall not include a
- 11 stop-loss policy obtained by a self-insured health plan or
- 12 a plan sponsor of a group health plan that self-insures
- 13 the health risks of its plan participants to reimburse the
- 14 plan or sponsor for losses that the plan or sponsor incurs
- 15 in providing health or medical benefits to such plan par-
- 16 ticipants in excess of a predetermined level set forth in
- 17 the stop-loss policy obtained by such plan or sponsor.".
