- 4 SEC. 2. INCREASE IN RATES OF DISABILITY COMPENSA-
- 5 TION AND DEPENDENCY AND INDEMNITY

- 7 (a) Rate Adjustment.—Effective on December 1,
- 8 2017, the Secretary of Veterans Affairs shall increase, in
- 9 accordance with subsection (c), the dollar amounts in ef-
- 10 fect on November 30, 2017, for the payment of disability
- 11 compensation and dependency and indemnity compensa-
- 12 tion under the provisions specified in subsection (b).
- 13 (b) Amounts To Be Increased.—The dollar
- 14 amounts to be increased pursuant to subsection (a) are
- 15 the following:
- 16 (1) Wartime disability compensation.—
- Each of the dollar amounts under section 1114 of
- title 38, United States Code.
- 19 (2) Additional compensation for depend-
- 20 Ents.—Each of the dollar amounts under section
- 21 1115(1) of such title.
- 22 (3) CLOTHING ALLOWANCE.—The dollar
- amount under section 1162 of such title.
- 24 (4) Dependency and indemnity compensa-
- 25 TION TO SURVIVING SPOUSE.—Each of the dollar

- 1 amounts under subsections (a) through (d) of sec-
- 2 tion 1311 of such title.
- 3 (5) Dependency and indemnity compensa-
- 4 TION TO CHILDREN.—Each of the dollar amounts
- 5 under sections 1313(a) and 1314 of such title.
- 6 (c) Determination of Increase.—Each dollar
- 7 amount described in subsection (b) shall be increased by
- 8 the same percentage as the percentage by which benefit
- 9 amounts payable under title II of the Social Security Act
- 10 (42 U.S.C. 401 et seq.) are increased effective December
- 11 1, 2017, as a result of a determination under section
- 12 215(i) of such Act (42 U.S.C. 415(i)).
- 13 (d) Special Rule.—The Secretary of Veterans Af-
- 14 fairs may adjust administratively, consistent with the in-
- 15 creases made under subsection (a), the rates of disability
- 16 compensation payable to persons under section 10 of Pub-
- 17 lie Law 85–857 (72 Stat. 1263) who have not received
- 18 compensation under chapter 11 of title 38, United States
- 19 Code.

20 SEC. 3. PUBLICATION OF ADJUSTED RATES.

- 21 The Secretary of Veterans Affairs shall publish in the
- 22 Federal Register the amounts specified in section 2(b), as
- 23 increased under that section, not later than the date on
- 24 which the matters specified in section 215(i)(2)(D) of the
- 25 Social Security Act (42 U.S.C. 415(i)(2)(D)) are required

- 1 to be published by reason of a determination made under
- $2 \;$ section 215(i) of such Act during fiscal year 2018.
