A BILL

To amend the Homeland Security Act of 2002 to ensure that the needs of children are considered in homeland security planning, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Homeland Security for*
5 *Children Act”.*

6 **SEC. 2. RESPONSIBILITIES OF THE UNDER SECRETARY FOR**
7 **STRATEGY, POLICY, AND PLANS.**

8 *Paragraph (6) of section 709(c) of the Homeland Secu-*
9 *rity Act of 2002 (6 U.S.C. 349(c)) is amended by inserting*
10 *“, including feedback from organizations representing the*
11 *needs of children,” after “stakeholder feedback”.*

12 **SEC. 3. TECHNICAL EXPERT AUTHORIZED.**

13 *Paragraph (2) of section 503(b) of the Homeland Secu-*
14 *rity Act of 2002 (6 U.S.C. 313(b)) is amended—*

15 *(1) in subparagraph (G), by striking “and” at*
16 *the end;*

17 *(2) in subparagraph (H), by striking the period*
18 *at the end and inserting “; and”; and*

19 *(3) by adding at the end the following new sub-*
20 *paragraph:*

21 *“(I) identify and integrate the needs of chil-*
22 *dren into activities to prepare for, protect*
23 *against, respond to, recover from, and mitigate*
24 *against the risk of natural disasters, acts of ter-*
25 *rorism, and other manmade disasters, including*

1 *catastrophic incidents, including by appointing*
2 *a technical expert, who may consult with rel-*
3 *evant outside organizations and experts, as nec-*
4 *essary, to coordinate such integration, as nec-*
5 *essary.”.*

6 **SEC. 4. REPORT.**

7 *Not later than one year after the date of the enactment*
8 *of this Act and annually thereafter for five years, the Under*
9 *Secretary for Strategy, Policy, and Plans of the Depart-*
10 *ment of Homeland Security shall submit to the Committee*
11 *on Homeland Security of the House of Representatives and*
12 *the Committee on Homeland Security and Governmental*
13 *Affairs of the Senate a report describing the efforts the De-*
14 *partment has undertaken to review and incorporate feed-*
15 *back from organizations representing the needs of children*
16 *into Department policy in accordance with paragraph (6)*
17 *of section 709(c) of the Homeland Security Act of 2002 (as*
18 *added by section 2 of this Act), including information on*
19 *the following:*

20 *(1) The designation of any individual respon-*
21 *sible for carrying out such paragraph (6).*

22 *(2) Any review, formal or informal, of Depart-*
23 *ment policies, programs, or activities to assess the*
24 *suitability of such policies, programs, or activities for*
25 *children and where feedback from organizations rep-*

1 *resenting the needs of children should be reviewed and*
2 *incorporated.*

3 *(3) Any review, change, modification, or promul-*
4 *gation of Department policies, programs, or activities*
5 *to ensure that such policies, programs, or activities*
6 *are appropriate for children.*

7 *(4) Coordination with organizations or experts*
8 *outside the Department pursuant to such paragraph*
9 *(6) conducted to inform any such review, change,*
10 *modification, or promulgation of such policies, pro-*
11 *grams, or activities.*
