SHORT TITLE.** This Act may be cited as the "National Law Enforce-4 5 ment Museum Exhibits Act". 6 SEC. 2. AUTHORITY OF NATIONAL LAW ENFORCEMENT MU-7 SEUM TO ACQUIRE, RECEIVE, POSSESS, COL-8 LECT, SHIP, TRANSPORT, IMPORT, AND DIS-9 PLAY FIREARMS. 10 The National Law Enforcement Museum Act (Public Law 106–492) is amended by adding at the end the fol-11 12 lowing: 13 "SEC. 5. AUTHORITY OF MUSEUM TO ACQUIRE, RECEIVE, 14 POSSESS, COLLECT, SHIP, TRANSPORT, IM-15 PORT, AND DISPLAY FIREARMS. "(a) IN GENERAL.—Notwithstanding any other pro-16 vision of Federal law, or any law or any rule or regulations 17 18 of a State or any political subdivision thereof, the Museum may acquire, receive, possess, collect, ship, transport, im-19 port, and display firearms (as defined in section 921(a)(3)) 20 21 of title 18, United States Code, or section 5845(a) of the 22 Internal Revenue Code of 1986) in fulfilling the purposes 23 of the Museum. 24 "(b) DEFINITION OF STATE.—In subsection (a), the

term 'State' means the several States, the District of Co-
