#### 115TH CONGRESS 1ST SESSION H.R. 1491

### **AN ACT**

- To reaffirm the action of the Secretary of the Interior to take land into trust for the benefit of the Santa Ynez Band of Chumash Mission Indians, and for other purposes.
  - 1 Be it enacted by the Senate and House of Representa-
  - 2 tives of the United States of America in Congress assembled,

#### 1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the "Santa Ynez Band of3 Chumash Indians Land Affirmation Act of 2017".

#### 4 SEC. 2. FINDINGS.

5 Congress finds the following:

6 (1) On October 13, 2017, the General Council 7 of the Santa Ynez Band of Chumash Indians voted 8 to approve the Memorandum of Agreement between 9 the County of Santa Barbara and the Santa Ynez Band of Chumash Indians regarding the approxi-10 11 mately 1,427.28 acres of land, commonly known as 12 Camp 4, and authorized the Tribal Chairman to sign 13 the Memorandum of Agreement.

14 (2) On October 31, 2017, the Board of Super15 visors for the County of Santa Barbara approved the
16 Memorandum of Agreement on Camp 4 and author17 ized the Chair to sign the Memorandum of Agree18 ment.

19 (3) The Secretary of the Interior approved the
20 Memorandum of Agreement pursuant to section
21 2103 of the Revised Statutes (25 U.S.C. 81).

#### 22 SEC. 3. REAFFIRMATION OF STATUS AND ACTIONS.

(a) RATIFICATION OF TRUST STATUS.—The action
taken by the Secretary on January 20, 2017, to place approximately 1,427.28 acres of land located in Santa Barbara County, California, into trust for the benefit of the

Santa Ynez Band of Chumash Indians is hereby ratified
 and confirmed as if that action had been taken under a
 Federal law specifically authorizing or directing that ac tion.

5 (b) RATIFICATION OF ACTIONS OF THESEC-RETARY.—The actions taken by the Secretary to assume 6 7 jurisdiction over the appeals relating to the fee-to-trust ac-8 quisition of approximately 1,427.28 acres in Santa Bar-9 bara County, California, on January 30, 2015, is hereby 10 ratified and confirmed as if that action had been taken under a Federal law specifically authorizing or directing 11 12 that action.

13 (c) RATIFICATION OF ACTIONS OF THE SEC-RETARY.—The actions taken by the Secretary to dismiss 14 15 the appeals relating to the fee-to-trust acquisition of approximately 1,427.28 acres in Santa Barbara County, 16 17 California, on January 19, 2017, is hereby ratified and 18 confirmed as if that action had been taken under a Fed-19 eral law specifically authorizing or directing that action. 20 (d) Administration.—

(1) ADMINISTRATION.—The land placed into
trust for the benefit of the Santa Ynez Band of
Chumash Indians by the Secretary of the Interior on
January 20, 2017, shall be a part of the Santa Ynez
Indian Reservation and administered in accordance

with the laws and regulations generally applicable to
 the land held in trust by the United States for an
 Indian tribe.

4 (2) EFFECT.—For purposes of certain Cali-5 fornia State laws (including the California Land 6 Conservation Act of 1965, Government Code Section 7 51200, et seq.), placing the land described in sub-8 section (b) into trust shall remove any restrictions 9 on the property pursuant to California Government 10 Code Section 51295 or any other provision of such 11 Act.

21 (f) RULES OF CONSTRUCTION.—Nothing in this Act22 shall—

(1) enlarge, impair, or otherwise affect anyright or claim of the Tribe to any land or interest

1 in land that is in existence before the date of the en-2 actment of this Act; 3 (2) affect any water right of the Tribe in existence before the date of the enactment of this Act; 4 5 or 6 (3) terminate or limit any access in any way to 7 any right-of-way or right-of-use issued, granted, or 8 permitted before the date of the enactment of this 9 Act. 10 (g) RESTRICTED USE OF TRANSFERRED LANDS.— 11 The Tribe may not conduct, on the land described in sub-12 section (b) taken into trust for the Tribe pursuant to this 13 Act, gaming activities— 14 (1) as a matter of claimed inherent authority; 15 or 16 (2) under any Federal law, including the Indian 17 Gaming Regulatory Act (25 U.S.C. 2701 et seq.) 18 and regulations promulgated by the Secretary or the 19 National Indian Gaming Commission under that 20 Act. 21 (h) DEFINITIONS.—For the purposes of this section: (1) SECRETARY.—The term "Secretary" means 22 23 the Secretary of the Interior.

(2) TRIBE.—The term "Tribe" means the
 Santa Ynez Band of Chumash Mission Indians.
