# **A BILL**

To reaffirm the action of the Secretary of the Interior to take land into trust for the benefit of the Santa Ynez Band of Chumash Mission Indians, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Santa Ynez Band of*  
5 *Chumash Indians Land Affirmation Act of 2017”.*

6 **SEC. 2. REAFFIRMATION OF STATUS AND ACTIONS.**

7 *(a) RATIFICATION OF TRUST STATUS.—The action*  
8 *taken by the Secretary on January 20, 2017, to place ap-*  
9 *proximately 1,427.28 acres of land located in Santa Bar-*  
10 *bara County, California, into trust for the benefit of the*  
11 *Santa Ynez Band of Chumash Indians is hereby ratified*  
12 *and confirmed as if that action had been taken under a*  
13 *Federal law specifically authorizing or directing that ac-*  
14 *tion.*

15 *(b) RATIFICATION OF ACTIONS OF THE SECRETARY.—*  
16 *The actions taken by the Secretary to assume jurisdiction*  
17 *over the appeals relating to the fee-to-trust acquisition of*  
18 *approximately 1,427.28 acres in Santa Barbara County,*  
19 *California, on January 30, 2015, is hereby ratified and*  
20 *confirmed as if that action had been taken under a Federal*  
21 *law specifically authorizing or directing that action.*

22 *(c) RATIFICATION OF ACTIONS OF THE SECRETARY.—*  
23 *The actions taken by the Secretary to dismiss the appeals*  
24 *relating to the fee-to-trust acquisition of approximately*  
25 *1,427.28 acres in Santa Barbara County, California, on*

1 *January 19, 2017, is hereby ratified and confirmed as if*  
2 *that action had been taken under a Federal law specifically*  
3 *authorizing or directing that action.*

4 *(d) ADMINISTRATION.—*

5 *(1) ADMINISTRATION.—The land placed into*  
6 *trust for the benefit of the Santa Ynez Band of*  
7 *Chumash Indians by the Secretary of the Interior on*  
8 *January 20, 2017, shall be a part of the Santa Ynez*  
9 *Indian Reservation and administered in accordance*  
10 *with the laws and regulations generally applicable to*  
11 *the land held in trust by the United States for an In-*  
12 *dian tribe.*

13 *(2) EFFECT.—For purposes of certain California*  
14 *State laws (including the California Land Conserva-*  
15 *tion Act of 1965, Government Code Section 51200, et*  
16 *seq.), placing the land described in subsection (b) into*  
17 *trust shall remove any restrictions on the property*  
18 *pursuant to California Government Code Section*  
19 *51295 or any other provision of such Act.*

20 *(e) LEGAL DESCRIPTION OF LANDS TRANSFERRED.—*

21 *The lands to be transferred pursuant to this Act are de-*

1       (f) *RULES OF CONSTRUCTION.*—*Nothing in this Act*  
2 *shall—*

3           (1) *enlarge, impair, or otherwise affect any right*  
4 *or claim of the Tribe to any land or interest in land*  
5 *that is in existence before the date of the enactment*  
6 *of this Act;*

7           (2) *affect any water right of the Tribe in exist-*  
8 *ence before the date of the enactment of this Act; or*

9           (3) *terminate or limit any access in any way to*  
10 *any right-of-way or right-of-use issued, granted, or*  
11 *permitted before the date of the enactment of this Act.*

12       (g) *RESTRICTED USE OF TRANSFERRED LANDS.*—*The*  
13 *Tribe may not conduct, on the land described in subsection*  
14 *(b) taken into trust for the Tribe pursuant to this Act, gam-*  
15 *ing activities—*

16           (1) *as a matter of claimed inherent authority; or*

17           (2) *under any Federal law, including the Indian*  
18 *Gaming Regulatory Act (25 U.S.C. 2701 et seq.) and*  
19 *regulations promulgated by the Secretary or the Na-*  
20 *tional Indian Gaming Commission under that Act.*

21       (h) *DEFINITIONS.*—*For the purposes of this section:*

22           (1) *SECRETARY.*—*The term “Secretary” means*  
23 *the Secretary of the Interior.*

24           (2) *TRIBE.*—*The term “Tribe” means the Santa*  
25 *Ynez Band of Chumash Mission Indians.*
