A BILL

To direct the Administrator of the Federal Emergency Management Agency to provide technical assistance to common interest communities regarding eligibility for disaster assistance, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Disaster Assistance Sup-*
5 *port for Communities and Homeowners Act of 2017”.*

6 **SEC. 2. TECHNICAL ASSISTANCE AND RECOMMENDATIONS.**

7 (a) *TECHNICAL ASSISTANCE.*—*The Administrator of*
8 *the Federal Emergency Management Agency shall provide*
9 *technical assistance to a common interest community that*
10 *provides essential services of a governmental nature on ac-*
11 *tions that a common interest community may take in order*
12 *to be eligible to receive reimbursement from a grantee that*
13 *receives funds from the Agency for certain activities per-*
14 *formed after an event that results in a disaster declaration.*

15 (b) *RECOMMENDATIONS.*—*Not later than 90 days after*
16 *the date of enactment of this Act, the Administrator shall*
17 *provide to the Committee on Transportation and Infra-*
18 *structure of the House of Representatives and the Committee*
19 *on Homeland Security and Governmental Affairs of the*
20 *Senate a legislative proposal on how to provide eligibility*
21 *for disaster assistance with respect to common areas of con-*
22 *dominiums and housing cooperatives.*
