A BILL

To direct the Secretary of Agriculture to transfer certain Federal land to facilitate scientific research supporting Federal space and defense programs.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. LAND CONVEYANCE, WASATCH-CACHE NA-**
 4 **TIONAL FOREST, RICH COUNTY, UTAH.**

5 (a) *LAND CONVEYANCE AUTHORIZED.*—Subject to
 6 *valid existing rights, not later than 6 months after the date*
 7 *of the enactment of this section, the Secretary of Agriculture*
 8 *shall convey, without consideration, to the Utah State Uni-*
 9 *versity Research Foundation, (in this section referred to as*
 10 *the “Foundation”)* all right, title, and interest of the United
 11 States in and to a parcel of real property consisting of ap-
 12 proximately 80 acres, including improvements thereon, lo-
 13 cated outside of the boundaries of the Wasatch-Cache Na-
 14 tional Forest, Rich County, Utah, within Sections 19 and
 15 30, Township 14 North, Range 5 East, Salt Lake Base and
 16 Meridian for the purpose of permitting the Foundation to
 17 use the property for scientific and educational purposes.

18 (b) *REVERSIONARY INTEREST.*—If the Secretary of Ag-
 19 riculture determines at any time that the real property con-
 20 veyed under subsection (a) is not being used in accordance
 21 with the purpose of the conveyance specified in such sub-
 22 section, all right, title and interest in and to such real prop-
 23 erty, including any improvements thereto, shall, at the op-
 24 tion of the Secretary, revert to and become the property of
 25 the United States, and the United States shall have the

1 *right of immediate entry onto such real property. A deter-*
 2 *mination by the Secretary under this subsection shall be*
 3 *made on the record after an opportunity for a hearing.*

4 *(c) PAYMENT OF COSTS OF CONVEYANCE.—*

5 *(1) PAYMENT REQUIRED.—The Secretary of Ag-*
 6 *riculture shall require the Foundation to cover the*
 7 *costs (except any costs for environmental remediation*
 8 *of the property) to be incurred by the Secretary, or*
 9 *to reimburse the Secretary for such costs incurred by*
 10 *the Secretary, to carry out the conveyance under sub-*
 11 *section (a), including survey costs, costs for environ-*
 12 *mental documentation, and any other administrative*
 13 *costs related to the conveyance. If amounts are col-*
 14 *lected from the Foundation in advance of the Sec-*
 15 *retary incurring the actual costs, and the amount col-*
 16 *lected exceeds the costs actually incurred by the Sec-*
 17 *retary to carry out the conveyance, the Secretary shall*
 18 *refund the excess amount to the Foundation.*

19 *(2) TREATMENT OF AMOUNTS RECEIVED.—*
 20 *Amounts received as reimbursement under paragraph*
 21 *(1) shall be credited to the fund or account that was*
 22 *used to cover those costs incurred by the Secretary in*
 23 *carrying out the conveyance. Amounts so credited*
 24 *shall be merged with amounts in such fund or ac-*
 25 *count, and shall be available for the same purposes,*

1 *and subject to the same conditions and limitations, as*
2 *amounts in such fund or account.*

3 *(d) DESCRIPTION OF PROPERTY.—The exact acreage*
4 *and legal description of the property to be conveyed under*
5 *subsection (a) shall be determined by a survey satisfactory*
6 *to the Secretary of Agriculture.*

7 *(e) ADDITIONAL TERMS AND CONDITIONS.—The Sec-*
8 *retary of Agriculture may require such additional terms*
9 *and conditions in connection with the conveyance under*
10 *subsection (a) as the Secretary considers appropriate to*
11 *protect the interests of the United States.*
