# **A BILL**

To amend title 18, United States Code, to expand the scope of certain definitions pertaining to unlawful sexual conduct, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Global Child Protec-  
5 tion Act of 2017”.

6 **SEC. 2. EXPANDING THE DEFINITION OF ILLICIT SEXUAL**  
7 **CONDUCT.**

8       Section 2423(f)(1) of title 18, United States Code,  
9 is amended—

10           (1) by striking “a sexual act (as defined in sec-  
11 tion 2246) with” and inserting “any conduct involv-  
12 ing”; and

13           (2) by striking “if the sexual act” and inserting  
14 “if the conduct”.

15 **SEC. 3. EXPANDING THE DEFINITION OF FEDERAL SEX OF-**  
16 **FENSE.**

17       Section 3559 of title 18, United States Code, is  
18 amended—

19           (1) in subsection (e)(2)(A)—

20                   (A) by inserting after “2244(a)(1)” the  
21 following “or 2244(a)(5)”;

22                   (B) by striking the “or” before “2423(a)”;

23                   (C) by striking “into prostitution”; and

1                   (D) by inserting “or 2423(c) (relating to  
2                   illicit sexual conduct)” before the semicolon at  
3                   the end; and

4                   (2) in subsection (e)(3), by striking “or  
5                   2423(a)” and inserting “, 2423(a), or 2423(c)”.
