## **A BILL**

To amend the Public Health Service Act to improve essential  
oral health care for low-income and other underserved  
individuals by breaking down barriers to care, and for  
other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Action for Dental Health*  
 5 *Act of 2017”.*

6 **SEC. 2. VOLUNTEER DENTAL PROJECTS AND ACTION FOR**  
 7 **DENTAL HEALTH PROGRAM.**

8 *Section 317M of the Public Health Service Act (42*  
 9 *U.S.C. 247b–14) is amended—*

10 *(1) by redesignating subsections (e) and (f) as*  
 11 *subsections (f) and (g), respectively;*

12 *(2) by inserting after subsection (d) the following*  
 13 *new subsection:*

14 *“(e) ACTION FOR DENTAL HEALTH PROGRAM.—*

15 *“(1) IN GENERAL.—The Secretary, in consulta-*  
 16 *tion with the Director of the Centers for Disease Con-*  
 17 *trol and Prevention and the Administrator of the*  
 18 *Health Resources and Service Administration, may*  
 19 *award grants to or enter into contracts with eligible*  
 20 *entities to collaborate with State, county, or local*  
 21 *public officials and other stakeholders to develop and*  
 22 *implement initiatives to accomplish any of the fol-*  
 23 *lowing goals:*

24 *“(A) To improve oral health education and*  
 25 *dental disease prevention, including through*

1        *community-wide prevention programs, through*  
2        *the use of dental sealants and fluoride varnish,*  
3        *and by increasing oral health literacy.*

4                *“(B) To reduce geographic barriers, lan-*  
5                *guage barriers, cultural barriers, and other simi-*  
6                *lar barriers to the provision of dental services.*

7                *“(2) ELIGIBLE ENTITY.—In this subsection, the*  
8        *term ‘eligible entity’ means an entity that is—*

9                *“(A) a State or local dental association;*

10               *“(B) a State oral health program;*

11               *“(C) a dental education, dental hygiene, or*  
12               *postdoctoral dental education program accredited*  
13               *by the Commission on Dental Accreditation; or*

14               *“(D) a community-based organization*  
15               *that—*

16               *“(i) partners with an academic insti-*  
17               *tution;*

18               *“(ii) is exempt from tax under section*  
19               *501(c) of the Internal Revenue Code of*  
20               *1986; and*

21               *“(iii) partners with public and private*  
22               *stakeholders to facilitate the provision of*  
23               *dental services for underserved popu-*  
24               *lations.”; and*

1           (3) in subsection (g), as redesignated by para-  
 2           graph (1), by striking “such sums as may be nec-  
 3           essary for each of the fiscal years 2001 through 2005”  
 4           and inserting “\$18,000,000 for each of the fiscal years  
 5           2018 through 2022”.

6 **SEC. 3. GRANTS FOR INNOVATIVE PROGRAMS.**

7           Section 340G of the Public Health Service Act (42  
 8           U.S.C. 256g) is amended—

9           (1) in subsection (b)(5)—

10                   (A) in subparagraph (B), by striking “and”  
 11                   at the end; and

12                   (B) by adding at the end the following:

13                           “(D) the establishment of dental homes for  
 14                           children and adults, including for the aged,  
 15                           blind, and disabled populations;

16                           “(E) the establishment of initiatives to re-  
 17                           duce the use of emergency departments by indi-  
 18                           viduals who seek dental services more appro-  
 19                           priately delivered in a dental primary care set-  
 20                           ting; and

21                           “(F) the provision of dental care to nursing  
 22                           home residents;”; and

23           (2) in subsection (f), by striking “\$25,000,000  
 24           for the 5-fiscal year period beginning with fiscal year

- 1        *2008” and inserting “\$13,903,000 for each of fiscal*
- 2        *years 2018 through 2022”.*
