## A BILL

To amend the Equal Credit Opportunity Act to prohibit discrimination on account of sexual orientation or gender identity when extending credit.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Freedom from Dis-  
3 crimination in Credit Act of 2017”.

4 **SEC. 2. PROHIBITION AGAINST DISCRIMINATION ON AC-  
5 COUNT OF SEXUAL ORIENTATION OR GEN-  
6 DER IDENTITY.**

7 Subsection (a)(1) of section 701 of the Equal Credit  
8 Opportunity Act (15 U.S.C. 1691) is amended by insert-  
9 ing “, sexual orientation, gender identity,” after “sex”.

10 **SEC. 3. DEFINITIONS.**

11 Section 702 of the Equal Credit Opportunity Act (15  
12 U.S.C. 1691a) is amended—

13 (1) by striking subsections (f) and (g); and

14 (2) by inserting after subsection (e) the fol-  
15 lowing new subsections:

16 “(f) The term ‘gender identity’ means the gender-re-  
17 lated identity, appearance, or mannerisms or other gen-  
18 der-related characteristics of an individual, with or with-  
19 out regard to the individual’s designated sex at birth.

20 “(g) The term ‘person’ means a natural person, a  
21 corporation, government or governmental subdivision or  
22 agency, trust, estate, partnership, cooperative, or associa-  
23 tion.

24 “(h) The terms ‘race’, ‘color’, ‘religion’, ‘national ori-  
25 gin’, ‘sex’, ‘sexual orientation’, ‘gender identity’, ‘marital

1 status’, or ‘age’, used with respect to an individual, in-  
2 cludes—

3 “(1) the race, color, religion, national origin,  
4 sex, sexual orientation, gender identity, marital sta-  
5 tus, or age, respectively, of another person with  
6 whom the individual is associated or has been associ-  
7 ated; and

8 “(2) a perception or belief, even if inaccurate,  
9 concerning the race, color, religion, national origin,  
10 sex, sexual orientation, gender identity, marital sta-  
11 tus, or age, respectively, of the individual.

12 “(i) The term ‘sex’ includes—

13 “(1) a sex stereotype;

14 “(2) pregnancy, childbirth, or a related medical  
15 condition; and

16 “(3) sexual orientation or gender identity.

17 “(j) The term ‘sexual orientation’ means homosex-  
18 uality, heterosexuality, or bisexuality.

19 “(k) Any reference to any requirement imposed under  
20 this title or any provision of this title shall be deemed to  
21 include a reference to the regulations of the Bureau under  
22 this title or the provision of this title in question.”.

1 **SEC. 4. RELATION TO STATE LAWS.**

2       Section 705(a) of the Equal Credit Opportunity Act  
3 (15 U.S.C. 1691d(a)) is amended by inserting “, sexual  
4 orientation, gender identity,” after “sex”.
