A BILL

To amend the Pittman-Robertson Wildlife Restoration Act to modernize the funding of wildlife conservation, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Modernizing the Pitt-*
5 *man-Robertson Fund for Tomorrow’s Needs Act”.*

6 **SEC. 2. PURPOSE.**

7 *The first section of the Pittman-Robertson Wildlife*
8 *Restoration Act (16 U.S.C. 669) is amended by adding at*
9 *the end the following: “One of the purposes of this Act is*
10 *to provide financial and technical assistance to the States*
11 *for the promotion of hunting and recreational shooting.”.*

12 **SEC. 3. DEFINITIONS.**

13 *Section 2 of the Pittman-Robertson Wildlife Restora-*
14 *tion Act (16 U.S.C. 669a) is amended—*

15 *(1) by redesignating paragraphs (2) through (8)*
16 *as paragraphs (4) through (10), respectively; and*

17 *(2) by inserting after paragraph (1) the fol-*
18 *lowing:*

19 *“(2) for the purposes of determining the number*
20 *of paid hunting-license holders in a State, the term*
21 *‘fiscal year’ means the fiscal year or license year of*
22 *the State;*

23 *“(3) the term ‘hunter recruitment and rec-*
24 *reational shooter recruitment’ means any activity or*

1 *project to recruit or retain hunters and recreational*
 2 *shooters, including by—*

3 “(A) *using social media, marketing, adver-*
 4 *tising, surveying, television spots, print, and*
 5 *media;*

6 “(B) *providing education, mentoring, and*
 7 *field demonstrations;*

8 “(C) *enhancing access for hunting and rec-*
 9 *reational shooting, including through range con-*
 10 *struction;*

11 “(D) *providing education to the public*
 12 *about the role of hunting and recreational shoot-*
 13 *ing in funding wildlife conservation; and*

14 “(E) *using any other means to ensure the*
 15 *growth of hunting and recreational shooting, as*
 16 *determined by the Secretary;”.*

17 **SEC. 4. ALLOCATION AND APPORTIONMENT OF AVAILABLE**
 18 **AMOUNTS.**

19 (a) *APPORTIONMENT TO STATES.*—Section 4(b) of the
 20 *Pittman-Robertson Wildlife Restoration Act (16 U.S.C.*
 21 *669c(b)) is amended—*

22 (1) *in the first sentence, by striking “The Sec-*
 23 *retary of the Interior” and inserting the following:*

24 “(1) *IN GENERAL.*—*The Secretary”;*

1 (2) *in the second sentence, by striking “Such ap-*
 2 *portionments” and inserting the following:*

3 “(2) *ADJUSTMENTS.—The apportionments under*
 4 *paragraph (1)”;*

5 (3) *by striking the third sentence; and*

6 (4) *by adding at the end the following:*

7 “(3) *USE OF FUNDS.—*

8 “(A) *IN GENERAL.—Subject to subpara-*
 9 *graph (B), amounts apportioned under this sub-*
 10 *section may be used for hunter recruitment and*
 11 *recreational shooter recruitment.*

12 “(B) *LIMITATION.—A State may make an*
 13 *expenditure under subparagraph (A) only if the*
 14 *amount of the expenditure during the fiscal year*
 15 *in which the expenditure is made plus the*
 16 *amount of the expenditures for hunter recruit-*
 17 *ment and recreational shooter recruitment made*
 18 *during the 4 fiscal years preceding that fiscal*
 19 *year is not greater than 25 percent of the total*
 20 *amount apportioned to the State under this sub-*
 21 *section during that 5-fiscal-year period.”.*

22 (b) *APPORTIONMENT OF CERTAIN TAXES.—The first*
 23 *subsection (c) of section 4 of the Pittman-Robertson Wildlife*
 24 *Restoration Act (16 U.S.C. 669c) is amended—*

1 (1) *by inserting “APPORTIONMENT OF REVE-*
 2 *NUES FROM PISTOLS, REVOLVERS, BOWS, AND AR-*
 3 *ROWS.—” after the enumerator;*

4 (2) *by striking “One-half” and inserting the fol-*
 5 *lowing:*

6 “(1) *IN GENERAL.—Subject to paragraph (2),*
 7 *1/2”;*

8 (3) *by striking “: Provided, That” and inserting*
 9 *a period;*

10 (4) *by striking “each State shall be apportioned*
 11 *not more than 3 per centum and not less than 1 per*
 12 *centum of such revenues” and inserting the following:*

13 “(2) *CONDITION.—The amount apportioned to*
 14 *each State under paragraph (1) shall be not greater*
 15 *than 3 percent and not less than 1 percent of the reve-*
 16 *nues described in such paragraph”;*

17 (5) *by striking “For the purpose” and inserting*
 18 *the following:*

19 “(3) *POPULATION DETERMINATION.—For the*
 20 *purpose”;* *and*

21 (6) *by adding at the end the following:*

22 “(4) *USE OF FUNDS.—In addition to other uses*
 23 *authorized under this Act, amounts apportioned*
 24 *under this subsection may be used for hunter recruit-*
 25 *ment and recreational shooter recruitment.”.*

1 (c) *TECHNICAL CORRECTION.*—Section 4 of the Pitt-
 2 man-Robertson Wildlife Restoration Act (16 U.S.C. 669c)
 3 is amended by redesignating the second subsection (c) and
 4 subsection (d) as subsections (d) and (e), respectively.

5 **SEC. 5. EXPENDITURES FOR MANAGEMENT OF WILDLIFE**
 6 **AREAS AND RESOURCES.**

7 Section 8 of the Pittman-Robertson Wildlife Restora-
 8 tion Act (16 U.S.C. 669g) is amended—

9 (1) in subsection (a), in the third sentence, by
 10 striking “and public relations”; and

11 (2) in subsection (b), in the first sentence, by
 12 striking “, as a part of such program”.

13 **SEC. 6. FIREARM AND BOW HUNTER EDUCATION AND SAFE-**
 14 **TY PROGRAM GRANTS.**

15 Section 10(a)(1)(A) of the Pittman-Robertson Wildlife
 16 Restoration Act (16 U.S.C. 669h–1(a)(1)(A)) is amended—

17 (1) in clause (iii), by striking “and” at the end;
 18 and

19 (2) by adding at the end the following:

20 “(v) the enhancement of hunter recruit-
 21 ment and recreational shooter recruitment;
 22 and”.

23 **SEC. 7. MULTISTATE CONSERVATION GRANT PROGRAM.**

24 Section 11 of the Pittman-Robertson Wildlife Restora-
 25 tion Act (16 U.S.C. 669h–2) is amended—

1 (1) *in subsection (a)(1)—*

2 (A) *by striking “Not more than” and insert-*
3 *ing the following:*

4 “(A) *IN GENERAL.—Not more than*”;
5 (B) *by adding at the end the following:*

6 “(B) *AVAILABILITY FOR HUNTER AND REC-*
7 *REATIONAL SHOOTER GRANTS.—Not more than*
8 *\$5,000,000 of the revenues covered into the fund*
9 *from any tax imposed under section 4161(b) of*
10 *the Internal Revenue Code of 1986 for a fiscal*
11 *year shall be available to the Secretary exclu-*
12 *sively for making hunter recruitment and rec-*
13 *reational shooter recruitment grants that pro-*
14 *mote a national hunting and shooting sport re-*
15 *ruitment program, including related commu-*
16 *nication and outreach activities.”;*

17 (2) *in the matter preceding subsection (b)(3)(A),*
18 *by striking “International”;*

19 (3) *in the matter preceding subsection*
20 *(c)(2)(A)(i), by striking “International”;*

21 (4) *in subsection (c)(2)(A)(i), by inserting “or to*
22 *recreational shooting activities” after “wildlife”; and*

23 (5) *in subsection (d), by inserting “or to rec-*
24 *reational shooting activities” after “wildlife”.*
