A BILL

To amend the Social Security Act to make certain revisions to provisions limiting payment of benefits to fugitive felons under titles II, VIII, and XVI of the Social Security Act.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Control Unlawful Fugi-*
 5 *tive Felons Act of 2017”.*

6 **SEC. 2. REVISIONS TO PROVISIONS LIMITING PAYMENT OF**
 7 **BENEFITS TO FUGITIVE FELONS UNDER**
 8 **TITLE XVI OF THE SOCIAL SECURITY ACT.**

9 *(a) FUGITIVE FELON WARRANT REQUIREMENT.—Sec-*
 10 *tion 1611(e)(4)(A)(i) of the Social Security Act (42 U.S.C.*
 11 *1382(e)(4)(A)(i)) is amended—*

12 *(1) by striking “fleeing to avoid” and inserting*
 13 *“the subject of an arrest warrant for the purpose of”;*

14 *(2) by striking “the place from which the person*
 15 *flee” the first place it appears and inserting “the ju-*
 16 *risdiction issuing the warrant”; and*

17 *(3) by striking “the place from which the person*
 18 *flee” the second place it appears and inserting “the*
 19 *jurisdiction”.*

20 *(b) PROBATION AND PAROLE WARRANT REQUIRE-*
 21 *MENT.—Section 1611(e)(4)(A)(ii) of such Act (42 U.S.C.*
 22 *1382(e)(4)(A)(ii)) is amended to read as follows:*

23 *“(ii) the subject of an arrest warrant for vio-*
 24 *lating a condition of probation or parole imposed*
 25 *under Federal or State law.”.*

1 (c) *DISCLOSURE.*—Section 1611(e)(5) of such Act (42
2 U.S.C. 1382(e)(5)) is amended—

3 (1) by striking “any recipient of” and inserting
4 “any individual who is a recipient of (or would be
5 such a recipient but for the application of paragraph
6 (4)(A))”; and

7 (2) by striking “the recipient” each place it ap-
8 pears and inserting “the individual”.

9 (d) *EFFECTIVE DATE.*—The amendments made by this
10 section shall be effective with respect to benefits payable for
11 months that begin on or after January 1, 2021.
