

In the Senate of the United States,

July 27, 2017.

Resolved, That the bill from the House of Representatives (H.R. 3298) entitled “An Act to authorize the Capitol Police Board to make payments from the United States Capitol Police Memorial Fund to employees of the United States Capitol Police who have sustained serious line-of-duty injuries, and for other purposes.”, do pass with the following

AMENDMENT:

Strike all after the enacting clause and insert the following:

1 ***SECTION 1. SHORT TITLE.***

2 *This Act may be cited as the “Wounded Officers Recov-*
3 *ery Act of 2017”.*

4 ***SEC. 2. PAYMENTS FROM UNITED STATES CAPITOL POLICE***

5 ***MEMORIAL FUND FOR EMPLOYEES KILLED IN***

6 ***THE LINE OF DUTY OR SUSTAINING SERIOUS***

7 ***LINE-OF-DUTY INJURIES.***

8 *(a) AUTHORIZING PAYMENTS FROM FUND.—Section 2*
9 *of Public Law 105–223 (2 U.S.C. 1952) is amended—*

1 (1) *in the section heading, by inserting “**AND***
 2 ***CERTAIN OTHER UNITED STATES CAPITOL PO-***
 3 ***LICE EMPLOYEES*” before the period at the end;**

4 (2) *by striking “Subject to the regulations” and*
 5 *inserting “(a) IN GENERAL.—Except to the extent*
 6 *used or reserved for use under subsection (b) and sub-*
 7 *ject to the regulations”; and*

8 (3) *by adding at the end the following new sub-*
 9 *section:*

10 “(b) *PAYMENTS FOR EMPLOYEES KILLED IN THE LINE*
 11 *OF DUTY OR SUSTAINING SERIOUS LINE-OF-DUTY INJU-*
 12 *RIES.—In addition to the amounts paid under subsection*
 13 *(a), and in accordance with the regulations issued under*
 14 *section 4(b), amounts in the Fund may be paid to—*

15 “(1) *families of employees of the United States*
 16 *Capitol Police who were killed in the line of duty; or*

17 “(2) *employees of the United States Capitol Po-*
 18 *lice who have sustained serious line-of-duty injuries.”.*

19 (b) *REGULATIONS OF CAPITOL POLICE BOARD.—Sec-*
 20 *tion 4 of Public Law 105–223 (2 U.S.C. 1954) is amend-*
 21 *ed—*

22 (1) *by striking “The Capitol Police Board” and*
 23 *inserting “(a) IN GENERAL.—The Capitol Police*
 24 *Board”; and*

1 (2) *by adding at the end the following new sub-*
 2 *section:*

3 “(b) *REGULATIONS GOVERNING PAYMENTS FOR EM-*
 4 *PLOYEES KILLED IN THE LINE OF DUTY OR SUSTAINING*
 5 *SERIOUS LINE-OF-DUTY INJURIES.*—*In carrying out sub-*
 6 *section (a), the Capitol Police Board shall issue specific reg-*
 7 *ulations governing the use of the Fund for making pay-*
 8 *ments to families of employees of the United States Capitol*
 9 *Police who were killed in the line of duty and employees*
 10 *of the United States Capitol Police who have sustained seri-*
 11 *ous line-of-duty injuries (as authorized under section 2(b)),*
 12 *including regulations—*

13 “(1) *establishing the conditions under which the*
 14 *family of an employee or an employee is eligible to*
 15 *receive such a payment;*

16 “(2) *providing for the amount, timing, and*
 17 *manner of such payments; and*

18 “(3) *ensuring that any such payment is in addi-*
 19 *tion to, and does not otherwise affect, any other form*
 20 *of compensation payable to the family of an employee*
 21 *or the employee, including benefits for workers’ com-*
 22 *ensation under chapter 81 of title 5, United States*
 23 *Code.”.*

24 (c) *TREATMENT OF AMOUNTS RECEIVED IN RESPONSE*
 25 *TO INCIDENT OF JUNE 14, 2017.*—*The second sentence of*

1 *section 1 of Public Law 105–223 (2 U.S.C. 1951) is amend-*
2 *ed by striking “deposit into the Fund” and inserting “de-*
3 *posit into the Fund, including amounts received in response*
4 *to the shooting incident at the practice for the Congressional*
5 *Baseball Game for Charity on June 14, 2017,”.*
