A BILL

 - 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the "Furthering Access to
3 Coordinated Treatment for Seniors Act of 2017" or the
4 "FACTS Act of 2017".

5 SEC. 2. PROVIDING PRESCRIPTION DRUG PLANS WITH
6 PARTS A AND B CLAIMS DATA TO PROMOTE
7 THE APPROPRIATE USE OF MEDICATIONS
8 AND IMPROVE HEALTH OUTCOMES.

9 Section 1860D-4(c) of the Social Security Act (42
10 U.S.C. 1395w-104(c)) is amended by adding at the end
11 the following new paragraph:

12 "(7) PROVIDING PRESCRIPTION DRUG PLANS
13 WITH PARTS A AND B CLAIMS DATA TO PROMOTE
14 THE APPROPRIATE USE OF MEDICATIONS AND IM15 PROVE HEALTH OUTCOMES.—

16 "(A) PROCESS.—Subject to subparagraph 17 (C), the Secretary shall establish a process 18 under which a PDP sponsor of a prescription 19 drug plan may submit a request for the Sec-20 retary to provide the sponsor, on a periodic 21 basis and in an electronic format, beginning in 22 plan year 2020, data described in subparagraph (D) with respect to enrollees in such plan. Such 23 24 data shall be provided without regard to wheth-25 er such enrollees are described in clause (ii) of 26 paragraph (2)(A).

"(B) PURPOSES.—A PDP sponsor may 1 2 use the data provided to the sponsor pursuant to subparagraph (A) for any of the following 3 4 purposes: "(i) To optimize therapeutic outcomes 5 6 through improved medication use, as such 7 phrase is used in clause (i) of paragraph 8 (2)(A).9 "(ii) To improve care coordination so 10 as to prevent adverse health outcomes, 11 such as preventable emergency department 12 visits and hospital readmissions. "(iii) For any other purpose deter-13 14 mined appropriate by the Secretary. "(C) LIMITATIONS ON DATA USE.—A PDP 15 16 sponsor shall not use data provided to the spon-17 sor pursuant to subparagraph (A) for any of 18 the following purposes: "(i) To inform coverage determina-19 20 tions under this part. "(ii) To conduct retroactive reviews of 21 22 medically accepted indications determina-23 tions.

24 "(iii) To direct enrollment changes to25 a different prescription drug plan or an

3	"(iv) To inform marketing of benefits.
4	"(v) For any other purpose that the
5	Secretary determines is necessary to in-
6	clude in order to protect the identity of in-
7	dividuals entitled to, or enrolled for, bene-
8	fits under this title and to protect the se-
9	curity of personal health information.
10	"(D) DATA DESCRIBED.—The data de-
11	scribed in this subparagraph are standardized
12	extracts (as determined by the Secretary) of
13	claims data under parts A and B for items and
14	services furnished under such parts for time pe-
15	riods specified by the Secretary. Such data shall
16	include data as current as practicable.".
