# **A BILL**

To authorize the Secretary of the Interior to establish fees for medical services provided in units of the National Park System, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. FEES FOR MEDICAL SERVICES.**

4        *(a) FEES AUTHORIZED.—The Secretary may establish*  
5 *and collect fees for medical services provided to persons in*  
6 *units of the National Park System or for medical services*  
7 *provided by National Park Service personnel outside units*  
8 *of the National Park System.*

9        *(b) NATIONAL PARK MEDICAL SERVICES FUND.—*  
10 *There is hereby established in the Treasury a fund to be*  
11 *known as the “National Park Medical Services Fund”. The*  
12 *Fund shall consist of—*

13            *(1) donations to the Fund; and*

14            *(2) fees collected under subsection (a).*

15        *(c) AVAILABILITY OF AMOUNTS.—All amounts depos-*  
16 *ited into the Fund shall be available to the Secretary, to*  
17 *the extent provided in advance by Acts of appropriation,*  
18 *for the following in units of the National Park System:*

19            *(1) Services listed in subsection (a).*

20            *(2) Preparing needs assessments or other pro-*  
21 *grammatic analyses for medical facilities, equipment,*  
22 *vehicles, and other needs and costs of providing serv-*  
23 *ices listed in subsection (a).*

1           (3) *Developing management plans for medical*  
2 *facilities, equipment, vehicles, and other needs and*  
3 *costs of services listed in subsection (a).*

4           (4) *Training related to providing services listed*  
5 *in subsection (a).*

6           (5) *Obtaining or improving medical facilities,*  
7 *equipment, vehicles, and other needs and costs of pro-*  
8 *viding services listed in subsection (a).*

9           (d) *DEFINITIONS.—For the purposes of this section:*

10           (1) *FUND.—The term “Fund” means the Na-*  
11 *tional Park Medical Services Fund established by sub-*  
12 *section (b).*

13           (2) *SECRETARY.—The term “Secretary” means*  
14 *the Secretary of the Interior.*
