## AN ACT

To improve and streamline security procedures related to general aviation and commercial charter air carrier utilizing risk-based security standards, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Securing General Avia-  
3 tion and Commercial Charter Air Carrier Service Act of  
4 2017”.

5 **SEC. 2. WEB-BASED SECURE FLIGHT COST AND FEASI-**  
6 **BILITY STUDY.**

7 Not later than 120 days after the date of the enact-  
8 ment of this Act, the Administrator of the Transportation  
9 Security Administration shall conduct a study to deter-  
10 mine the cost and feasibility of establishing web-based ac-  
11 cess to Secure Flight for commercial charter air carriers.

12 **SEC. 3. SCREENING IN AREAS OTHER THAN PASSENGER**  
13 **TERMINALS.**

14 (a) IN GENERAL.—The Administrator of the Trans-  
15 portation Security Administration is authorized to provide  
16 screening services to a commercial charter air carrier in  
17 areas other than primary passenger terminals of airports  
18 upon the request of such carrier.

19 (b) REQUEST.—A commercial charter air carrier that  
20 wants screening services to be provided to such carrier in  
21 an area other than a primary passenger terminal shall re-  
22 quest the Federal Security Director for the airport at  
23 which such services are requested.

24 (c) AVAILABILITY.—A Federal Security Director may  
25 elect to provide screening services under this section if  
26 such services are available.

1 (d) AGREEMENTS.—

2 (1) IN GENERAL.—The Administrator of the  
3 Transportation Security Administration shall enter  
4 into an agreement with a commercial charter air  
5 carrier for compensation from such carrier request-  
6 ing the use of screening services under this section  
7 for all reasonable costs in addition to overtime costs  
8 that are incurred in the provision of such services.

9 (2) AVAILABILITY.—Any compensation received  
10 by the Transportation Security Administration pur-  
11 suant to an agreement under this subsection shall be  
12 credited to the account used in connection with the  
13 provision of the screening services that are the sub-  
14 ject of such agreement, notwithstanding section  
15 3302 of title 31, United States Code.

16 **SEC. 4. REPORT ON GENERAL AVIATION SECURITY AND SE-**  
17 **LECT AVIATION SECURITY TOPICS.**

18 Not later than 120 days after the date of the enact-  
19 ment of this Act, the Administrator of the Transportation  
20 Security Administration, in consultation with the Aviation  
21 Security Advisory Committee, shall, consistent with the re-  
22 quirements of paragraphs (6) and (7) of section 44946(b)  
23 of title 49, United States Code, submit to the Committee  
24 on Homeland Security of the House of Representatives  
25 and the Committee on Commerce, Science, and Transpor-

1 tation of the Senate an implementation plan, including an  
2 implementation schedule, for any of the following rec-  
3 ommendations that were adopted by the Aviation Security  
4 Advisory Committee and with which the Administrator has  
5 concurred before the date of the enactment of this Act:

6 (1) The recommendation regarding general  
7 aviation access to Ronald Reagan Washington Na-  
8 tional Airport, as adopted on February 17, 2015.

9 (2) The recommendation regarding the vetting  
10 of persons seeking flight training in the United  
11 States, as adopted on July 28, 2016.

12 (3) Any other such recommendations relevant  
13 to the security of general aviation adopted before the  
14 date of the enactment of this Act.

15 **SEC. 5. DESIGNATED STAFFING FOR GENERAL AVIATION.**

16 The Administrator of the Transportation Security  
17 Administration is authorized to designate not fewer than  
18 one full time employee of the Administration to be respon-  
19 sible for engagement with general aviation stakeholders  
20 and manage issues related to general aviation.

21 **SEC. 6. SECURITY ENHANCEMENTS.**

22 Not later than 1 year after the date of the enactment  
23 of this Act, the Administrator of the Transportation Secu-  
24 rity Administration, in consultation with the Aviation Se-  
25 curity Advisory Committee, shall provide to the Committee

1 on Homeland Security of the House of Representatives  
2 and the Committee on Commerce, Science, and Transpor-  
3 tation of the Senate a report on the feasibility of requiring  
4 security threat assessments for all candidates seeking  
5 flight school training in the operation of any aircraft hav-  
6 ing a maximum certificated takeoff weight of more than  
7 12,500 pounds to further enhance the vetting of persons  
8 seeking such training in the United States.
