#### 1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the "Community Institution3 Mortgage Relief Act of 2017".

## 4 SEC. 2. COMMUNITY FINANCIAL INSTITUTION MORTGAGE 5 RELIEF.

6 (a) EXEMPTION FROM ESCROW REQUIREMENTS FOR
7 LOANS HELD BY SMALLER CREDITORS.—Section 129D
8 of the Truth in Lending Act (15 U.S.C. 1639d) is amend9 ed—

10 (1) by adding at the end the following:

11 "(k) SAFE HARBOR FOR LOANS HELD BY SMALLER12 CREDITORS.—

"(1) IN GENERAL.—A creditor shall not be in
violation of subsection (a) with respect to a loan if—
"(A) the creditor has consolidated assets of
\$10,000,000,000 or less; and
"(B) the creditor holds the loan on the balance sheet of the creditor for the 3-year period
beginning on the date of the origination of the

20 loan.

21 "(2) EXCEPTION FOR CERTAIN TRANSFERS.—
22 In the case of a creditor that transfers a loan to an23 other person by reason of the bankruptcy or failure
24 of the creditor, the purchase of the creditor, or a su25 pervisory act or recommendation from a State or
26 Federal regulator, the creditor shall be deemed to

1	nave complied with the requirement under p	ara-
2	graph $(1)(B)$ ."; and	

3 (2) by striking the term "Board" each place4 such term appears and inserting "Bureau".

5 (b) MODIFICATION TO EXEMPTION FOR SMALL
6 SERVICERS OF MORTGAGE LOANS.—Section 6 of the Real
7 Estate Settlement Procedures Act of 1974 (12 U.S.C.
8 2605) is amended by adding at the end the following:

9 "(n) SMALL SERVICER EXEMPTION.—The Bureau 10 shall, by regulation, provide exemptions to, or adjustments 11 for, the provisions of this section for a servicer that annu-12 ally services 20,000 or fewer mortgage loans, in order to 13 reduce regulatory burdens while appropriately balancing 14 consumer protections.".
