3	SECTION 1. SHORT TITLE.
4	This Act may be cited as the "Women in Aerospace
5	Education Act".
6	SEC. 2. ROBERT NOYCE TEACHER SCHOLARSHIP PROGRAM
7	FELLOWSHIP OPPORTUNITIES.
8	(a) IN GENERAL.—The National Science Foundation
9	Authorization Act of 2002 (Public Law 107–368; 42 U.S.C.
10	1862n et seq.) is amended—
11	(1) in section $10(a)(3)(A)(iv)$, by inserting ", in-
12	cluding research experiences at national laboratories
13	and NASA centers" before the semicolon; and
14	(2) in section $10A(c)(4)$ —
15	(A) in subparagraph (A), by striking "and"
16	at the end;
17	(B) in subparagraph (B), by striking the
18	period at the end and inserting "; and"; and
19	(C) by adding at the end the following:
20	"(C) providing internship opportunities for
21	fellows, including research experiences at na-
22	tional laboratories and NASA Centers.".
23	(b) EFFECTIVE DATE.—The amendments made by sub-
24	section (a) shall apply with respect to grants awarded on
25	or after October 1, 2018.

3 Not later than October 1, 2018, the Administrator of 4 the National Aeronautics and Space Administration (in this section referred to as "NASA") shall institute a process 5 to prioritize the recruitment of qualified candidates who are 6 women or individuals who are historically underrepresented 7 8 in the fields of science, technology, engineering, and mathematics (STEM) and computer science for internships and 9 fellowships at NASA with relevance to the aerospace sector 10 11 and related fields.
