## A BILL

To amend title 38, United States Code, to include local government minimum wage requirements in determining the hourly minimum wage applicable for purposes of the work-study allowance under the educational assistance programs administered by the Secretary of Veterans Affairs.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2       This Act may be cited as the “Wage Adjustment for  
3 Veterans Student Act”.

4 **SEC. 2. AMOUNT OF WORK-STUDY ALLOWANCE UNDER DE-**  
5 **PARTMENT OF VETERANS AFFAIRS EDU-**  
6 **CATIONAL ASSISTANCE PROGRAMS.**

7       (a) IN GENERAL.—Paragraph (6) of section 3485(a)  
8 of title 38, United States Code, is amended to read as  
9 follows:

10           “(6) For the purposes of this subsection and  
11 subsection (e), the term ‘applicable hourly minimum  
12 wages’ means the higher of the following wages:

13           “(A) The hourly minimum wage under sec-  
14 tion 6(a) of the Fair Labor Standards Act of  
15 1938 (29 U.S.C. 206(a)).

16           “(B) The hourly minimum wage under  
17 comparable law of the State in which the serv-  
18 ices are to be performed.

19           “(C) The hourly minimum wage under  
20 comparable law of the local government with ju-  
21 risdiction over the area in which the services  
22 are to be performed.”.

23       (b) EFFECTIVE DATE.—The amendment made by  
24 subsection (a) shall apply with respect to a payment of  
25 work-study allowance made on or after January 1, 2019.
