A BILL

To direct the Secretary of Veterans Affairs to increase the number of peer-to-peer counselors providing counseling for women veterans, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. PEER SUPPORT COUNSELING PROGRAM FOR**
 4 **WOMEN VETERANS.**

5 *(a) IN GENERAL.—Section 1720F(j) of title 38, United*
 6 *States Code, is amended by adding at the end the following*
 7 *new paragraph:*

8 *“(4)(A) As part of the counseling program under this*
 9 *subsection, the Secretary shall emphasize appointing peer*
 10 *support counselors for women veterans. To the degree prac-*
 11 *ticable, the Secretary shall seek to recruit women peer sup-*
 12 *port counselors with expertise in—*

13 *“(i) female gender-specific issues and services;*

14 *“(ii) the provision of information about services*
 15 *and benefits provided under laws administered by the*
 16 *Secretary; or*

17 *“(iii) employment mentoring.*

18 *“(B) To the degree practicable, the Secretary shall em-*
 19 *phasize facilitating peer support counseling for women vet-*
 20 *erans who are eligible for counseling and services under sec-*
 21 *tion 1720D of this title, have post-traumatic stress disorder*
 22 *or suffer from another mental health condition, are homeless*
 23 *or at risk of becoming homeless, or are otherwise at in-*
 24 *creased risk of suicide, as determined by the Secretary.*

1 “(C) *The Secretary shall conduct outreach to inform*
2 *women veterans about the program and the assistance*
3 *available under this paragraph.*

4 “(D) *In carrying out this paragraph, the Secretary*
5 *shall coordinate with such community organizations, State*
6 *and local governments, institutions of higher education,*
7 *chambers of commerce, local business organizations, organi-*
8 *zations that provide legal assistance, and other organiza-*
9 *tions as the Secretary considers appropriate.*

10 “(E) *In carrying out this paragraph, the Secretary*
11 *shall provide adequate training for peer support counselors,*
12 *including training carried out under the national program*
13 *of training required by section 304(c) of the Caregivers and*
14 *Veterans Omnibus Health Services Act of 2010 (38 U.S.C.*
15 *1712A note).’.*

16 (b) *FUNDING.—The Secretary of Veterans Affairs shall*
17 *carry out paragraph (4) of section 1720F(j) of title 38,*
18 *United States Code, as added by subsection (a), using funds*
19 *otherwise made available to the Secretary. No additional*
20 *funds are authorized to be appropriated by reason of such*
21 *paragraph.*

22 (c) *REPORT TO CONGRESS.—Not later than two years*
23 *after the date of the enactment of this Act, the Secretary*
24 *of Veterans Affairs shall submit to the Committees on Vet-*
25 *erans’ Affairs of the Senate and House of Representatives*

1 *a report on the peer support counseling program under sec-*
2 *tion 1720F(j) of title 38, United States Code, as amended*
3 *by this section. Such report shall include—*

4 *(1) the number of peer support counselors in the*
5 *program;*

6 *(2) an assessment of the effectiveness of the pro-*
7 *gram; and*

8 *(3) a description of the oversight of the program.*
