# **A BILL**

To establish the Kennedy–King National Historic Site in  
the State of Indiana, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        *This Act may be cited as the “Kennedy–King National*  
5 *Commemorative Site Act”.*

6 **SEC. 2. DEFINITIONS.**

7        *In this Act:*

8            (1) *SECRETARY.*—*The term “Secretary” means*  
9 *the Secretary of the Interior.*

10           (2) *SITE.*—*The term “Site” means the Kennedy-*  
11 *King National Commemorative Site as designated by*  
12 *section 3(a).*

13           (3) *STATE.*—*The term “State” means the State*  
14 *of Indiana.*

15 **SEC. 3. NATIONAL COMMEMORATIVE SITE.**

16           (a) *DESIGNATION.*—*The Landmark for Peace Memo-*  
17 *rial in Martin Luther King, Jr. Park in Indianapolis, in*  
18 *the State, is hereby designated as the Kennedy-King Na-*  
19 *tional Commemorative Site.*

20           (b) *AFRICAN AMERICAN CIVIL RIGHTS NETWORK.*—  
21 *The Site shall be part of the African American Civil Rights*  
22 *Network established under Public Law 115–104.*

23           (c) *ADMINISTRATION.*—

24            (1) *COOPERATIVE AGREEMENTS.*—*The Secretary*  
25 *may enter into cooperative agreements with appro-*

1        *appropriate public or private entities for interpretative and*  
2        *educational purposes related to the Site.*

3            (2) *EFFECT OF DESIGNATION.—The Site shall*  
4        *not be a unit of the National Park System.*

5            (3) *LIMITATIONS.—Nothing in this Act—*

6                    (A) *authorizes the Secretary to interfere*  
7                    *with the rights of any person with respect to pri-*  
8                    *vate property or any local zoning ordinance or*  
9                    *land use plan of the State or any political sub-*  
10                   *division thereof; or*

11                   (B) *authorizes the Secretary to acquire land*  
12                   *or interests in land through condemnation or*  
13                   *otherwise.*

14            (d) *SPECIAL RESOURCE STUDY.—The Secretary shall*  
15        *conduct a special resource study of the Site to evaluate the*  
16        *national significance of the Site and determine the suit-*  
17        *ability and feasibility of designating the Site as a unit of*  
18        *the National Park System. The Secretary shall also consider*  
19        *other alternatives for preservation, protection, and interpre-*  
20        *tation of the Site by Federal, State, or local government*  
21        *entities, or private and non-profit groups. The study shall*  
22        *be conducted in accordance with section 100507 of title 54,*  
23        *United States Code. Not later than three years after the date*  
24        *on which funds are made available to conduct the study,*  
25        *the Secretary shall submit a report to Congress that de-*

- 1 *describes the results of the study and any recommendations*
- 2 *of the Secretary.*
