# **A BILL**

To amend title XIX of the Social Security Act to ensure health insurance coverage continuity for former foster youth.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Health Insurance for*  
5 *Former Foster Youth Act”.*

6 **SEC. 2. COVERAGE CONTINUITY FOR FORMER FOSTER**  
7 **CARE CHILDREN UP TO AGE 26.**

8 *(a) IN GENERAL.—Section 1902(a)(10)(A)(i)(IX) of*  
9 *the Social Security Act (42 U.S.C. 1396a(a)(10)(A)(i)(IX))*  
10 *is amended—*

11 *(1) in item (bb), by striking “are not described*  
12 *in or enrolled under” and inserting “are not de-*  
13 *scribed in and are not enrolled under”;*

14 *(2) in item (cc), by striking “responsibility of*  
15 *the State” and inserting “responsibility of a State”;*  
16 *and*

17 *(3) in item (dd), by striking “the State plan*  
18 *under this title or under a waiver of the” and insert-*  
19 *ing “a State plan under this title or under a waiver*  
20 *of such a”.*

21 *(b) EFFECTIVE DATE.—The amendments made by this*  
22 *section shall take effect with respect to foster youth who at-*  
23 *tain 18 years of age on or after January 1, 2023.*

1 **SEC. 3. GUIDANCE.**

2 *Not later than one year after the date of the enactment*  
3 *of this Act, the Secretary of Health and Human Services*  
4 *shall issue guidance to States, with respect to the State Med-*  
5 *icaid programs of such States—*

6 *(1) on best practices for—*

7 *(A) removing barriers and ensuring stream-*  
8 *lined, timely access to Medicaid coverage for*  
9 *former foster youth up to age 26;*

10 *(B) tracking the Medicaid coverage status*  
11 *and verifying Medicaid eligibility for such*  
12 *youth; and*

13 *(C) conducting outreach and raising aware-*  
14 *ness among such youth regarding Medicaid cov-*  
15 *erage options for such youth; and*

16 *(2) which shall include examples of States that*  
17 *have successfully extended Medicaid coverage to*  
18 *former foster youth up to age 26.*
