A BILL

To provide for an exchange of lands with San Bernardino County, California, to enhance management of lands within the San Bernardino National Forest, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Big Bear Land Ex-*
5 *change Act”.*

6 **SEC. 2. DEFINITIONS.**

7 *In this Act:*

8 (1) *COUNTY.*—*The term “County” means the*
9 *County of San Bernardino, California.*

10 (2) *FEDERAL LAND.*—*The term “Federal land”*
11 *means the approximately 73 acres of Federal land ad-*
12 *ministered by the Forest Service generally depicted as*
13 *“Federal Land Proposed for Exchange” on the Map.*

14 (3) *NON-FEDERAL LAND.*—*The term “non-Fed-*
15 *eral land” means the approximately 71 acres owned*
16 *by the County generally depicted as “Non-Federal*
17 *Land Proposed for Exchange” on the Map.*

18 (4) *SECRETARY.*—*The term “Secretary” means*
19 *the Secretary of Agriculture.*

20 (5) *MAP.*—*The term “Map” means the map ti-*
21 *tled “Big Bear Land Exchange” and dated August 6,*
22 *2018.*

23 **SEC. 3. EXCHANGE OF LAND; EQUALIZATION OF VALUE.**

24 (a) *EXCHANGE AUTHORIZED.*—*Subject to valid exist-*
25 *ing rights and the terms of this Act, no later than one year*

1 *after the date that the portion of the Pacific Crest National*
2 *Scenic Trail is relocated in accordance with subsection (h),*
3 *if the County offers to convey the non-Federal land to the*
4 *United States, the Secretary shall—*

5 *(1) convey to the County all right, title, and in-*
6 *terest of the United States in and to the Federal land;*
7 *and*

8 *(2) accept from the County a conveyance of all*
9 *right, title, and interest of the County in and to the*
10 *non-Federal land.*

11 *(b) EQUAL VALUE AND CASH EQUALIZATION.—*

12 *(1) EQUAL VALUE EXCHANGE.—The land ex-*
13 *change under this section shall be for equal value, or*
14 *the values shall be equalized by a cash payment as*
15 *provided for under this subsection or an adjustment*
16 *in acreage. At the option of the County, any excess*
17 *value of the non-Federal lands may be considered a*
18 *gift to the United States.*

19 *(2) CASH EQUALIZATION PAYMENT.—The County*
20 *may equalize the values of the lands to be exchanged*
21 *under this section by cash payment without regard to*
22 *any statutory limit on the amount of such a cash*
23 *equalization payment.*

24 *(3) DEPOSIT AND USE OF FUNDS RECEIVED*
25 *FROM COUNTY.—Any cash equalization payment re-*

1 *ceived by the Secretary under this subsection shall be*
2 *deposited in the fund established under Public Law*
3 *90–171 (16 U.S.C. 484a; commonly known as the*
4 *Sisk Act). The funds so deposited shall remain avail-*
5 *able to the Secretary, until expended, for the acquisi-*
6 *tion of lands, waters, and interests in land for the*
7 *San Bernardino National Forest.*

8 *(c) APPRAISAL.—The Secretary shall complete an ap-*
9 *praisal of the land to be exchanged under subsection (a)*
10 *in accordance with—*

11 *(1) the Uniform Appraisal Standards for Fed-*
12 *eral Land Acquisitions; and*

13 *(2) the Uniform Standards of Professional Ap-*
14 *praisal Practice.*

15 *(d) TITLE APPROVAL.—Title to the land to be ex-*
16 *changed under this Act shall be in a format acceptable to*
17 *the Secretary and the County.*

18 *(e) SURVEY OF NON-FEDERAL LANDS.—Before com-*
19 *pleting the exchange under this Act, the Secretary shall in-*
20 *spect the non-Federal lands to ensure that the land meets*
21 *Federal standards, including hazardous materials and land*
22 *line surveys.*

23 *(f) COSTS OF CONVEYANCE.—As a condition of convey-*
24 *ance, any costs related to the exchange under this section*
25 *shall be paid by the County.*

1 (g) *MANAGEMENT OF ACQUIRED LANDS.*—*The Sec-*
2 *retary shall manage the non-Federal land acquired under*
3 *this section in accordance with the Act of March 1, 1911*
4 *(16 U.S.C. 480 et seq.; commonly known as the Weeks Act),*
5 *and other laws and regulations pertaining to National For-*
6 *est System lands.*

7 (h) *PACIFIC CREST NATIONAL SCENIC TRAIL RELOCA-*
8 *TION.*—*No later than three years after the date of enactment*
9 *of this Act, the Secretary, in accordance with applicable*
10 *laws, shall relocate the portion of the Pacific Crest National*
11 *Scenic Trail located on the Federal land to—*

12 (1) *adjacent National Forest System land;*

13 (2) *land owned by the County, subject to County*
14 *approval;*

15 (3) *land within the Federal land, subject to*
16 *County approval; or*

17 (4) *a combination of paragraphs (1), (2), and*
18 *(3).*

19 (i) *MAP AND LEGAL DESCRIPTIONS.*—*As soon as prac-*
20 *ticable after the date of the enactment of this Act, the Sec-*
21 *retary shall finalize a map and legal descriptions of all*
22 *land to be conveyed under this Act. The Secretary may cor-*
23 *rect any minor errors in the map or in the legal descrip-*
24 *tions. The map and legal descriptions shall be on file and*

- 1 *available for public inspection in appropriate offices of the*
- 2 *Forest Service.*
