## AN ACT

To amend title XI of the Social Security Act to require States to annually report on certain adult health quality measures, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. MANDATORY REPORTING WITH RESPECT TO**  
2 **ADULT BEHAVIORAL HEALTH MEASURES.**

3 Section 1139B of the Social Security Act (42 U.S.C.  
4 1320b–9b) is amended—

5 (1) in subsection (b)—

6 (A) in paragraph (3)—

7 (i) by striking “Not later than Janu-  
8 ary 1, 2013” and inserting the following:

9 “(A) VOLUNTARY REPORTING.—Not later  
10 than January 1, 2013”; and

11 (ii) by adding at the end the fol-  
12 lowing:

13 “(B) MANDATORY REPORTING WITH RE-  
14 SPECT TO BEHAVIORAL HEALTH MEASURES.—  
15 Beginning with the State report required under  
16 subsection (d)(1) for 2024, the Secretary shall  
17 require States to use all behavioral health meas-  
18 ures included in the core set of adult health  
19 quality measures and any updates or changes to  
20 such measures to report information, using the  
21 standardized format for reporting information  
22 and procedures developed under subparagraph  
23 (A), regarding the quality of behavioral health  
24 care for Medicaid eligible adults.”; and

25 (B) in paragraph (5), by adding at the end  
26 the following new subparagraph:

1           “(C) BEHAVIORAL HEALTH MEASURES.—  
2           Beginning with respect to State reports re-  
3           quired under subsection (d)(1) for 2024, the  
4           core set of adult health quality measures main-  
5           tained under this paragraph (and any updates  
6           or changes to such measures) shall include be-  
7           havioral health measures.”; and  
8           (2) in subsection (d)(1)(A)—  
9           (A) by striking “the such plan” and insert-  
10          ing “such plan”; and  
11          (B) by striking “subsection (a)(5)” and in-  
12          serting “subsection (b)(5) and, beginning with  
13          the report for 2024, all behavioral health meas-  
14          ures included in the core set of adult health  
15          quality measures maintained under such sub-  
16          section (b)(5) and any updates or changes to  
17          such measures (as required under subsection  
18          (b)(3))”.
