## A BILL

To recognize that Christians and Yazidis in Iraq, Syria, Pakistan, Iran, and Libya are targets of genocide, and to provide for the expedited processing of immigrant and refugee visas for such individuals, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Save Christians from  
5 Genocide Act”.

1 **SEC. 2. DECLARATION OF POLICY.**

2 Congress—

3 (1) recognizes that Christians and Yazidis in  
4 Iraq, Syria, Pakistan, Iran, and Libya are targets of  
5 genocide and encourages other nations to likewise  
6 recognize the ongoing genocide and the threat of  
7 genocide to these people; and

8 (2) further recognizes that such targets of  
9 genocide who are seeking admission to the United  
10 States as immigrants or refugees should be given  
11 priority and expedited processing.

12 **SEC. 3. EMERGENCY ADMISSION OF REFUGEES AND IMMI-**  
13 **GRANTS.**

14 (a) REFUGEES.—

15 (1) EMERGENCY REFUGEE SITUATION DE-  
16 SCRIBED.—The persecution of Christians and  
17 Yazidis in Iraq, Syria, Pakistan, Iran, and Libya  
18 constitutes an unforeseen emergency refugee situa-  
19 tion, and the admission of such persecuted individ-  
20 uals in response to that situation is of grave human-  
21 itarian concern.

22 (2) EXPEDITED PROCESSING.—The Secretary  
23 of Homeland Security shall provide for the expedited  
24 processing of the visas for aliens described in para-  
25 graph (3), and shall ensure that such applications

1 receive first priority among applications for refugee  
2 status.

3 (3) ALIENS DESCRIBED.—An alien is described  
4 in this paragraph if the alien—

5 (A) is a citizen or national of Iraq, Syria,  
6 Pakistan, Iran, or Libya, or in the case of an  
7 alien having no nationality, whose country of  
8 last habitual residence was Iraq, Syria, Paki-  
9 stan, Iran, or Libya;

10 (B) is a member of the Christian or Yazidi  
11 community; and

12 (C) is seeking admission to the United  
13 States as a refuge under section 207 of the Im-  
14 migration and Nationality Act (8 U.S.C. 1157).

15 (4) QUALIFICATION AS REFUGEES.—For pur-  
16 poses of qualifying as a refugee under section 101  
17 of the Immigration and Nationality Act (8 U.S.C.  
18 1101)—

19 (A) membership in the Christian or Yazidi  
20 community shall qualify an alien described in  
21 paragraph (3) as a member of a persecuted  
22 group; and

23 (B) the requirement that an alien be out-  
24 side any country of such person's nationality or,  
25 in the case of a person having no nationality,

1 is outside any country in which such person last  
2 habitually resided, shall not apply to an alien  
3 described in paragraph (3).

4 (b) IMMIGRANTS.—

5 (1) EXPEDITED PROCESSING.—The Secretary  
6 of Homeland Security shall provide for the expedited  
7 processing of visas for the aliens described in para-  
8 graph (2), and shall ensure that such applications  
9 receive first priority among applications for immi-  
10 grant status.

11 (2) ALIENS DESCRIBED.—An alien is described  
12 in this paragraph if the alien—

13 (A) is a citizen or national of Iraq, Syria,  
14 Pakistan, Iran, Libya, or in the case of an alien  
15 having no nationality, whose country of last ha-  
16 bitual residence was Iraq, Syria, Pakistan, Iran,  
17 or Libya;

18 (B) is a member of the Christian or Yazidi  
19 community; and

20 (C) is seeking admission to the United  
21 States as an immigrant under subsection (a) or  
22 (b) of section 203 of the Immigration and Na-  
23 tionality Act (8 U.S.C. 1153).
